Beginning at a $2\frac{1}{2}$ inch galvanized iron pipe at the West corner of this lot, the North corner of Lot 46, and on the East side of Haakoa Road, the coordinates of said point of beginning referred to Government Survey Trig. Station "Papaaloa" being 1375.7 feet South and 1654.8 feet East, as shown on Government Survey Registered Map No. 2582, and running by true azimuths:-

8. $240^{\circ} 40'$ 196.3 feet along top of South edge of Haakoa gulch;
9. $263^{\circ} 53'$ 185.1 feet along same;
10. $241^{\circ} 56'$ 147.2 feet along same;
11. $210^{\circ} 39'$ 317.2 feet along same to a $2\frac{1}{2}$ inch galvanized iron pipe;
12. $306^{\circ} 30'$ 189.3 feet along Grant 2220, to Kanamu, to a $2\frac{1}{2}$ inch galvanized iron pipe;

- 13. 37° 28' 288.9 feet along top of West edge of Ahoa gulch;
- 14. 56° 51' 309.9 feet across Makai Cross Road along West edge of Ahoa gulch;
- 15. 28° 24' 155.1 feet along top of West edge of Ahoa gulch;
- 16. 1° 10' 198.5 feet along same;
- 17. 50° 34' 89.1 feet along same;
- 18. 28° 04' 135.4 feet along same;
- 19. 63° 44' 211.0 feet along same;
- 20. 46° 14' 257.6 feet along same;
- 21. 11° 22' 120.8 feet along same to a 2½ inch galvanized iron pipe;
- 22. 131° 15' 827.8 feet along Lot 46 to the point of beginning.
