Beginning at a  $1\frac{1}{2}$  inch galvanized iron pipe at the North corner of this lot and the West corner of Lot 74, on the Southeast side of Kalaniai Road, the coordinates of said point of beginning referred to Government Survey Trig. Station "Kalaniai" being 4494.2 feet South and 4025.2 feet West, as shown on Government Survey Registered Map No. 2586, and running by true azimuths:-

1.  $305^{\circ} 00'$  1049.5 feet along Lot 74 to a  $1\frac{1}{2}$  inch pipe on top of West edge of Kalopa Gulch;
2. Thence following along top of West edge of Kalopa Gulch to a  $1\frac{1}{2}$  inch pipe, the direct azimuth and distance being:  $31^{\circ} 23'$  717.1 feet;
3.  $119^{\circ} 14'$  1100.2 feet to a  $1\frac{1}{2}$  inch pipe;
4.  $215^{\circ} 00'$  826.3 feet along the Southeast side of Kalaniai Road to the point of beginning.

Area 19-70/100 Acres.

Excepting and Reserving therefrom the Government Survey Trig. Station "Ohia" and a lot 50 feet square surrounding same, (area 6/100 acre), with the right to enter upon said lot and to occupy said Trig. Station, LEAVING A NET AREA OF 19-64/100 ACRES.


