Waiakea, South Hilo, Hawaii

Being a portion of the Government (Crown) Land of Waiakea

Beginning at the west corner of this parcel of land, the north corner of Grant 11688 to John and Irene Vasconcellos (Lot 1415, Waiakea Homesteads, 2nd Series), and on the southeast side of Road C, the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI" being 25746.69 feet South and 13102.32 feet West, as shown on Government Survey Registered Map 2650, thence running by azimuths measured clockwise from True South:-

1. 223° 25' 15.00 feet along the southeast side of Road C;
2. 313° 25' 97.39 feet along the Tank and Storage Yard (Executive Order 1983) and the westerly end of the Pipeline Right-of-Way - Part "A" (Executive Order 1983);
3. 245° 15' 253.16 feet along the south side of the Pipeline Right-of-Way - Part "A" (Executive Order 1983);
4. 313° 25' 58.46 feet along Grant 11271 to Winifred L. Downing (Lot 1414, Waiakea Homesteads, 2nd Series);
5. 43° 25' 250.00 feet along Grant 11271 to Winifred L. Downing and Grant 11688 to John and Irene Vasconcellos (Lots 1414 and 1415, respectively, Waiakea Homesteads, 2nd Series);
6. 133° 25' 250.00 feet along Grant 11688 to John and Irene Vasconcellos (Lot 1415, Waiakea Homesteads, 2nd Series) to the point of beginning and containing an Area of 0.655 Acre.
