RESOLUTION NO. 246 (1933)

BE IT RESOLVED by the Board of Supervisors of the City and County of Honolulu, Territory of Hawaii, that pursuant to the provisions of Section 1743, Revised Laws of Hawaii, 1925, that certain roadway now known as the Luluku-Mokapu Road skirting the shore line of Kaneohe Bay from Kamehameha Highway, near Kaneohe, to the junction of the Mokapu and Kalama Roads in Oneawa, Kailua, be and the same is hereby named and designated as the -

KANEOHE BAY DRIVE

BE IT FURTHER RESOLVED that the road from this junction at Oneawa and running in the direction of the Fish and Game Bird Farm and beyond, shall be named and designated as the -

MOEAIU ROAD

BE IT FURTHER RESOLVED that a copy of this resolution be sent to the Postmaster for his information in the matter
