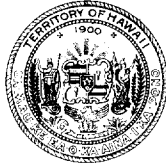

Beginning at the Northeast corner of this lot, on the South side of Kaumana Road, (50 feet wide), the coordinates of said point of beginning referred to Government Survey Triangulation Station "Kaumana" being 287.61 feet South and 3578.89 feet West, as shown on Government Survey Registered Map 2922, and running by azimuths measured clockwise from true South:-

1. 360° 00' 100.00 feet along Lot 50, Kaumana House Lots;
2. 90° 21' 100.00 feet along Lot 86, Kaumana House Lots;
3. 180° 00' 99.36 feet along Lot 52, ^(Gr 11504 to Tsugito Yoshioka) Kaumana House Lots;
4. Thence along the new South side of Kaumana Road on a curve to the right having a radius of 930.37 feet the direct azimuth and distance being: 269° 16' 36" 34.86 feet;
5. 270° 21' 65.14 feet along South side of Kaumana Road to the point of beginning.

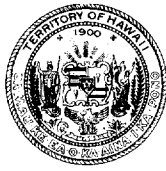
