L.C.Aw. 8559-B Apana 32 to William C. Lunailo.

Being also portion of the land conveyed to the Minister
of Interior by the Trustees of William C. Lunailo Estate
by Deed dated June 17, 1884, and recorded in Liber 88 on
Pages 223 and 224 (Land Office Deed 136), set aside as
Fort Ruger Military Reservation, Tract 1, by Presidential
Executive Order 6408, dated November 7, 1933 and subsequently
restored to the possession, use and control of the Territory
of Hawaii by Presidential Executive Order 10648 (Parcel 1)
dated December 8, 1955.

Beginning at the North corner of this lot, the east corner of Lot 62
of Diamond Head View Lots, Unit One, and on the southwest side of Hakaka Street,
the coordinates of said point of beginning referred to Government Survey Triangu-
lation Station "LEAHI" being 1190.77 feet North and 6079.29 feet East, as shown on
Government Survey Registered Map H.T.S. Plat 2165, thence running by azimuths
measured clockwise from True South:-

1. 303° 04' 83.50 feet along the southwest side of Hakaka Street;
2. 33° 04' 116.86 feet along Lot 60 of Diamond Head View Lots, Unit One;
3. 119° 00' 83.71 feet along National Guard, Air National Guard and Civil
Defense Reservation (Parcel 6, Presidential Execu-
tive Order 10648);
4. 213° 04' 122.79 feet along Lot 62 of Diamond Head View Lots, Unit One,
to the point of beginning and containing an Area
of 10,005 Square Feet.
