Being a portion of the Government (Crown) Land of Pukele.

Beginning at a pipe on the southeast corner of this lot, the southwest corner of Lot 16-E (20.00 Foot Roadway) of Francis Ii Brown Tract (File Plan 406) and on the north side of Hanakealoha Place, the coordinates of said point of beginning referred to Government Survey Triangulation Station "MAKANUI" being 665.53 feet South and 651.35 feet West, as shown on Government Survey Registered Map 2313, thence running by azimuths measured clockwise from True South:-

1. 107° 34' 5.40 feet along the north side of Hanakealoha Place to a pipe;
