Beginning at an ohia tree marked K surrounded by a pile of stones, at the North corner of this lot, and the East corner of Lot 11, the coordinates of said point referred to Trig. Station "Puaakoko" being 10854.2 feet South and 1971.2 feet East, as shown on Homestead Map No. 21 on file in the Office of the Government Survey, and running by true azimuths:-

1. 286° 48' 1116.0 feet along road along Waikahiula to Puupahoehoe at an ohia tree marked K;
2. Thence along road reservation over Lava Flow of 1840, the direct azimuth and distance being 21° 30' 1285.0 feet;
3. Thence still along road reservation over Lava Flow of 1840, the direct azimuth and distance being 60° 47' 715.1 feet;
4. 145° 31' 1524.0 feet along Lot 12A;
5. 235° 31' 1080.0 feet along Lot 11 to the point of beginning.

Area 48-60/100 Acres.

Excepting and Reserving therefrom a right-of-way 20 feet wide for a road along the Northeast boundary of this lot (area 50/100 acre) LEAVING A NET AREA OF 48-10/100 ACRES.

Also Excepting and Reserving therefrom all rights over and across the ancient trail passing through this lot.
