Beginning at the South corner of this lot, the West corner of Lot 187 and on the Northeast side of Kamehameha Highway, the direct azimuth and distance from an iron pipe at the West corner of Lot 185, being $320^{\circ} 00'$ 151.47 feet and the coordinates of said point of beginning referred to Government Survey Trig.
