Beginning at a stake at the West corner of this lot, the North corner of Lots 21 and 22, Part A, on the Southeast side of Aiea Ridge Road, the coordinates of said point of beginning referred to Government Survey Trig. Station "Salt Lake" being 9825.9 feet North and 1509.1 feet West, as shown on Government Survey Registered Map No. 2536, and running by true azimuths:-

1. 219° 42' 140.6 feet along the Southeast side of Aiea Ridge Road, to a stake;
2. 201° 06' 74.7 feet along same, to a stake;
3. 174° 24' 70.8 feet along East side of Aiea Ridge Road, to a stake;
4. 300° 03' 756.5 feet along Lot 16, Part A, to a point 10 feet from West edge of the North Fork of the Aiea Stream, passing over a stake at 526.5 feet;
5. Thence in a line parallel to and 10 feet from West edge of the North Fork of the Aiea Stream, the direct azimuth and distance being: 2° 38' 304.1 feet;
