Station "Salt Lake" being 9556.7 feet North and 1814.1 feet West, as shown on Government Survey Registered Map No. 2536, and running by true azimuths:-

1. 146° 05' 127.0 feet along Lot 26 (Revised) to a stake;
2. 210° 03' 330.0 feet along Lots 26 and 19, to a pipe;
3. 300° 03' 192.7 feet along a 15 Foot Road to a stake;
4. 352° 04' 24.7 feet along road to a stake;

Beginning at a stake at the North corner of this lot, the West corner of Lot 20, Part A, on the Southeast side of Aiea Ridge Road, the coordinates of said point of beginning referred to Government Survey Trig. Station "Salt Lake" being 9825.9 feet North and 1509.1 feet West, as shown on Government Survey Registered Map No. 2536, and running by true azimuths:-

1.  $300^{\circ} 03'$  866.9 feet along Lot 20, Part A, to a point 10 feet from West edge of the North Fork of the Aiea Stream, passing over a stake at 596.9 feet;
2. Thence up slope of gulch to top of rocky ledge, the direct azimuth and distance being:  $45^{\circ} 41'$  259.7 feet;
3. Thence along rocky ledge to East corner of Lots 23 and 24, Part A, the direct azimuth and distance being:  $46^{\circ} 56'$  535.1 feet;
4.  $146^{\circ} 05'$  826.9 feet along Lots 23 and 24, Part A, passing over a stake at 190.0 feet;
5.  $224^{\circ} 26'$  403.8 feet along Southeast side of Aiea Ridge Road, to a spike;
6.  $219^{\circ} 42'$  8.2 feet along same, to the point of beginning.
