Realignment of MOKAPU ROAD

PARCEL 2

Territory of Hawaii,

Owner

Being a portion of the present Mokapu Road; being also portions of the Ahupuaa of Kailua, R.P. 7985, L.C.A. 4452, Apana 12, to H. Kalama, the Ili of Oneawa, R.P. 5642, L.C.A. 7122, Apana 5 to T. Tute, and the Ahupuaa of Kaneohe, R.P. 7984, L.C.A. 4452, Apana 13, to H. Kalama,

Situated on the northwest side of Lot 2-A of Land Court Application No. 677 (Amended), at Kailua and Kaneohe, Koolaupoko, Oahu, T.H.

Beginning at a pipe on the east boundary of this piece of land, being also the southwest corner of Lot 4 of Land Court Application No. 677 (Amended), the coordinates of said pipe referred to Government Survey Triangulation Station "Mokapu" being 13,315.0 feet south and 5183.8 feet west, and running by true azimuths:

1. 345° 03' 661.50 feet along beach lots owned by H. Foeke and R.H. Trent, along the east side of Mokapu Road;
2. 37° 15' 2967.2 feet along Lots 2-A and 2-B of Land Court Application No. 677 (amended) along the southeast side of Mokapu Road;
3. thence on a curve to the left with a radius of 607.3 feet, along Lot 2-A of Land Court Application No. 677 (amended) along the east side of Mokapu Road, the direct azimuth and distance being 4° 37' 655.0 feet;
4. 331° 59' 246.80 feet along Lot 2-A of Land Court Application 677 (amended) along the northeast side of Mokapu Road;
5. 60° 37' 40.00 feet across Mokapu Road to a pipe at the initial point of Land Court Application 495;
6. 151° 59' 247.75 feet along the remainder of the Ahupuaa of Kailua along the southwest side of Mokapu Road;
7. thence on a curve to the right with a radius of 647.3 feet, along the remainders of the Ahupuaa of Kailua and the Ili of Oneawa, along the west side of Mokapu Road, the direct azimuth and distance being 184° 37' 698.1 feet;
8. 217° 15' 2767.00 feet along the remainder of the Ili of Oneawa, along the northwest side of Mokapu Road;
9. thence on a curve to the left with a radius of 368.60 feet, along same, the direct azimuth and distance being 191° 09' 324.32 feet;
10. 165° 03' 1833.5 feet along the remainders of the Ili of Oneawa and the Ahupuaa of Kaneohe along the west side of Mokapu Road;
11. 216° 23' 51.22 feet along the northwest side of road;
12. 345° 03' 1404.16 feet, crossing road and along Lot 4 of Land Court Application 677 (amended) along the east side of Mokapu Road to the point of beginning and containing an area of 5.577 acres.
