Piihonua, South Hilo, Hawaii

Being a portion of the Government (Crown) Land of Piihonua

Beginning at the north corner of this parcel of land, the west corner of Grant 13538 to Gary A. Yoshina (Lot 62, Piihonua House Lots, Third Series Extension) and on the southeast side of Kahema Street, the coordinates of said point of beginning referred to Government Survey Triangulation Station "HALAI" being 903.91 feet North and 1527.03 feet West, as shown on Government Survey Registered Map 3050, thence running by azimuths measured clockwise from True South:-

1. 326° 48' 174.98 feet along Grant 13538 to Gary A. Yoshina (Lot 62, Piihonua House Lots, Third Series Extension);
2. 236° 48' 79.45 feet along Grant 13538 to Gary A. Yoshina (Lot 62, Piihonua House Lots, Third Series Extension);
3. 326° 48' 5.00 feet along Parcel H, Utilities Right-of-Way, Piihonua House Lots, Third Series Extension;
4. 56° 48' 84.45 feet along Parcels G and E, Utilities Right-of-Way, Piihonua House Lots, Third Series Extension;
5. 146° 48' 179.98 feet along Parcel D, Utilities Right-of-Way, Piihonua House Lots, Third Series Extension;
6. 236° 48' 5.00 feet along the southeast side of Kahema Street to the point of beginning and containing an Area of 1,297 Square Feet.
