Liliuokalani Estate to Territory of Hawaii

Portion of the Ili of Hamohamo, Waikiki, Oahu.

(Comprising part of L.C.A. 8452 to Lechokalo, L.C.A. 1450 Apana 1 to Koa, L.C.A. 1457 Apana 2 to Paumano, L.C.A. 1447 Apana 2 to Mahue, L.C.A. 2492 Apanas 1 and 2 to Kinikini, L.C.A. 2843 Apana 2 to Kaanaana, L.C.A. 1458 Apana 2 to Kapea, L.C.A. 1452 Apana 2 to Haau, L.C.A. 1451 to Obuohu, and L.C.A. 1455 Apana 2 to Pelekane)

Beginning at the West corner of this lot on the boundary between the Ilis of Kalamanamana and Hamohamo, in the center of the Pahoa stream, 20 ft. - 4. 62° 19' 319.9 " " the center of stream marking the boundary between the Ilis of Kaneloa and Hamohamo to the lower line of the Waikiki Reclamation Project, 7 feet Southeast of a concrete monument, thence
- 5. 132° 45' 1225.2 " along the said makai line to the point of beginning.
