Being a portion of the Government (Crown) Land of Wailua.


Beginning at the top of bank on the northwest side of Wailua Stream at the southeast corner of this parcel of land and at the southwest corner of Lot 44-A of Wailua Homesteads, the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUU ILILUA" being 2682.20 feet South and 1127.20 feet East, thence running by azimuths measured clockwise from True South:-

1. Along the top of bank on the northwest side of Wailua Stream, the direct azimuth and distance being:  
65° 06' 88.80 feet;
2. 132° 20' 300.00 feet along Grant S-14,781 to Libby Kekiwi Akina and Part 2 of Grant 13,239 to Dorothea Sui Lim Young Lum Hoy;
3. 221° 30' 22.00 feet along Grant 13,304 to Paul Quon Hoy Young;
4. 299° 00' 137.00 feet along Grant 13,304 to Paul Quon Hoy Young;
5. 182° 20' 115.00 feet along Grant 13,304 to Paul Quon Hoy Young;
6. 270° 52' 55.40 feet along Grant 13,209 to James Akina Wong;


- 7. 360° 00' 126.00 feet along Grant 13,191 to Mary Kapono Kalalani Kekiwi;
- 8. 269° 20' 110.00 feet along Grant 13,191 to Mary Kapono Kalalani Kekiwi;
- 9. 6° 00' 75.00 feet along Lot 44-A of Wailua Homesteads;
- 10. 349° 00' 30.00 feet along Lot 44-A of Wailua Homesteads to the point of beginning and containing an AREA OF 0.75 ACRE, MORE OR LESS.

The above-described Lot 43-A is subject to easements and all other ancient rights that may be appurtenant to lots located in the vicinity or possessed in gross by the owners of said lots or by others entitled to the use of said easements or other rights.
