#### The Historical Commission

#### Introduction

The records of the Historical Commission consist of 2.5 cubic feet. They span the period 1922-1934. They were accessioned from the Commission according to Act 120 of 1921, which stipulated that all Commission records should be preserved in the Territorial Archives. There are no restrictions on access.

#### Administrative History

Established: The Historical Commission was established by Act 120 of 1921, as amended by Act 139 of 1923, and abolished in 1932 and its functions transferred to the Regents of the University of Hawaii (Act 9, Second Special Session, 1932).

Functions: The function of the Commission was to accomplish four tasks: to write a comprehensive general history of Hawaii, to revise an apparently existing elementary history of Hawaii for use in the public schools, to compile a history of Hawaii's role in World War I, and to report to the legislature on places of historical importance for the purpose of marking them.

The law provided for a three-member commission and the employment of "such competent persons as are necessary for the compilation of the said history." The Commission wanted a trained historian to fill this job, involving as it did, the planning and writing of so much history, and in April, 1922, offered the position of executive secretary to Ralph S. Kuydendall. Kuykendall accepted and began work in September, 1922. The office of the Commission was located at the University of Hawaii at Manoa.

The Commission began first the writing of the elementary textbook. When that had been well started, they began the longer-term work of writing the comprehensive history. This project eventuated in Kuykendall's three volume <a href="History of the Hawaiian Kingdom">History of the Hawaiian Kingdom</a>, 1778-1893. In response to Kuykendall's idea that the history should place Hawaii in a world context, rather than concentrate purely on island affairs, the Commission first surveyed what records existed in Hawaii for the purpose, and then began concerted searches elsewhere. Kuykendall personally examined libraries in the United States and Canada with major holdings relating to Hawaii, especially the Bancroft Library at the University of California at Berkeley, the provincial library of British Columbia, the Oregon Historical Society library, Harvard College Library, and the U.S. State Department archives.

The Commission also contracted for copy work in the British and French government archives, again, for diplomatic

correspondence relating to Hawaii. In addition, the Commission secured copies of documents relating to Hawaii from the Mexican government archives, and copies of the correspondence of David S. Gregg, Peter A. Brinsmade, Robert G. Davis, William L. Lee, and Sanford B. Dole. The law provided that it was to deposit all the documents it collected in the Territorial Archives.

**Disestablished:** The Commission was abolished in 1932 and its functions transferred to the Board of Regents of the University of Hawaii.

Physical characteristics/condition: Paper material in fair to good condition. The correspondence contains a small amount of acidification due to the inclusion of newspaper clippings in the folders, and a small amount of tearing of newsletter material that extended above the folder edges. No insect or water damage.

Content description: Contains correspondence relating to two projects of the Commission: the writing of a history of Hawaii's role in World War I, and the marking of historical sites in Hawaii. The World War I correspondence relates to the compilation of an Honor Roll of Hawaii's war dead in World War I. The historical sites correspondence contains mailed survey sheets relating to public nominations of historical sites on each island, and correspondence relating to the design of a standard plaque to mark sites, to the attempt to acquire the site of the Russian Fort at Waimea, Kauai, for a park, and to an attempt to acquire a model of Cook's ship Resolution from England for display in Hawaii.

Arrangement: Alphabetical.

Note: The Commission apparently did not preserve the minutes of its meetings.

Date Range: 1922-1934

Quantity: 2.0 linear feet

Creator: Ruth Anna Fisher and an unnamed person, employees of the Historical Commission

Physical characteristics/condition: Handwritten material in bound volumes and loose typescript material. All in good condition.

Content description: Contains copies of documents from the British Public Record Office, London, relating to the formation of British policy toward Hawaii from 1824 to 1894, copied by Ruth Anna Fisher. Includes the British Foreign Office letterbook series no. 58 relating to the Pacific Islands, and another relating to France. Series 58 contains outgoing letters to the British Consuls in Hawaii. The subseries relating to the British Consul-General in Honolulu contains outgoing letters sent home to the British Foreign Office, as well as to the Hawaiian Secretary of State for Foreign Affairs.

Arrangement: In two subseries: Foreign Office material followed by Consul-General material. The Consul-General subseries is arranged chronologically.

#### Notes:

- 1. The Historical Commission made copies of the outgoing and incoming letters to the British Foreign Office from the British consuls in Hawaii. The names of the British consuls in Hawaii appear in the Container List opposite the relevant date span of the copybook letters (e.g., Charlton, Synge, Miller, etc.).
- 2. The Historical Commission used a numbering system for its copybooks that began with "First Series" and ended with "Sixth Series," but continued to copy material after the sixth series. This newer material carries no series numbers.
- 3. The Commission did not copy the British Foreign Office letterbooks exactly in chronological order, so that some of the copied material is out of sequence. Nevertheless, there appear to be no gaps in the coverage, although as noted above, the copyist was selective in what letters she copied

from any one letterbook.
