Introduction

The records of the Hawaiian Homes Commission, 1921 to 2010, consist of minutes, agendas, meeting notices, submittal reports, staff recommendations, and exhibits from the Minutes of the Hawaiian Homes Commission collection. The Public Relations Files of the Department of Hawaiian Home Lands collection, 1921 to 1994, consist of paper records, photographs, and VHS videotapes.

The Hawaiian Homes Commission records were transferred to the State Archives in several accessions between 1963 and 2008. The Information & Community Relations office records were transferred to the State Archives in 1998. The records total 57.75 cubic feet.

Access to the records is unrestricted.

Administrative History

Established:

By the Hawaiian Homes Commission Act, 1920, enacted by the United States Congress [Act of July 9, 1921, c 42, 42 Stat 108]. Section XII of the Hawai'i State Constitution adopted the Congressional act as a law of the state. Section 24 of Act 1 passed by the First State Legislature, Second Special Session transferred the authority and functions of the Hawaiian Homes Commission to the Department of Hawaiian Home Lands.

Predecessor Agency:

Hawaiian Homes Commission, 1920-1959

Functions:

The purpose of the act is to enable native Hawaiians to return to their lands in order to fully support self-sufficiency for and self-determination of native Hawaiians. [Act of July 9, 1921 c.42, 42 Stat 108, section 101] The Hawai'i Admission Act transferred complete responsibility of the program and the homelands to the State of Hawai'i. The Commission sets policy of the Department of Hawaiian Home Lands. The Department issues homestead leases to qualified native Hawaiian applicants and income generating leases to the general public, manages land exchanges, and issues licenses for public utility and access easements. The Department also provides financial assistance to native Hawaiian lessees via loans for home construction, home improvement and repair, farming, ranching and operation of water systems.

Scope and Content Note

The records of the Department of Hawaiian Home Lands comprises of two series: Minutes of the Hawaiian Homes Commission, dating from 1921 to 2010; and the Public Relation Files from the Information and Community Relations Office, dating from 1921 to 1994.

The Minutes of the Hawaiian Home Commission are of public proceedings and provide comprehensive coverage of the policymaking and decision making activities of the commission since its inception. There are gaps for minutes to the Hawaiian Homes Commission meetings in October, November, and December 1977 (meeting numbers 209, 210, and 211). Minutes dated 1921 to 1967 were bound by the Commission prior to transfer to the archives; Minutes from 1968 to 1974 were filed in pressboard binders by the commission prior to transfer to the Archives. For preservation purposes, bound minutes from 1960 to 1974 were disbound during processing.

The Public Relations Files of the Department of Hawaiian Home Lands consist of directors' speeches, testimony, interviews, news releases, radio and television scripts, flyers, and programs. The bulk of the collection are records of homesteads awarded to the native Hawaiians from late 1960's to early 1990's.

Division History Hawaiian Homes Commission

Agency Name: Hawaiian Homes Commission

Established: By the Hawaiian Homes Commission Act, 1920, enacted by the United States Congress and signed into law by President Warren Harding on July 9, 1921. Section XII of the Hawai'i State Constitution adopted the Congressional act as a law of the state. Section 24 of Act 1 passed by the First State Legislature, Second Special Session transferred the authority and functions of the Hawaiian Homes Commission to the Department of Hawaiian Home Lands.

Function: The Commission functions as an executive board and sets policy of the Department of Hawaiian Home Lands. The Governor with the advice and consent of the Hawai'i State Senate appoints the nine members of the Hawaiian Homes Commission.

The Hawaiian Homes Commission is composed of nine members: three residents from the City and County of Honolulu; two residents from the island of Hawaii; two residents from Maui County, one of whom shall be resident of Molokai; one resident from Kauai; and the ninth member shall be the chairman of the Hawaiian Homes Commission.

Series No. 239

Series Title: Minutes of the Hawaiian Homes Commission

Date Range: September 21, 1921 – December 14, 2010

Quantity of Records: 55.5 cubic feet, in 22 cubic foot boxes, 48 6-inch boxes, and 26 volumes.

Physical Characteristics: Typed minutes, 1921-2010. Minutes for 1921-1967 were bound by the Commission. Minute books for 1921-1933 were disbound by Archives staff in preparation for microfilming. Disbound minutes, 1921-1933, and the agenda and minutes for 1960-2010 are filed in individual alkaline enclosures. Photographs were sleeved and Records with corrections or information added via sticky labels or correcting tape were photocopied and replaced by photocopies for preservation.

Content Description: The minutes provide comprehensive documentation of the Hawaiian Homes Commission activities and decisions since its inception in 1921. They consist of minutes of the public portion of the commission regular meetings held monthly at various homestead communities throughout the state. Include minutes to public portions of special commission meetings held once or twice a year. Meeting notices, agenda, staff reports and recommendations, and exhibits are filed with the minutes. The Commission's decisions regarding lease activity, capital improvement projects and infrastructure improvements, development plans, management plans, land exchanges, licenses issued for utility and access easements, government loan applications, lot subdivisions, departmental personnel, and Commission finances are documented in the minutes.

Arrangement: The records are arranged chronologically by Commission meeting date, also in numerical order by meeting number. There are gaps for minutes to the Hawaiian Homes Commission meetings in October, November, and December 1977 (meetings number 209, 210, and 211).

Access: For most records, there are no restrictions on access [HRS §92-9; HRS §92F-12.a.16]. Some records are restricted under the Uniform Information Practices Act [HRS §92F-14; OIP Op. Ltr. No. 91-19]. The restrictions are removed by HRS §94-7, effective on different dates as marked on the Records Container List and the folders. Folders containing restricted records must be screened by an archivist before being issued.

Division History Information and Community Relations Office

Agency Name: Information and Community Relations Office.

Function: The Information and Community Relations Office plans, organizes, and carries out public information programs and community relations projects. It provides advice and assistance to the Hawaiian Homes Commission and Department of Hawaiian Home Lands staff on public relations and public information matters and administers projects for the department such as homestead beautification contests.

Series Title: Public Relations Files of the Department of Hawaiian Home Lands.

Date Range: ca. 1921 - 1994.

Physical Characteristics: Paper records, photographs, and VHS videotapes in good condition.

Content Description: Textual and visual records comprise the public relations files of the Department of Hawaiian Home Lands (DHHL). Textual records consist of directors' speeches, testimony, interviews, news releases, radio and television scripts, flyers, and programs. Visual records consist of black and white and a few color photographs, negatives and videotapes.

Records of the Department's efforts to award homesteads to native Hawaiians from the late 1960's to the early 1990's comprise the bulk of the collection. There are a few photos ca. 1920's to 1930's of Moloka'i settlements and agricultural activities, Keaukaha homesteads and Waiakea Airfield (General Lyman Field and Hilo International Airport) construction.

The records and images provide coverage of homestead awards to applicants and public works projects to develop infrastructure required to support the subdivision of Hawaiian home lands into pastoral lots, agricultural lots, and residential lots for single family homes. Projects include construction of new streets and improvements to existing roads, water supply, drainage, fencing, and soil erosion mitigation. Agricultural development projects on Moloka'i, Hawai'i, Kaua'i and Maui; and residential subdivision development on all islands are covered. There are images depicting social services programming such as maternal care, childcare, and early education for O'ahu homestead residents. Images of buildings, offices, and staff members of the Department of Hawaiian Home Lands as well as assorted local, state, and federal government officials; Hawaiian musicians; and homestead residents are found in this collection.

Speeches, interviews, and testimony topics include accelerated home building projects, department accomplishments, entitlements to native Hawaiians, homestead evictions, home loans, infrastructure improvements, state of the state drafts, accomplishments of Jonah Kuhio Kalanianaole (1871-1922), and a eulogy for George Jarrett Helm (1950-1977).

News releases announce groundbreaking, dedications, homestead award recipients, homestead beautification awards, land use development and management plan revisions, public hearings and meetings, employee service awards, bid advertisements, department rules and regulations, financial and management audits and legislative proposals.

Arrangement: The records are arranged in the following order: news releases, speeches, ceremony programs, photographs and videotapes. News releases, speeches and ceremony programs are arranged chronologically. Photographs are arranged geographically by island therein by alphabetical by name of homestead community. Videotapes are arranged chronologically.

Access: Access is unrestricted.
