## INTRODUCTION

Princess Margaret Dowling Ghika visited Hawaii in [March to Sept.?] 1930. During her visit she became interested in the Hansen's disease patients at Kalaupapa, and was able to visit the Settlement for 2 days as the guest of Superintendent Ralph L. Cooke. While there, she met and befriended the Catholic Church's resident priest, Father Peter d'Orgeval, who came from France and served at the Settlement from 1927-1947. Because of his trained background in music, he also directed the church choir. The princess took an interest in his musical work with the patients, and believed there should be more musical opportunities afforded the patients. Back in Honolulu she solicited prominent fellow tourists at the hotel for donations of ukulele or guitars and she ultimately sent a donation of 26 ukulele and 4 guitars.
