

**JONAH KUHIO KALANIANAOLE COLLECTION  
1844-1921**

This collection consists of 1.62cu. ft. of papers related to several Hawaiian monarchs, their families and associates. Papers are arranged by reigning monarch followed by family members and other individuals. Thereunder, papers are in chronological order.

Papers of Kamehameha III's reign include: notebook of accounts of the Honolulu Fort (1844-1850); transcripts of court cases and other legal matters coming before Gov. Mataio Kekuanaoa; minutes of preliminary meetings of the legislature of 1851.

Papers of Kamehameha IV's reign include: draft of his acceptance speech of January 17, 1854 and many letters written to Kamehameha IV. These letters are listed by author in a separate inventory list.

Papers of Kamehameha V's reign include: three letters by Robert Crichton Wyllie; resolution by legislature on death of Princess Victoria Kamamalu; draft of Gov. John Kapena's resolution approving reciprocity.

Papers of Kalakaua and Kapiolani include: private letter to Kalakaua March 9, 1875 from H. W. Severance on purchasing 200 stand of arms in the U.S.; letter from W.F. Allen, December 28, 1875 on loss of revenue to Hawaiian government because of reciprocity treaty; draft report covering Kapiolani's trip to the Leper Asylum on Molokai (July 1884) and notebook of complaints from lepers; Kawaihau Sugar Company rules and regulations and correspondence (May 1877-May 1878); letters to Kapiolani and Kalakaua and condolences on the death of Kalakaua; Notebook of the minutes of meetings of trustees of Kalakaua's estate (November 29, 1887 - August 21, 1890). Also included are Kalakaua's medicine notes and a ledger entitled The Lawyers' Common-Place Book.

Jonah Kuhio Kalanianaole's papers (1892-1920) include: his Habeas Corpus case, 1895; letterbook containing copies of letters from Morris K. Keohokalole for the Kapiolani estate (1889-1903) and from Kalanianaole as delegate to Congress (1903-1904). There are a few papers concerning the Hawaiian homestead act, but most of those papers are to be found in Kalanianaole's official files as Delegate to Congress, also in the Archives. (M-474)

Jonah Kuhio Kalaniana'ole Papers

Introduction

The Jonah Kuhio Kalaniana'ole Collection contains the papers of Kalaniana'ole's ten terms as Delegate to Congress from Hawaii, 1903-1922, totaling 4 linear feet. The collection contains mainly Congressional bill copies and correspondence. The collection came to the Archives as the gift of Elizabeth Kahanu Kaaupai Kalaniana'ole Woods, the former wife of the Prince, on April 18, 1927.

Biographical Sketch

1871--March 26, born at Hoai, Kualu, Koloa, Kauai, to David Kahalepouli Piikoi and Kinoiki Kekaulike, the youngest sister of Queen Kapiolani.

Educated at Royal School, Punahou School, and at St. Matthew's College at San Mateo, California. Also attended Royal Agricultural College, England, where he took business courses.

1884---Named prince by royal decree, February 14.

1896---Married Elizabeth Kahanu Kaaupai, October 9.

1902---Elected in November to first of ten consecutive terms as Delegate to Congress from Hawaii. A Republican, he served until January, 1922, when he died in office.

---Appointed to House committees on Agriculture, Coinage, Weights and Measures, Military Affairs and Territories

1911---Complaint to Interior Department against Governor Walter F. Frear for mismanagement of public lands.

1916---Sued to break Queen Liliuokalani Trust, February-April.

1921---Responsible for passage of Hawaiian Homes Commission Act

---Member, Hawaiian Homes Commission and Hawaiian Historical Commission

1922---Died, January 7.

### Scope and Content

The Jonah Kuhio Kalaniana'ole Papers, totaling 4.3 linear feet, document Kalaniana'ole's 19 year career in office as Delegate to Congress, 1903-1922. They also contain congressional records and some correspondence from Harold Baldwin, who served out the remainder of Kalaniana'ole's unexpired term until 1923 after Kalaniana'ole died.

The collection contains six series: 1.) U.S. Congress Records; 2.) Subject Correspondence; 3.) Name Correspondence; 4.) U.S. Departments Correspondence; 5.) Territorial Departments Correspondence; and 6.) City and County Departments Correspondence.

The U.S. Congress Records, series #1, contains copies of the bills Kalaniana'ole introduced, correspondence and related documents and printed material.

The five correspondence series document Kalaniana'ole's actions to introduce or testify on behalf of legislation beneficial to Hawaii. They contain correspondence with individual constituents, private organizations such as the Honolulu Chamber of Commerce, and various government agencies.

The correspondence and bill series, in comparison to other delegate to congress collections, reflect unusually close consultation between the delegate, the governor and the Honolulu Chamber of Commerce on legislation of interest to Hawaii. Series #3, Name Correspondence, contains evidence of the delegate's strong interest in Hawaii electoral politics through detailed correspondence with such persons as Noa Aluli, C.W. Ashford, John C. Lane, and W.A. Kinney. In addition, series #1, Congressional Records, as noted above, contains the Congressional records of Harold Baldwin (1871-1946), Kalaniana'ole's successor, who served out the one year of Kuhio's unexpired term in a special election.

Documentation on Kalaniana'ole's efforts to effect passage of the Hawaiian Homes Commission Act is found mainly in series #1, U.S. Congress Records by date, and also under series #2, Subject Correspondence, under "Fisher Investigation," "Rehabilitation," and some items under "Governor, 1918-1921."

During processing of the collection, the six series were rearranged into an order reflecting their legislative purpose, beginning with the bills file, and followed by the various correspondence files as described above.

See also the Kalaniana'ole Collection, M-80, and the Alexander G.M. Robertson Papers, M-390, for additional letters from Kalaniana'ole. The Robertson papers contain 26 letters from him, between 1904-1909.

### Series Descriptions

**1. U.S. Congress Records. 1903-1923. 13 linear inches.**

Arranged alphabetically by type of record.

Documents Kalaniana'ole's actions to introduce bills and obtain favorable consideration of legislation of interest to Hawaii. Also documents the legislation of Harold Baldwin. Contains typescript bill drafts, printed House bill copies, Senate companion bills, typescript statements of testimony, committee reports, printed laws, correspondence, petitions from the public, resolutions from the Territorial legislature and printed committee hearings.

Includes correspondence relating to a series of four congressional visits to Hawaii that Kuhio arranged for the purpose of familiarizing key congressional figures with Hawaii affairs, in particular, the sugar situation; the army and navy defense question as it pertained to Schofield Barracks and Pearl Harbor; and various needs for public works projects, including a Honolulu federal building and harbor improvements.

Subjects of legislation include the Hawaiian Homes Commission Act of 1919-1921, the county home rule bill, vocational education, the Hilo breakwater, post office roads, and numerous other bills of interest to Hawaii. See also series #2, Subject Correspondence, series #4, U.S. Departments Correspondence, and series #5, Territorial Departments Correspondence under folders entitled "House", "Senate" and "Governor," for further information on legislation.

Subjects include the sugar tariff, harbor improvements for Honolulu and Hilo, the Honolulu federal building, a Coast Guard revenue cutter for Hawaii, diversified agriculture (coffee and tobacco), fisheries research and agricultural extension aid.

KANEOHE PLANTATION

Dowager Queen Hazaleleponi Kapahuhaili Kalama (1817 – 1870), owned 20,000 acres of land in Kaneohe in the early 1860's. Part of this land, Kaneohe Plantation, was planted in sugar cane. A mill was built around 1864 with equipment shipped from Liverpool. Charles Coffin Harris (1822 – 1881), a prominent lawyer, was the Queen's partner and manager of the plantation. The labor force was primarily Hawaiian women, they being replaced later by Chinese coolies.

On October 7, 1866, the sugar mill, trash house, 70,000 lbs. of sugar and about 1,000 sugar kegs burned, with a total loss valued at about \$30,000. The mill was not rebuilt, although cane was grown on the land until the late 1880's. Title to the land was passed to C. C. Harris, then to his daughter, Nannie R. (Harris) Rice. It was later purchased by James B. Castle. After 1890 much of this land was used for cattle range until urban spread reached the area.

KAPIOLANI PARK ASSOCIATION

1876 - 1896

The Kapiolani Park Association was formed on November 8, 1876, when a group of people interested in the establishment of a park and fairground gathered at the rooms of the Honolulu Chamber of Commerce. Among them was His Majesty King Kalakaua, who offered 300 acres in Waikiki (the extent to which Crown Commissioners were able to lease) for a "nominal fee". An election of officers resulted in the following men being elected: president, Captain James Makee; vice-president, Archibald S. Cleghorn; secretary, Henry MacFarlane; and treasurer, John H. Paty. A committee was created to draft a charter and present it to the government and on December 22, 1876, the Kapiolani Park Association was granted its charter of incorporation.

Besides leasing land from the Crown, the group also leased adjoining lands from Allen Herbert in 1877. Dedication ceremonies for the park were held on Kamehameha Day, June 11, 1877, with King Kalakaua and the Royal Family present. The highlight of the program was a speech by the King followed by horse racing at the park track.

Two hundred shares were offered at \$50 each, entitling each shareholder to bid on leases for lots in Kapiolani Park. Captain Makee passed away in 1879, and was succeeded by vice-president A.S. Cleghorn, who served as president until 1896 when control of Kapiolani Park was turned over to the Honolulu Park Commission.

Because of the limited funds available for its large land area, the Association could barely manage to keep up the land and water areas of Kapiolani Park. It was often in debt and in 1881, received \$5,000 from the Legislature for "improvements", and to help repay it's \$3,000 debt. It also received financial support from private citizens and organizations and a little income from selling rights for cutting firewood and grass and picking algaroba beans.

Finally in the spring of 1896, the Kapiolani Park Association passed a Resolution in regard to Act 53, Session Laws 1896, releasing and conveying its leaseholds and other property to the Republic of Hawaii for the creation of a free public Kapiolani Park under the control, management, and possession of six commissioners serving six-year terms. William Irwin, E.S. Cunha, and Cecil Brown were elected to represent the Association on the Honolulu Park Commission, of which Mr. Irwin was elected chairman.

The records of the Kapiolani Park Association consist of ten folders, a certificate book (of shares) and a bound book containing the minutes and correspondence of the Kapiolani Park Association and the Honolulu Park Commission, 1876 to 1902.
