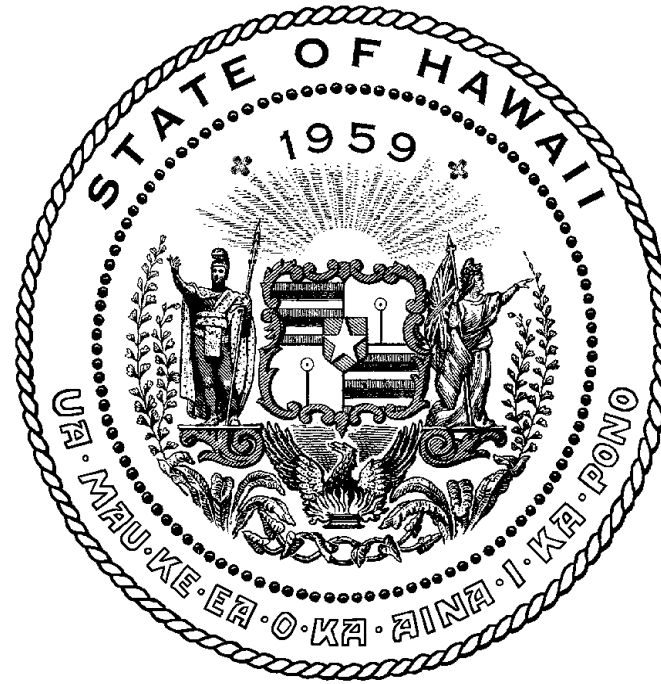

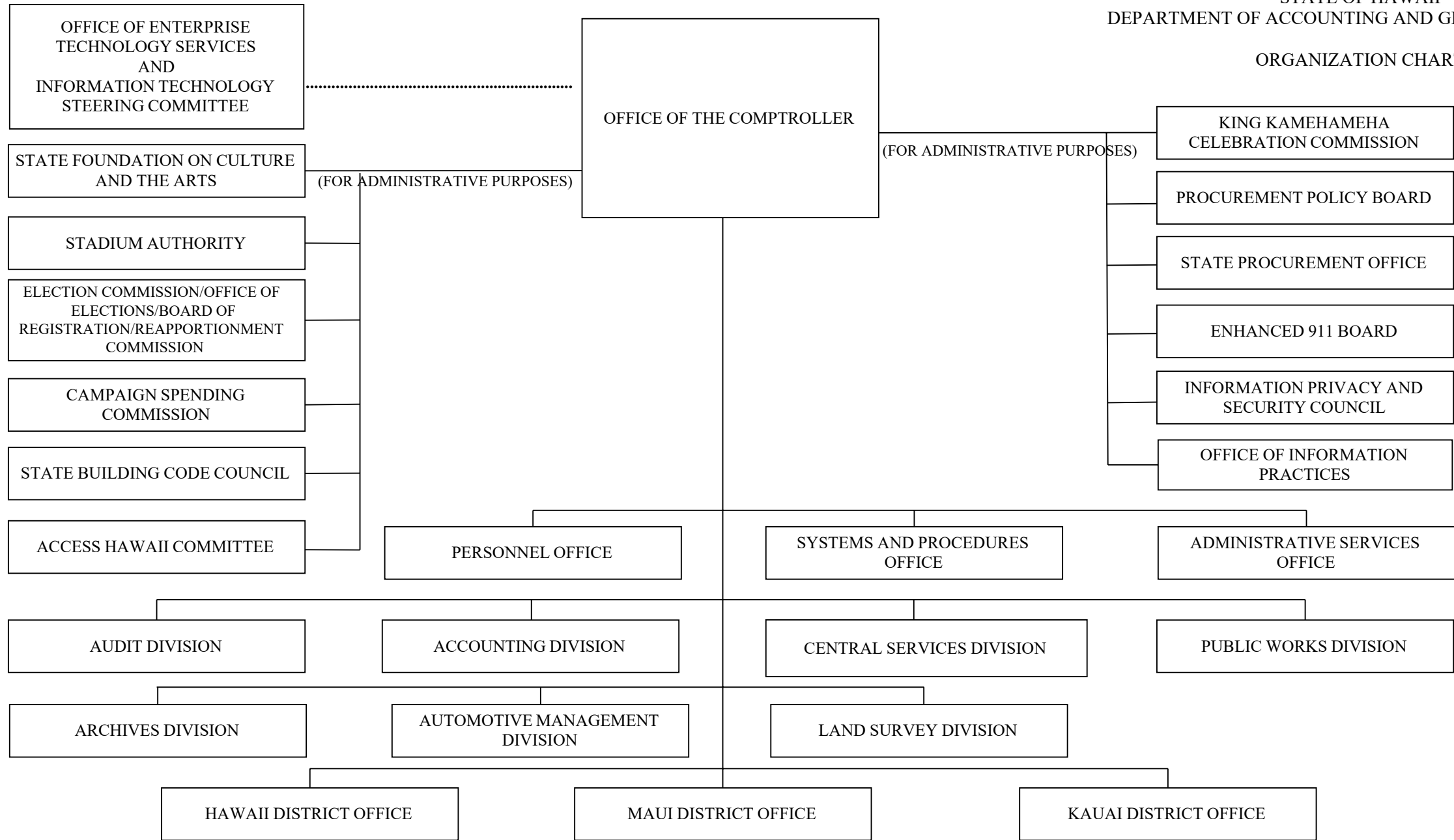

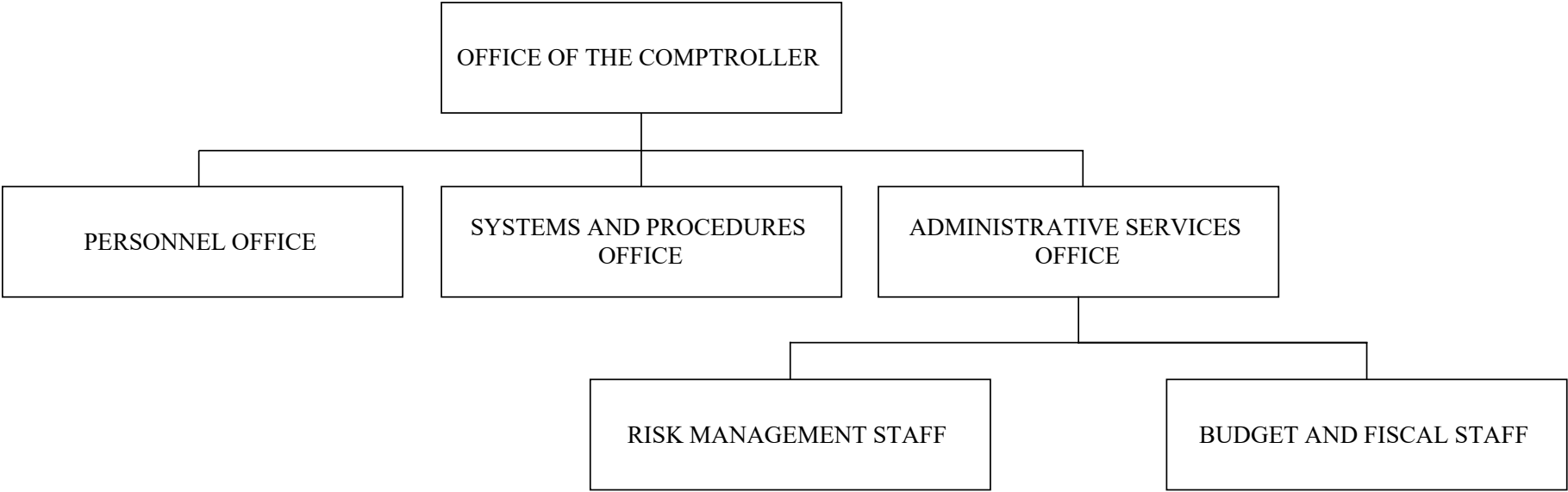

ORGANIZATION CHART

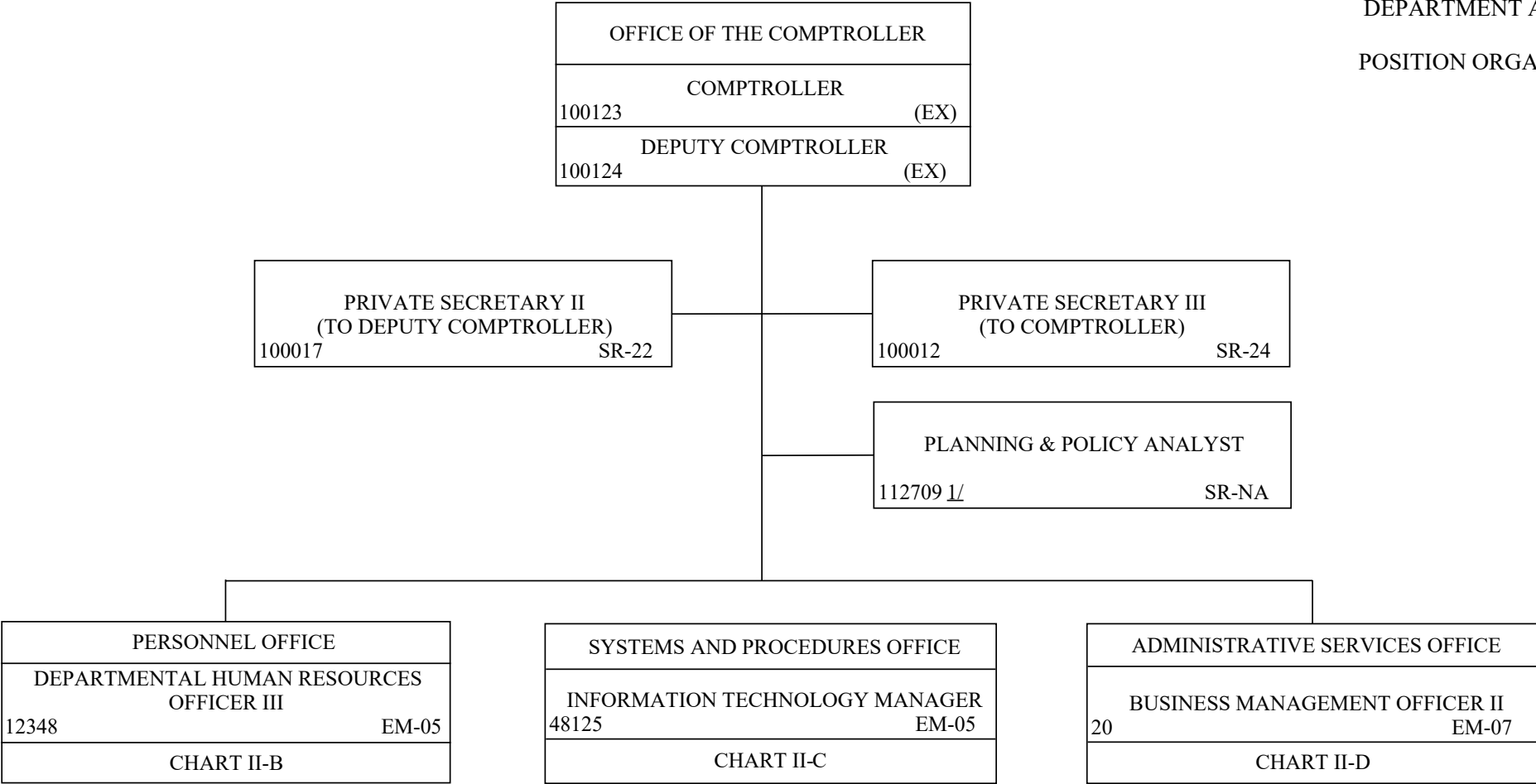

ORGANIZATION CHART



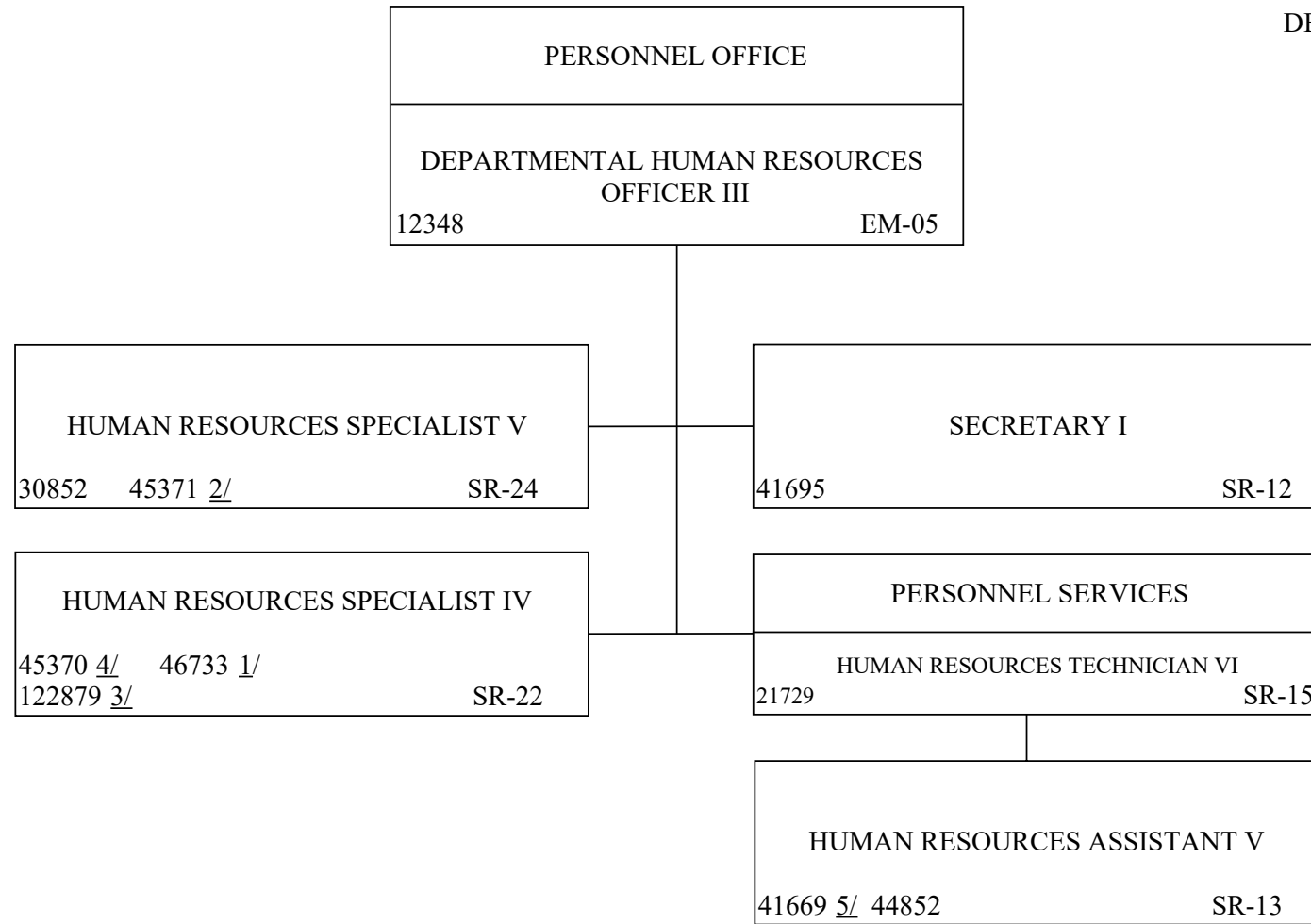

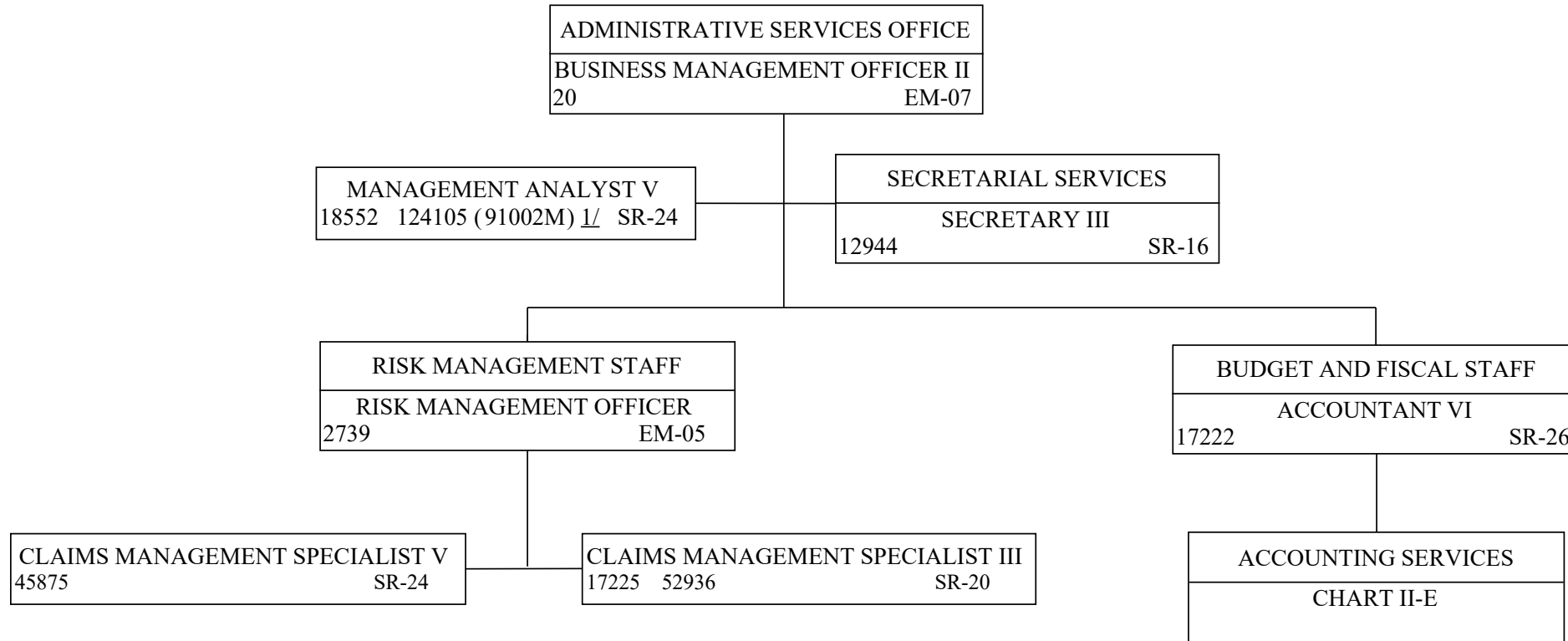

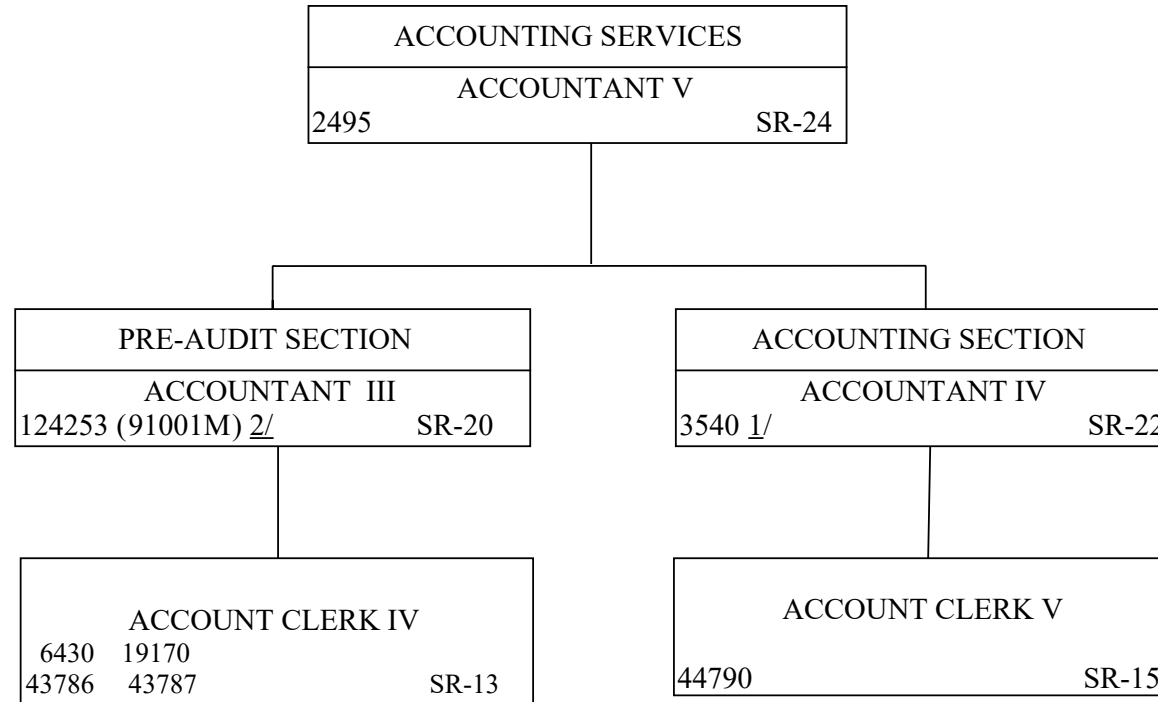
POSITION ORGANIZATION CHART

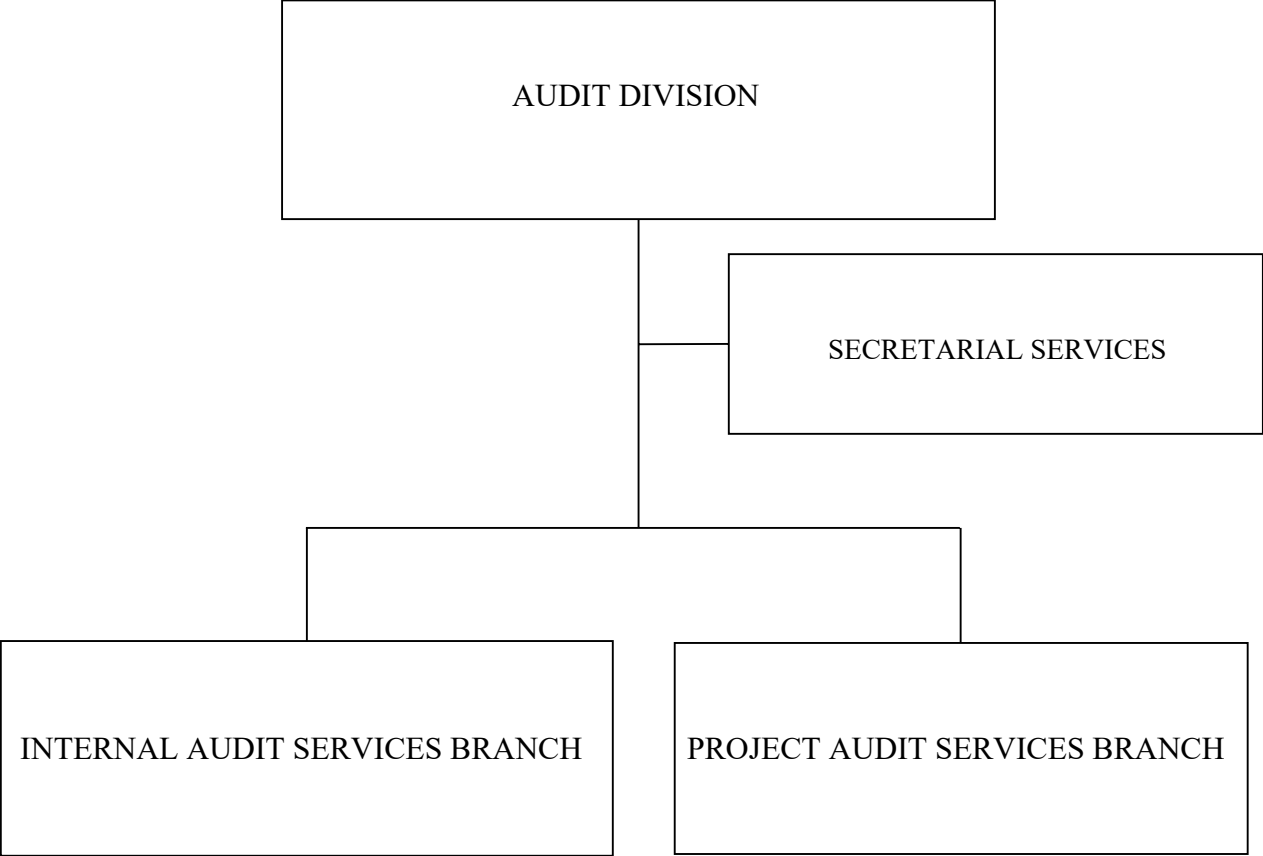

POSITION ORGANIZATION CHART

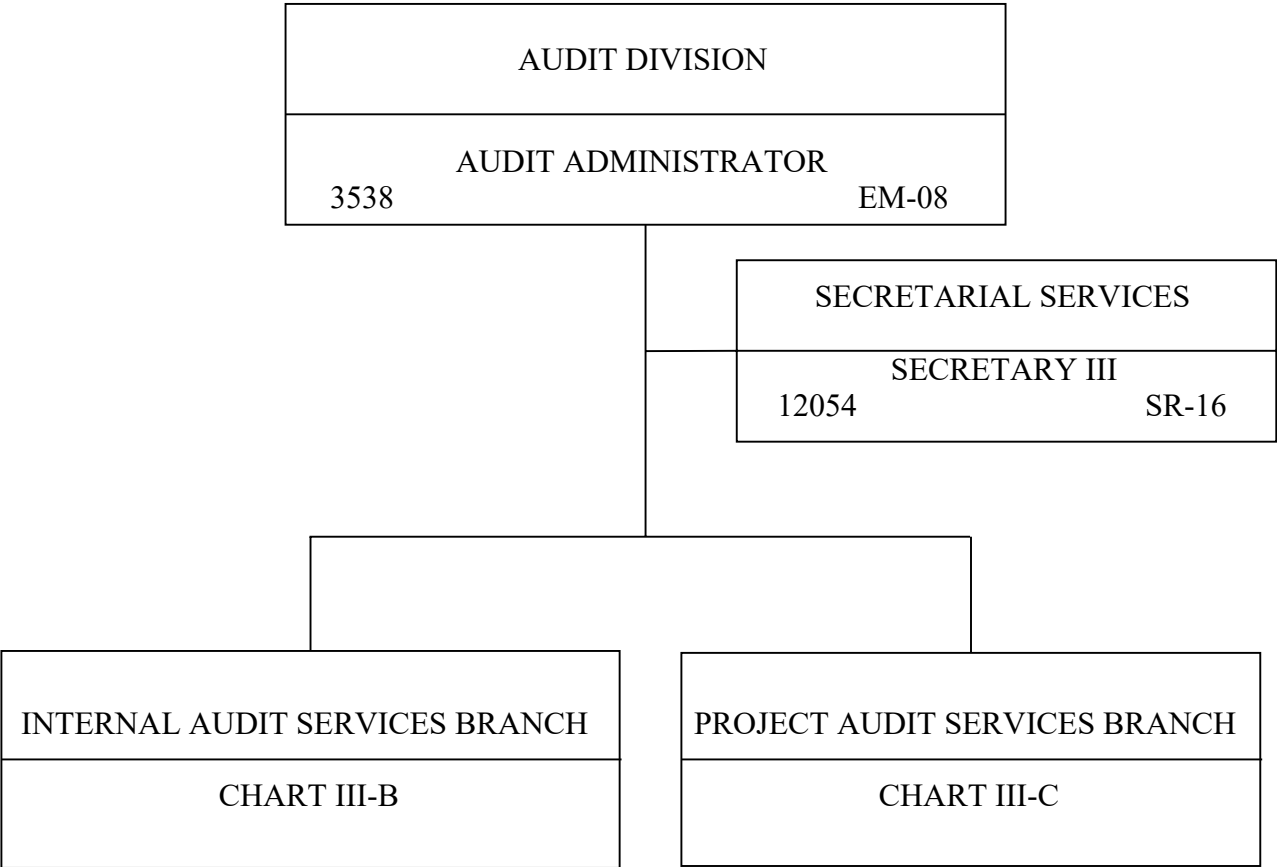

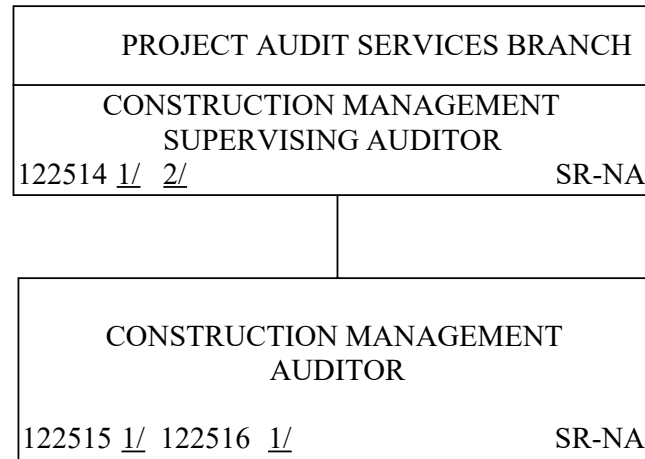

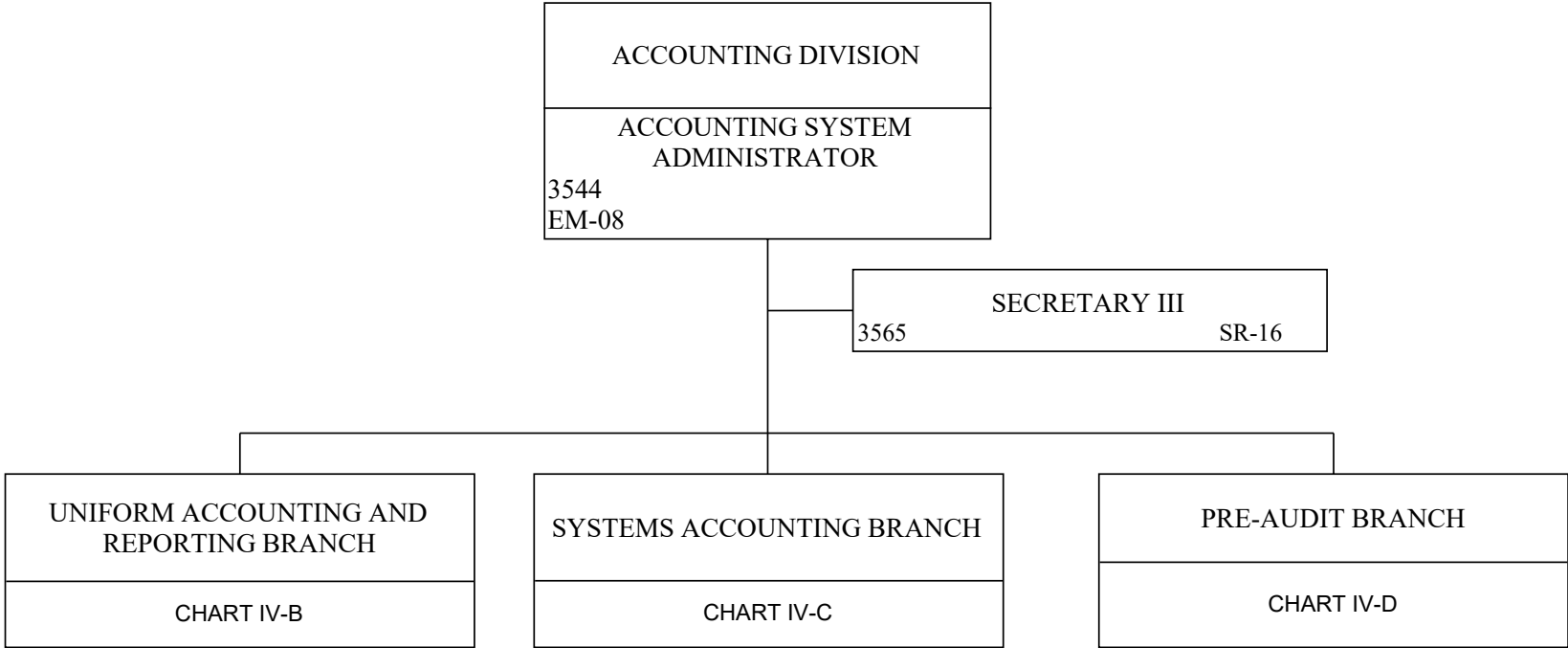
ORGANIZATION CHART

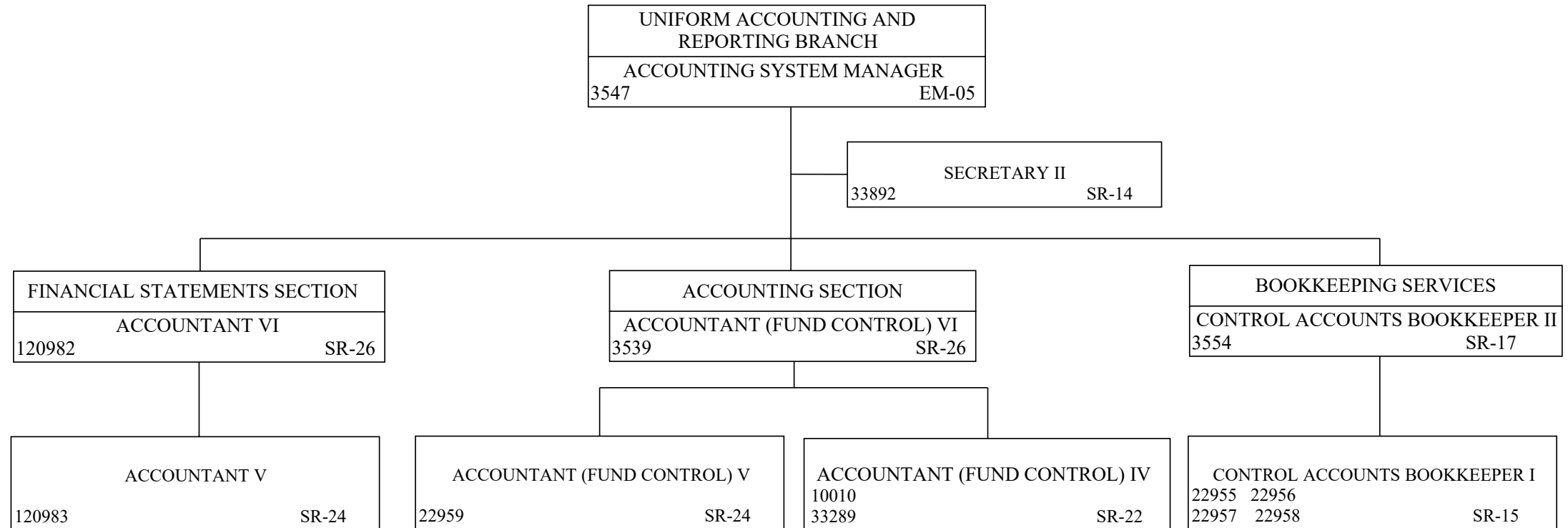
POSITION ORGANIZATION CHART



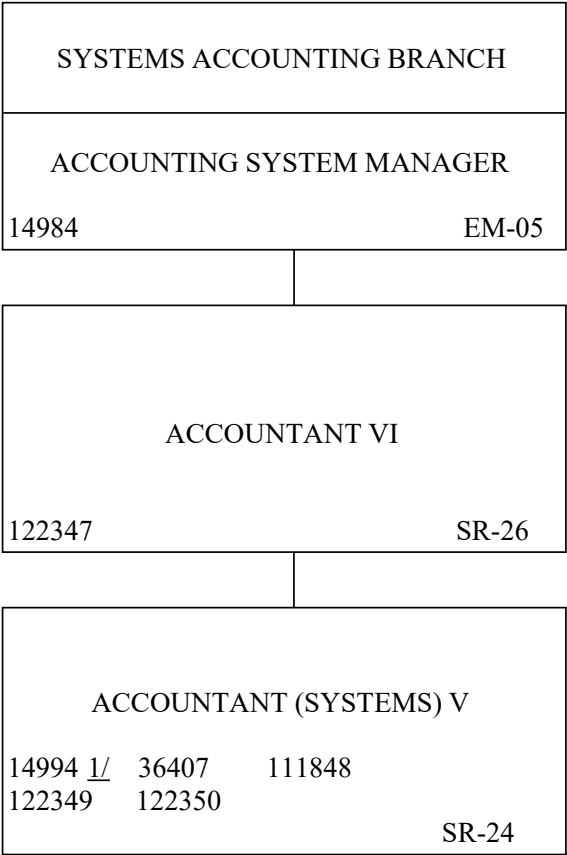

POSITION ORGANIZATION CHART



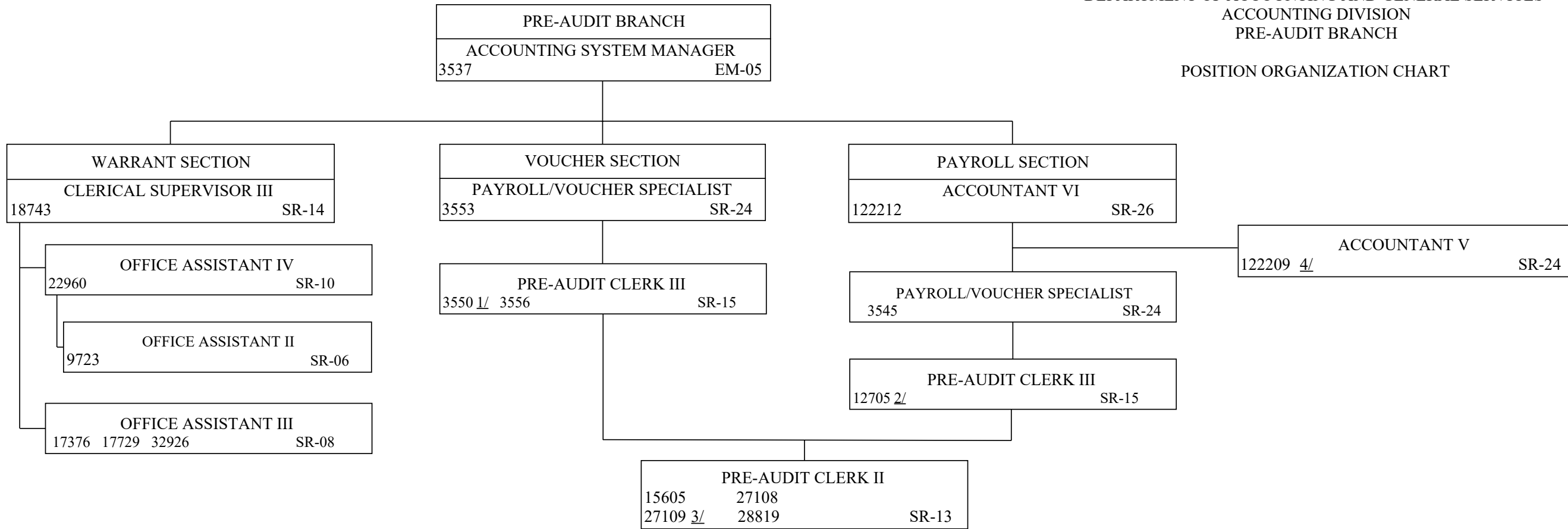

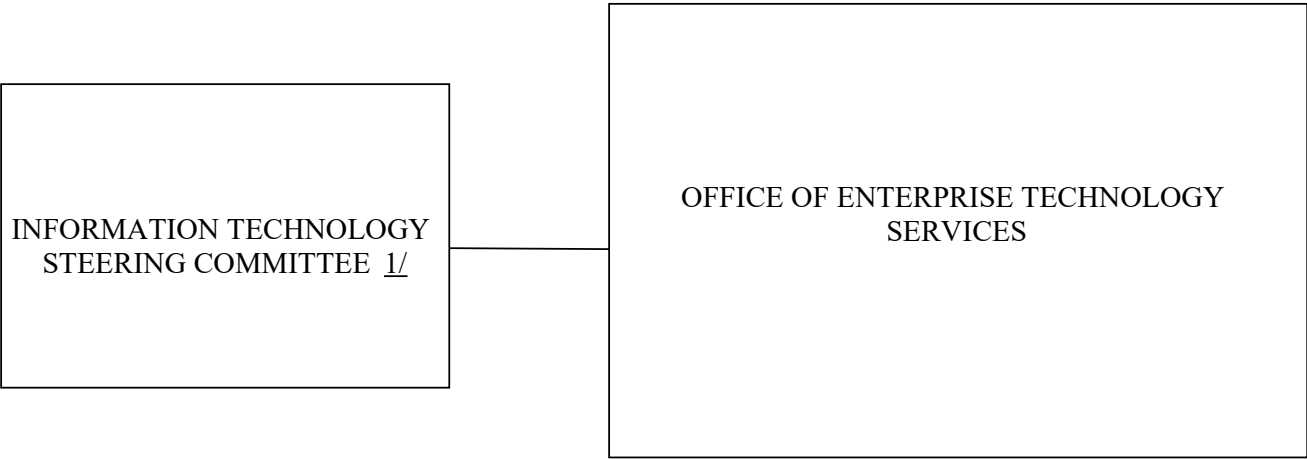

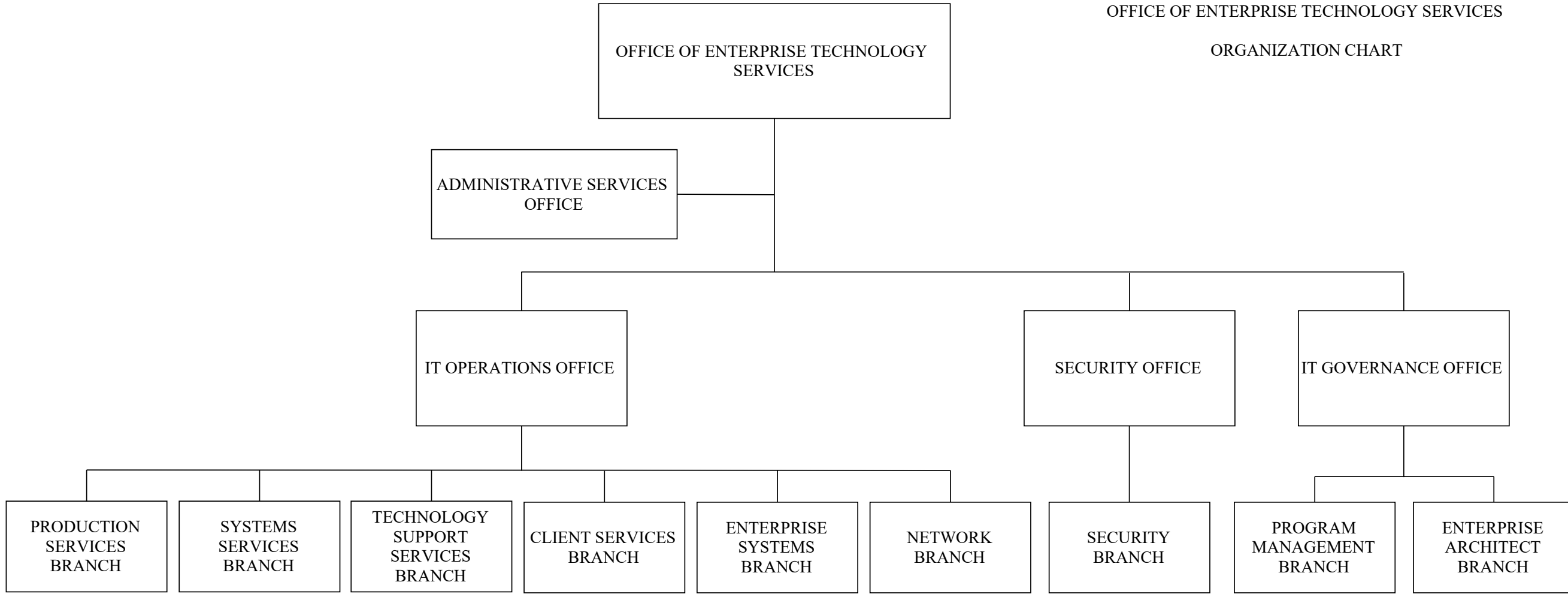

POSITION ORGANIZATION CHART



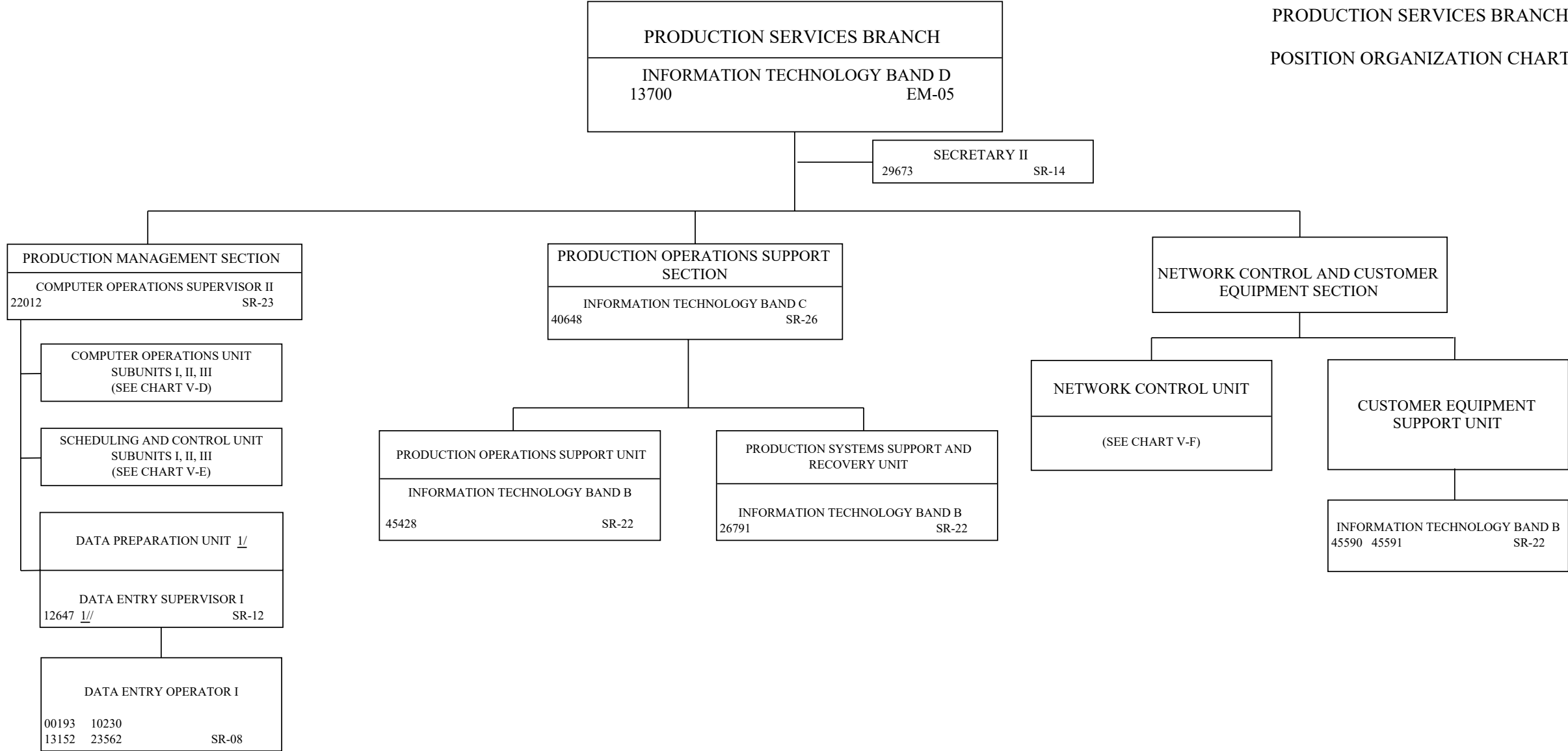

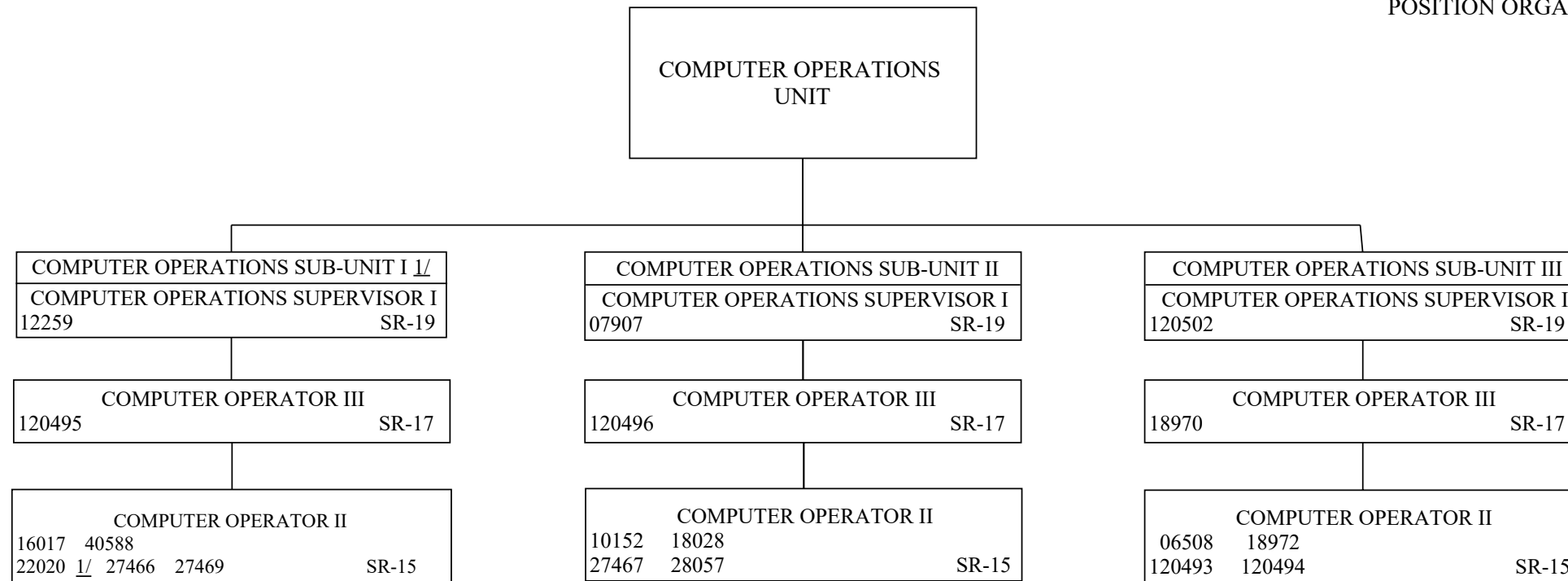

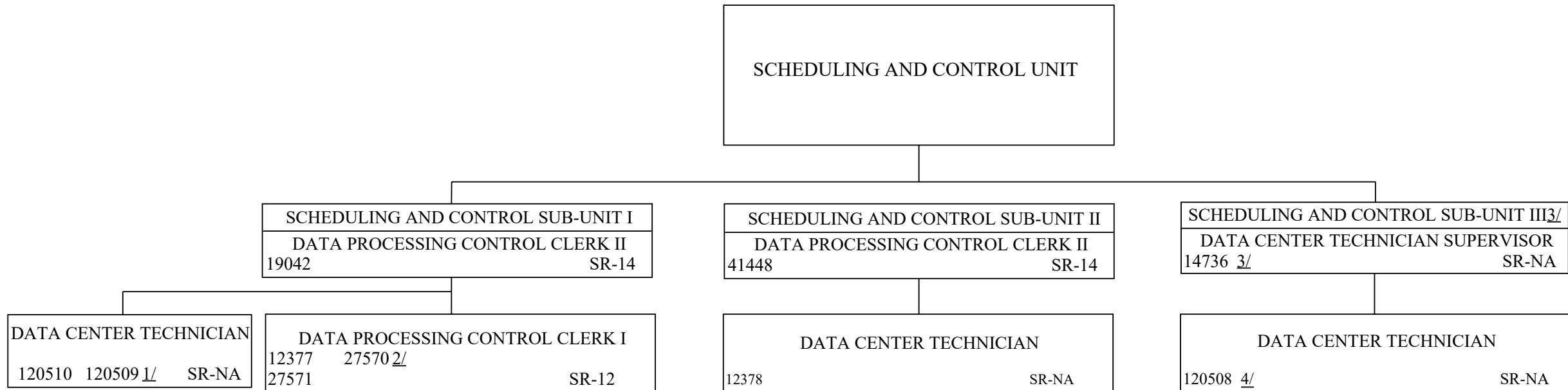

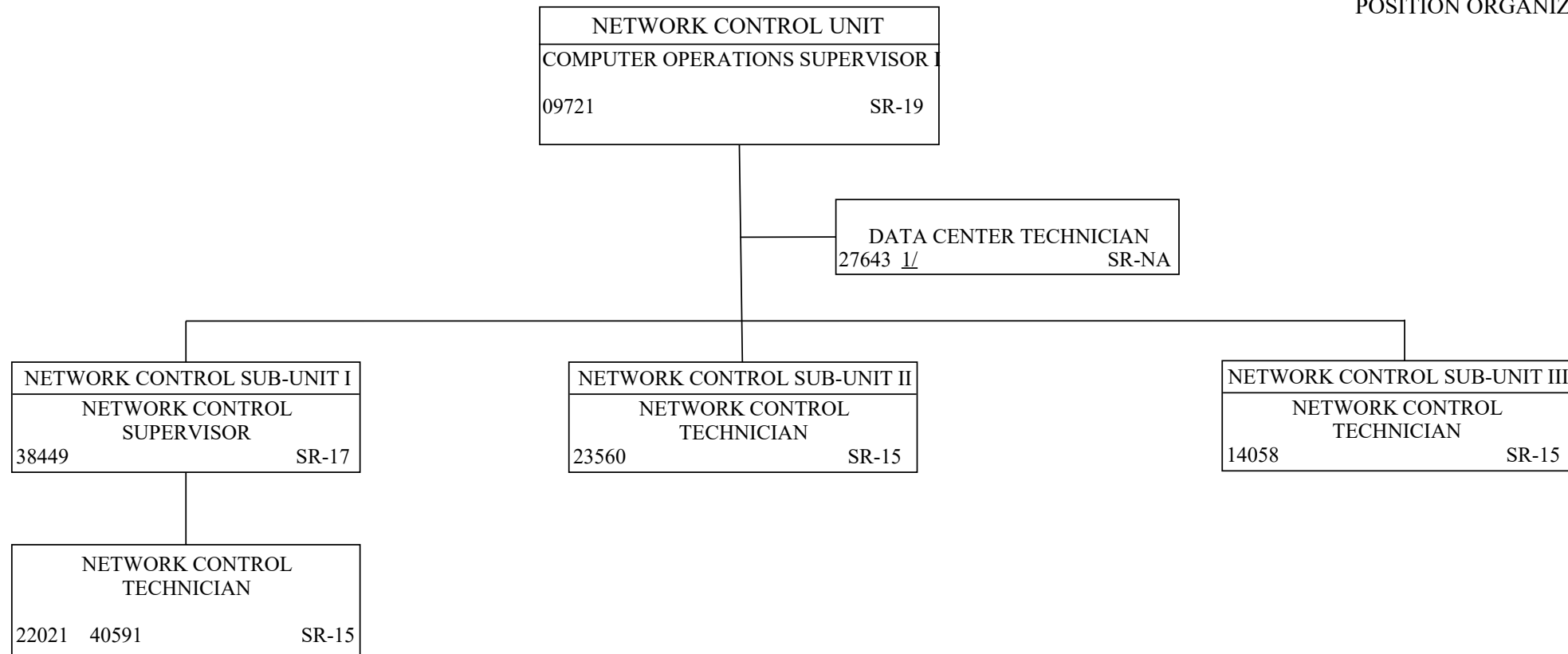

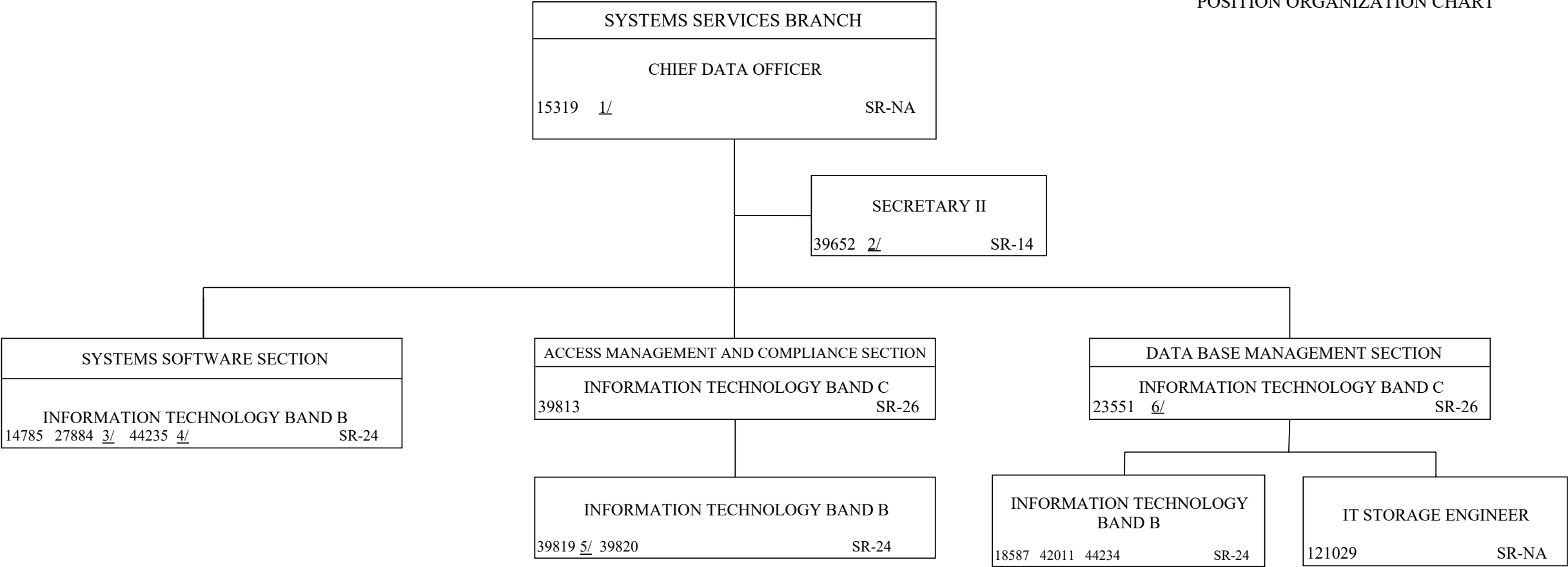

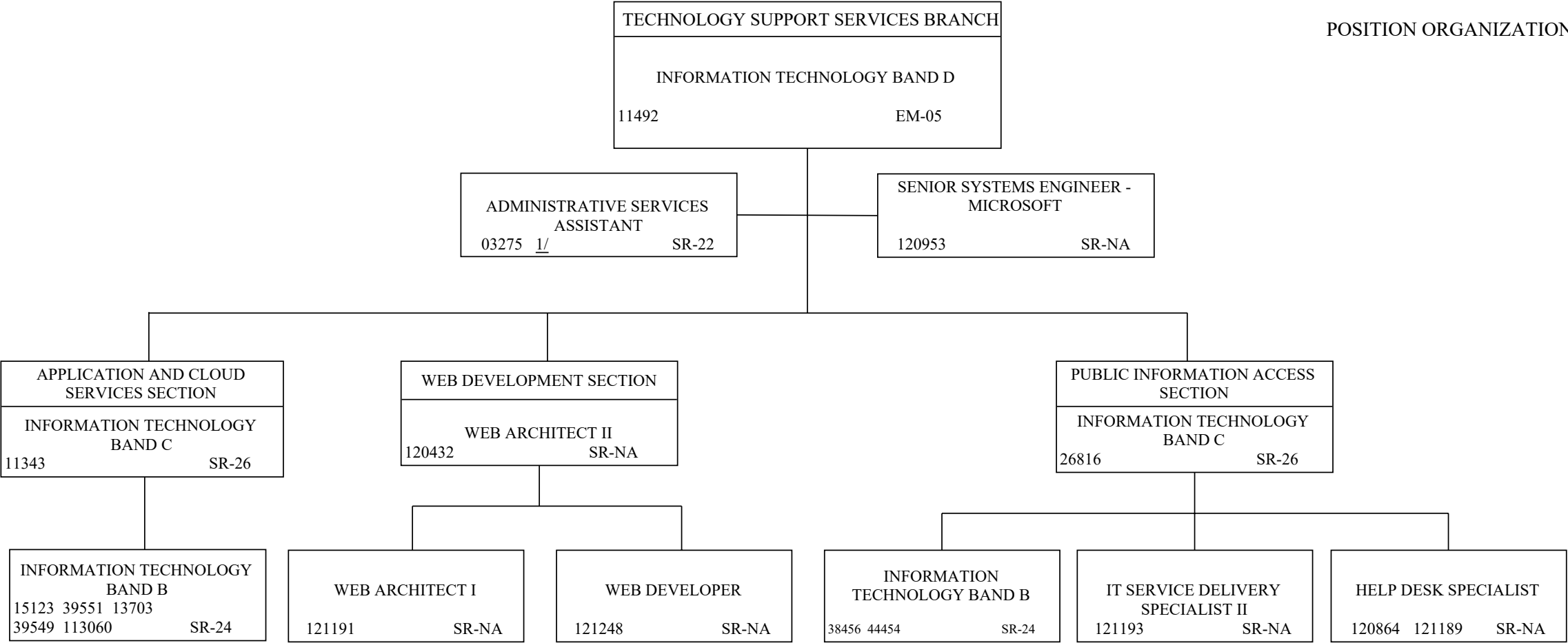

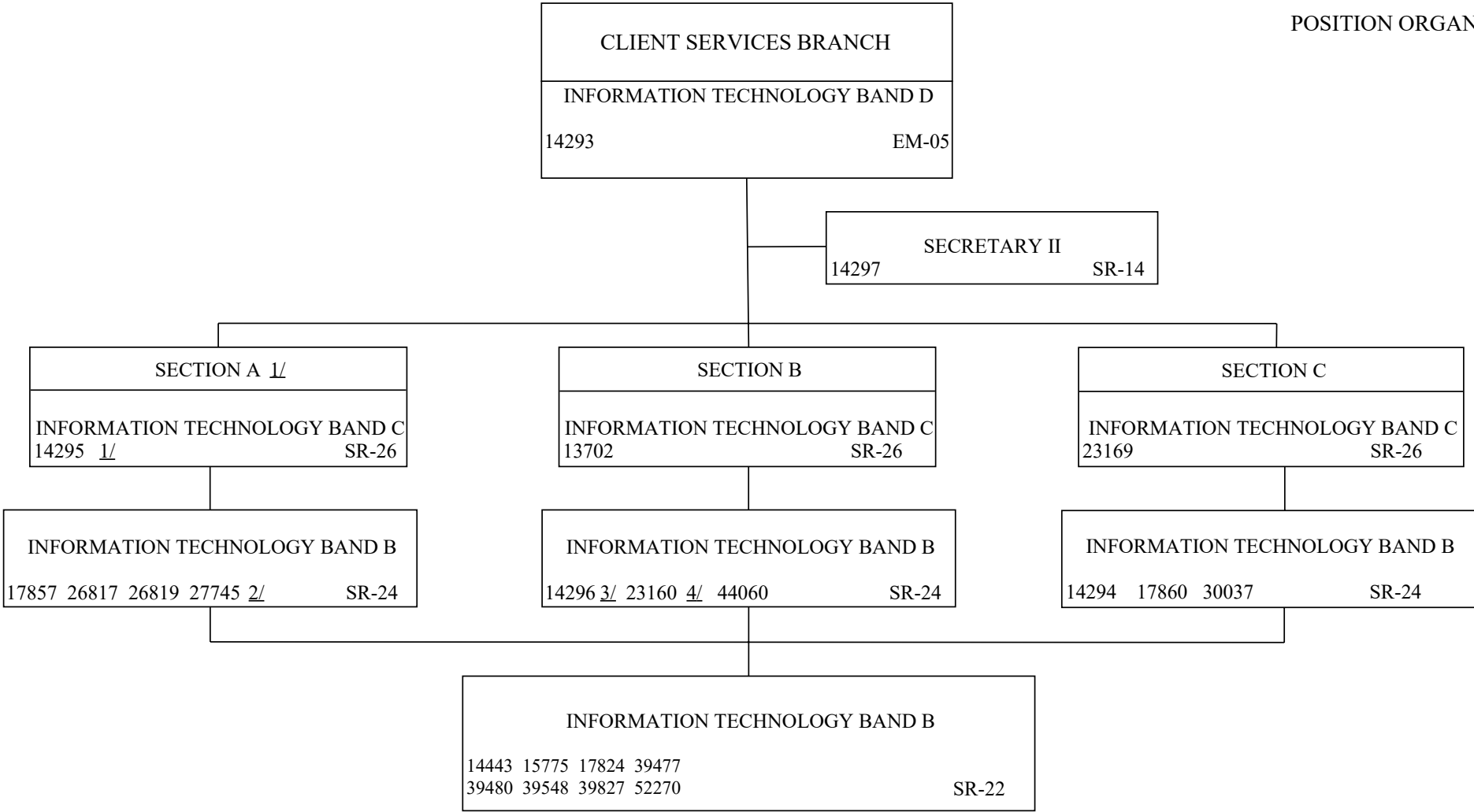

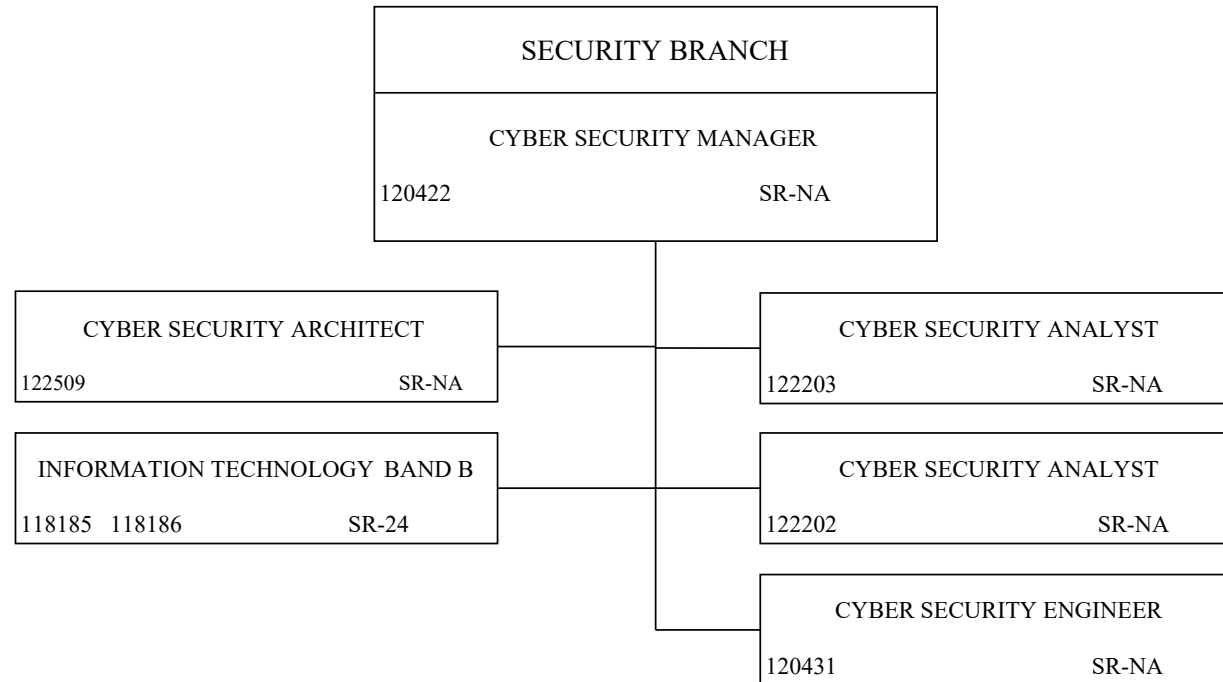

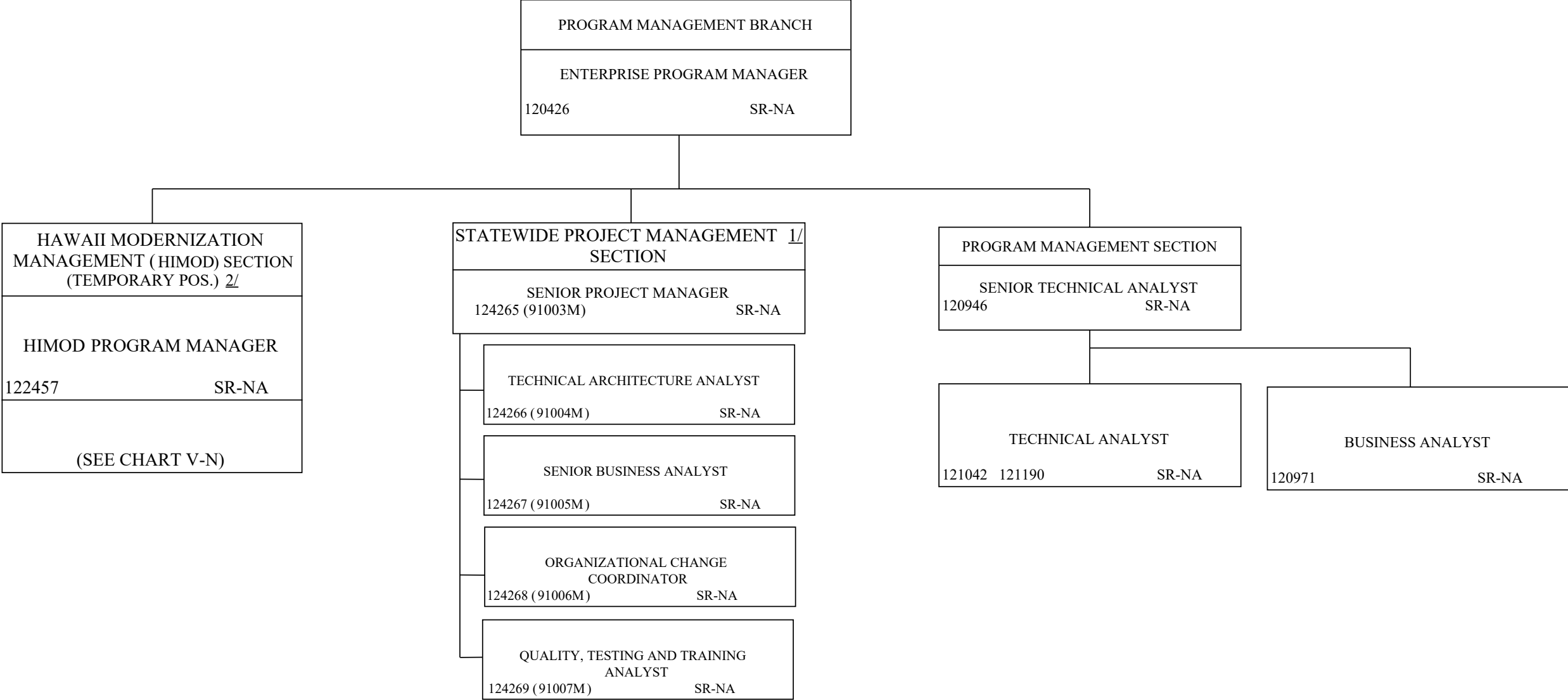

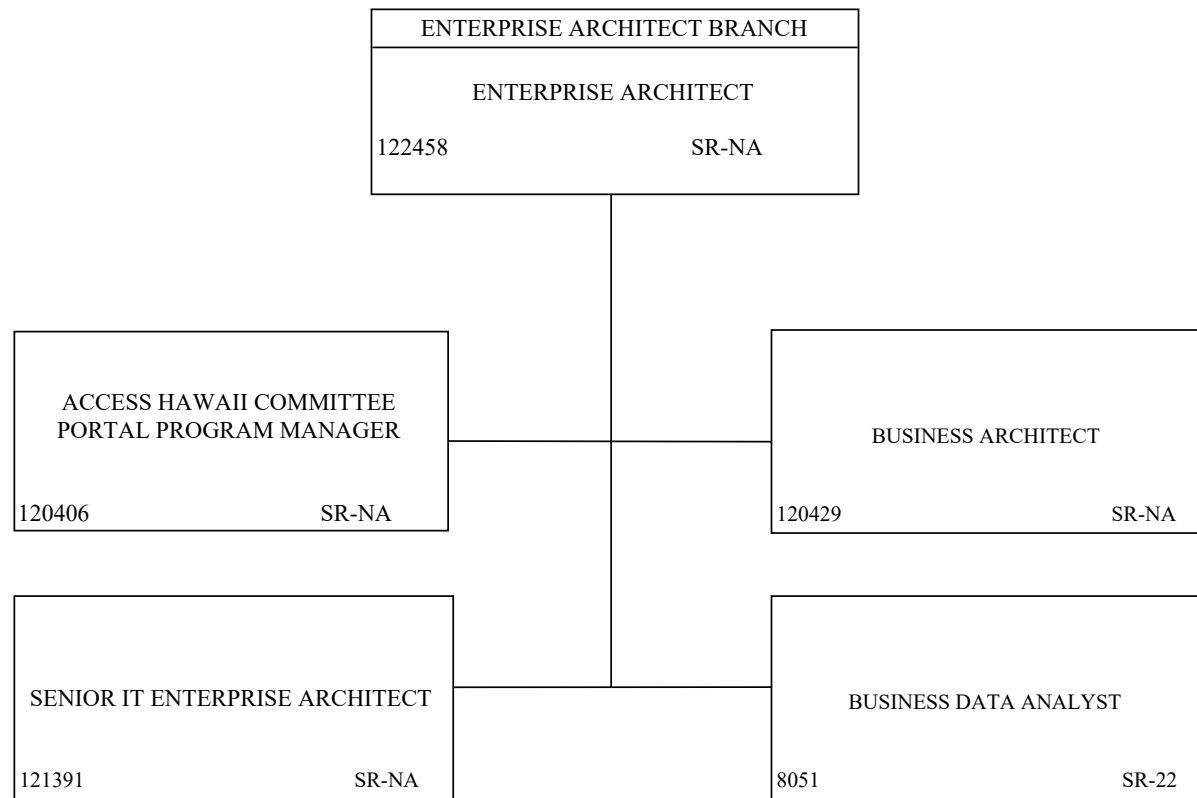

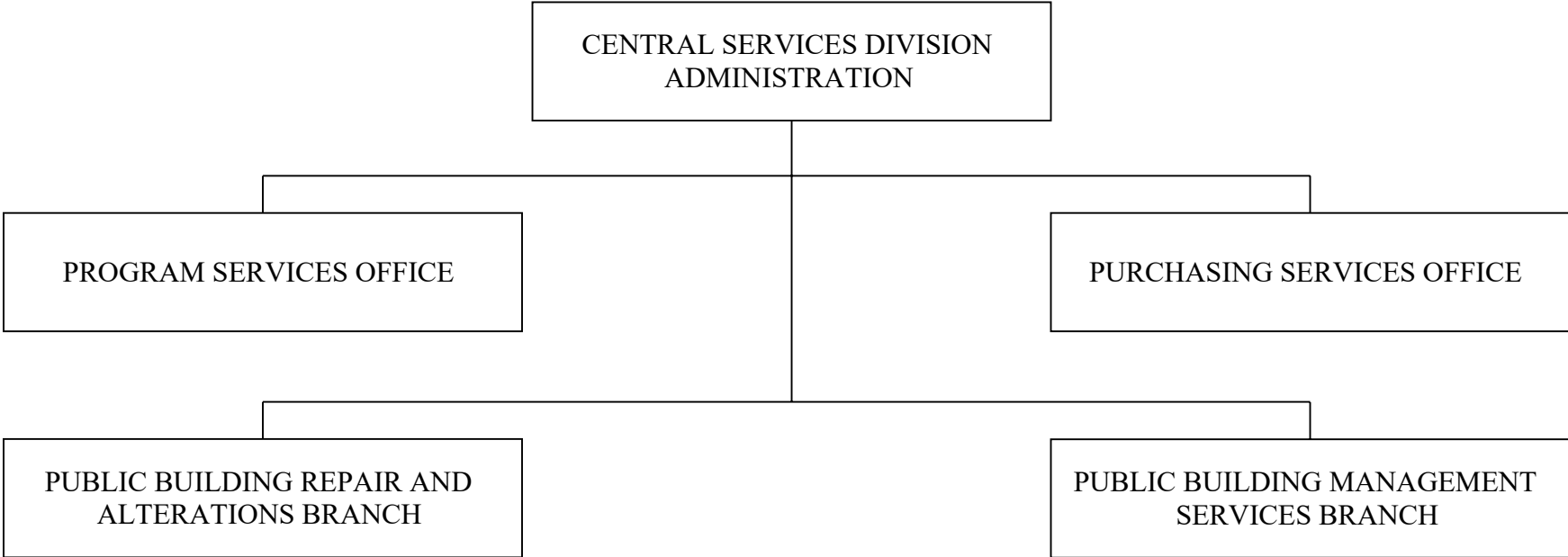

POSITION ORGANIZATION CHART



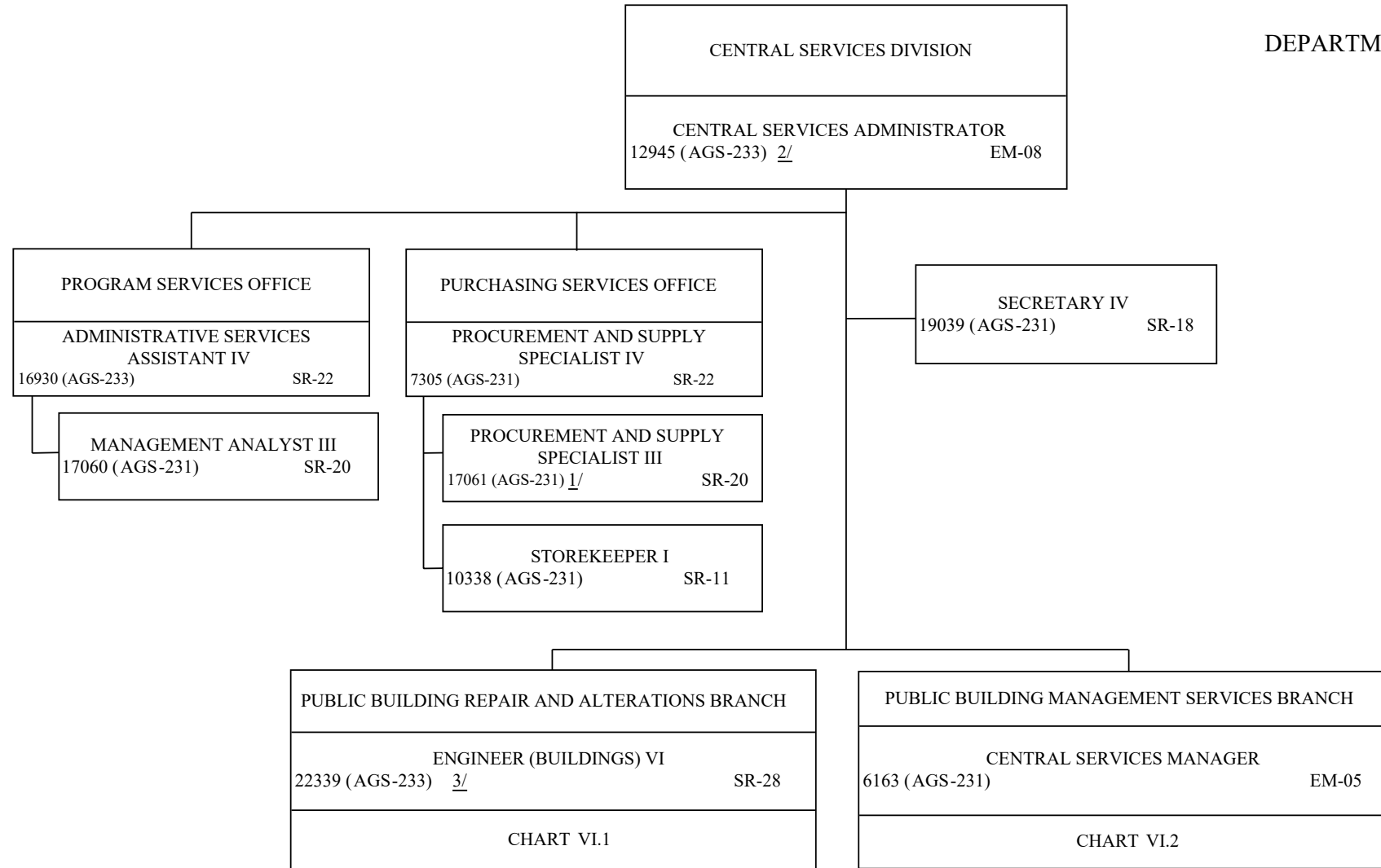

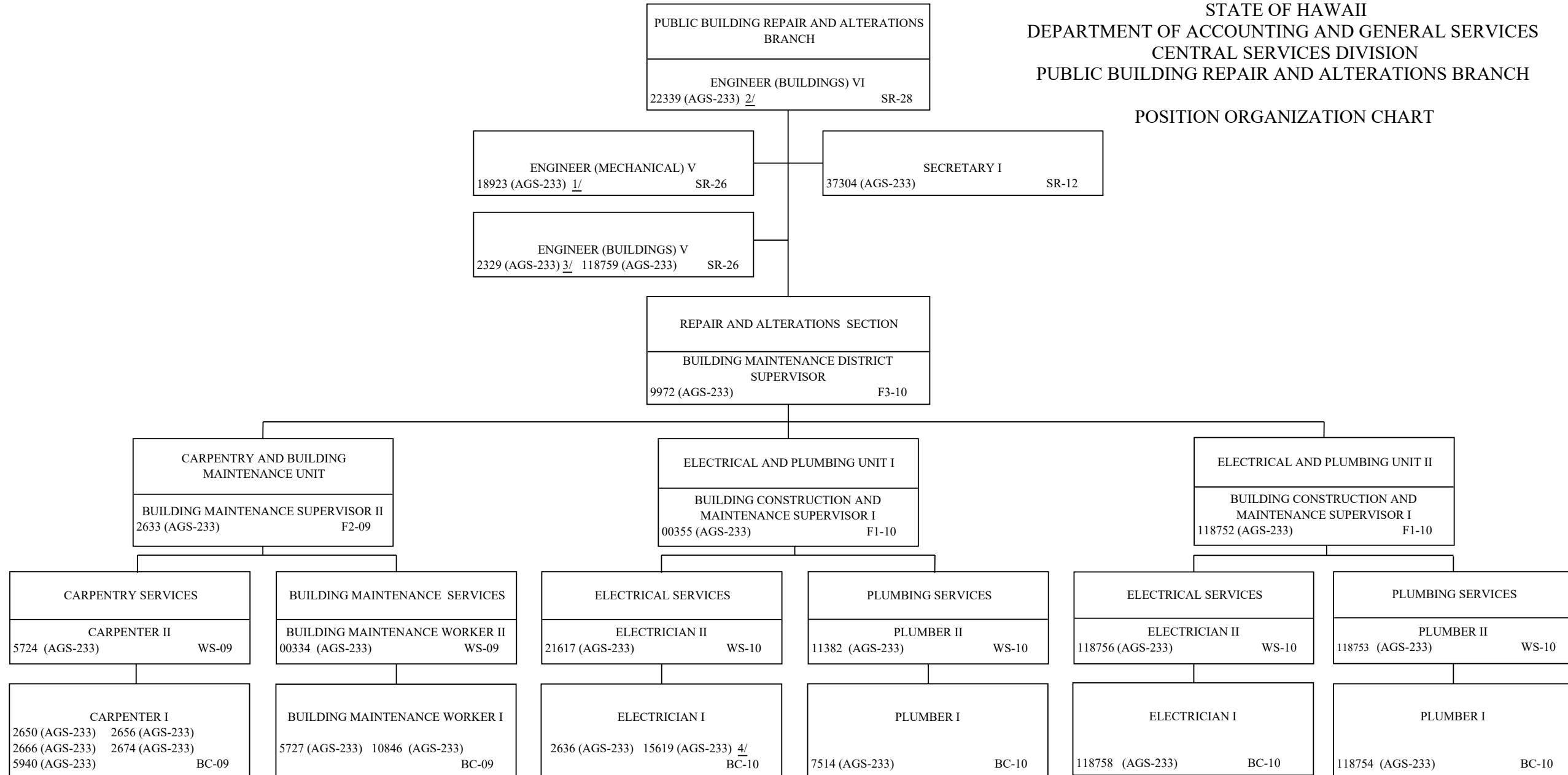

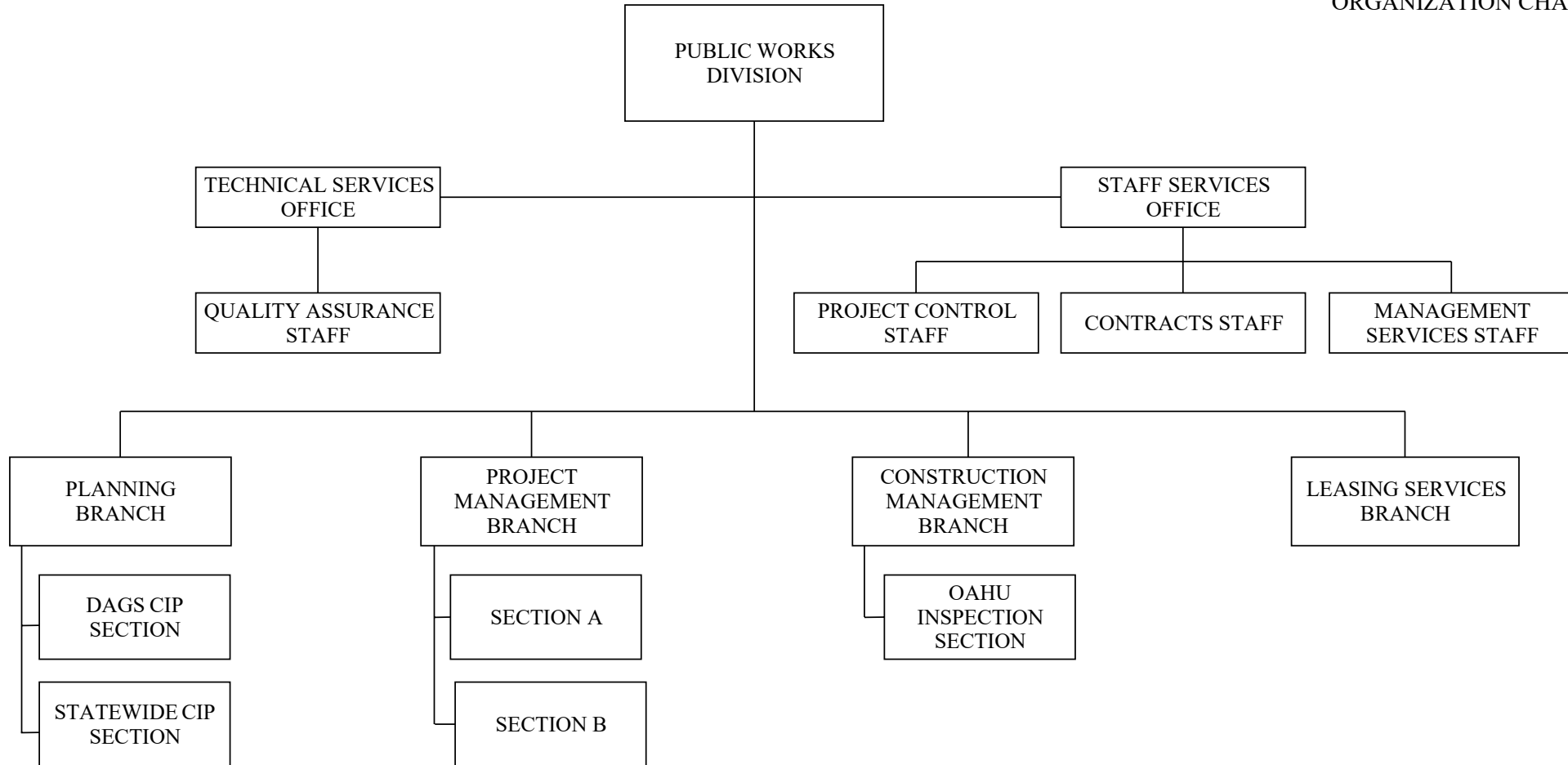

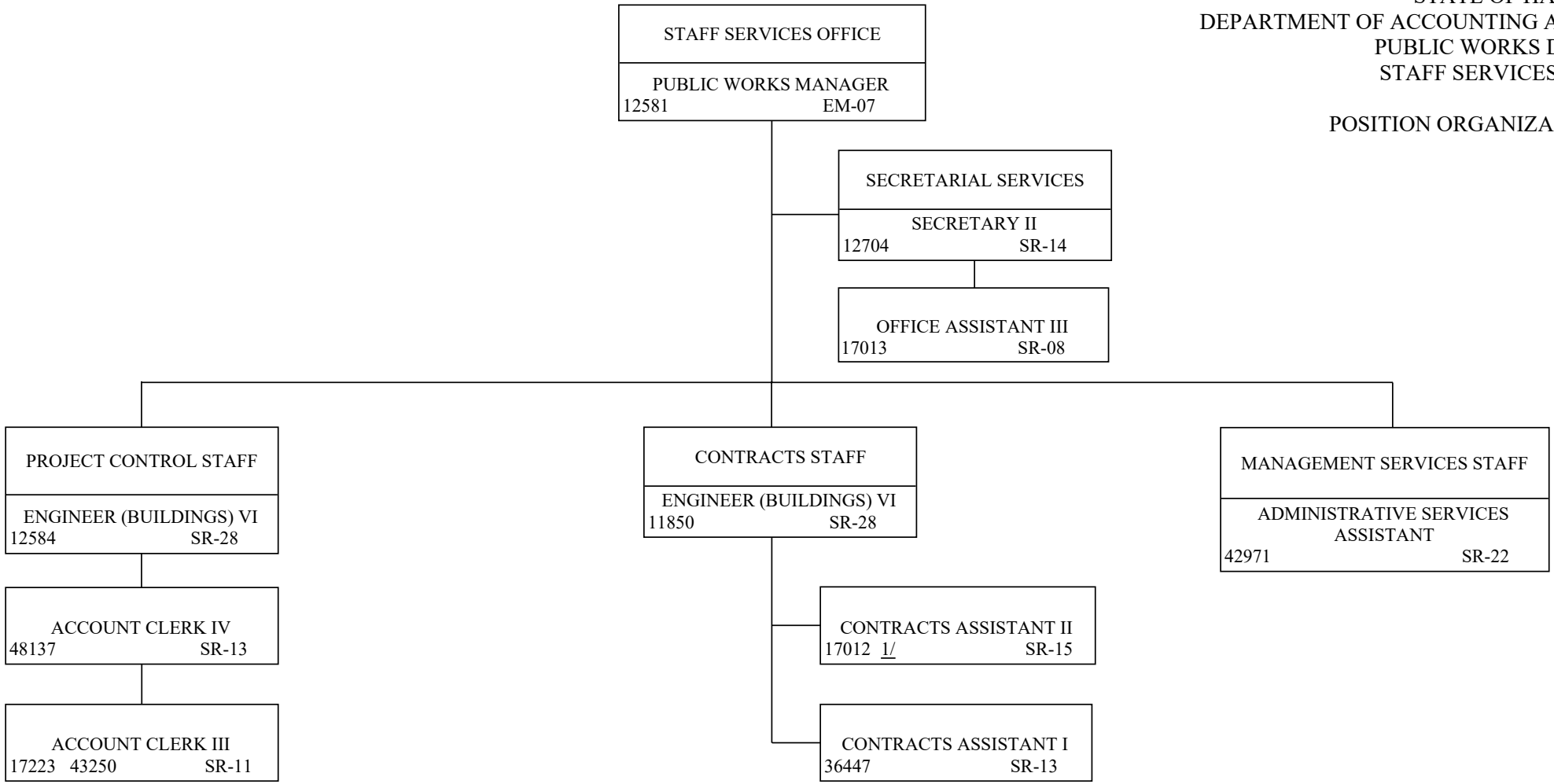

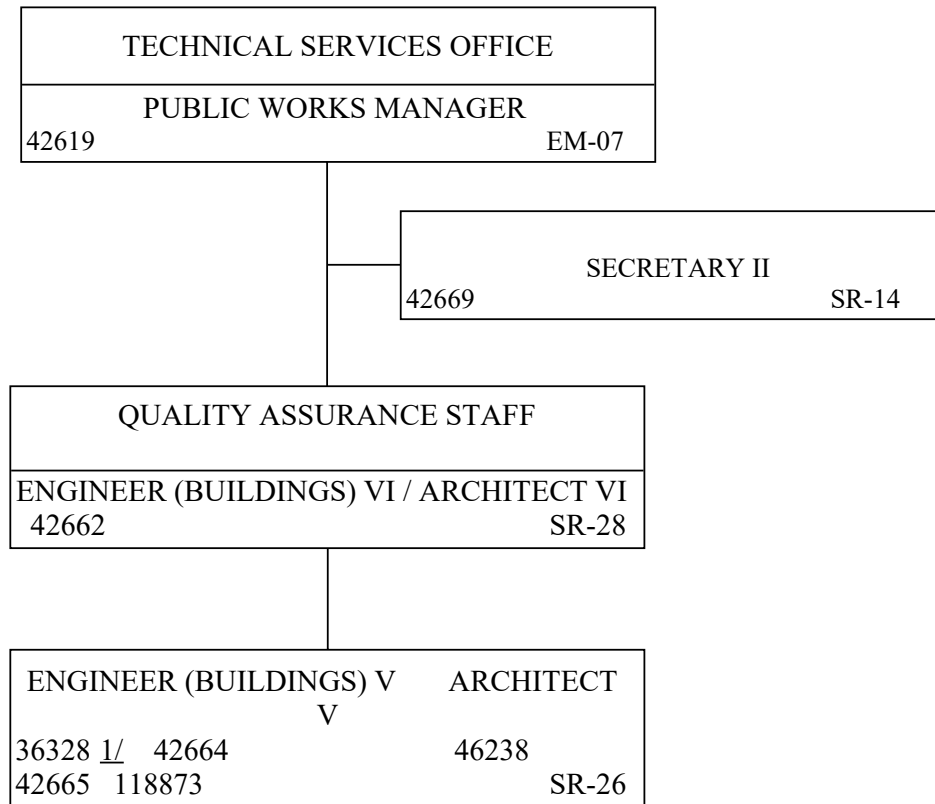

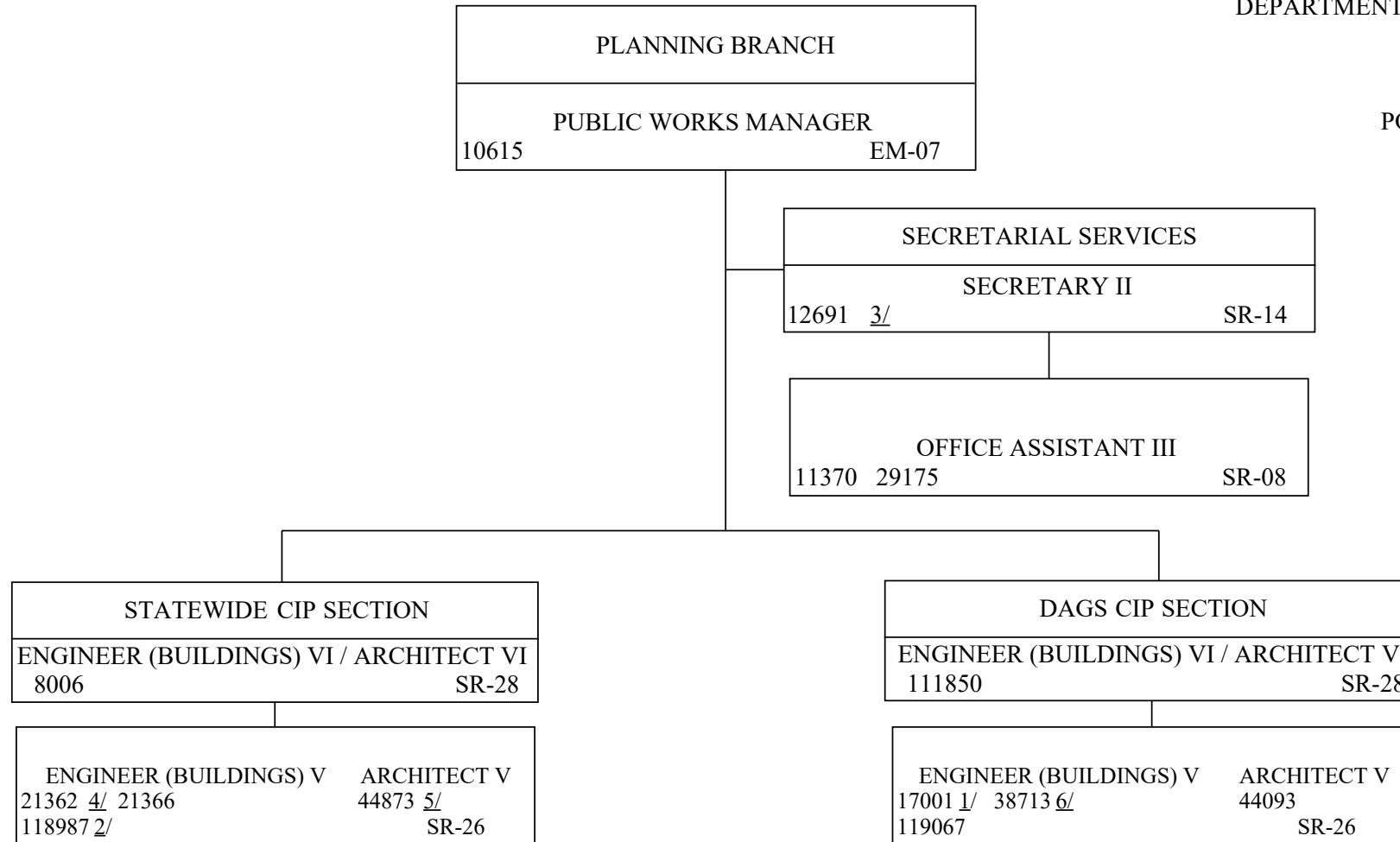

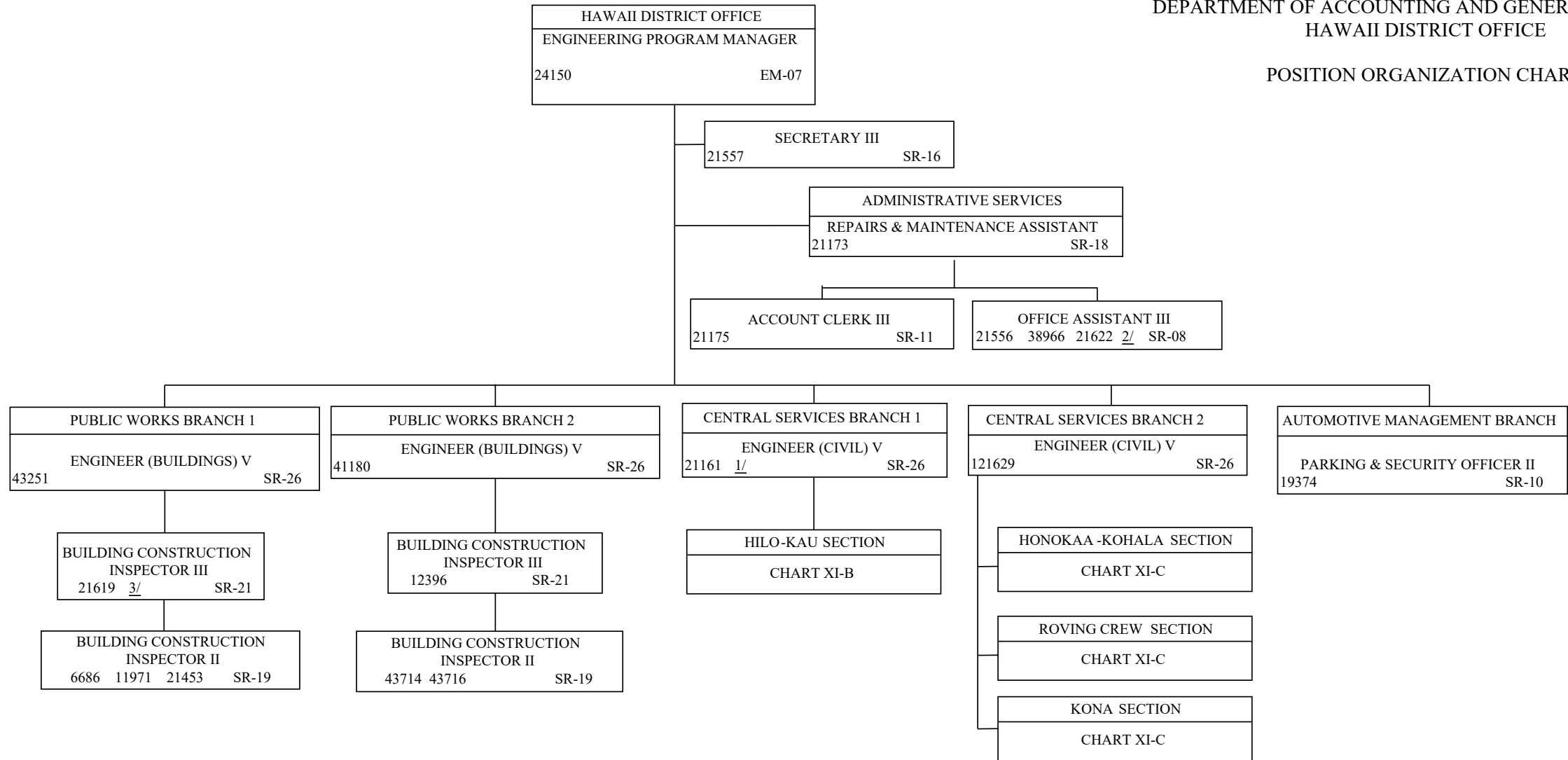

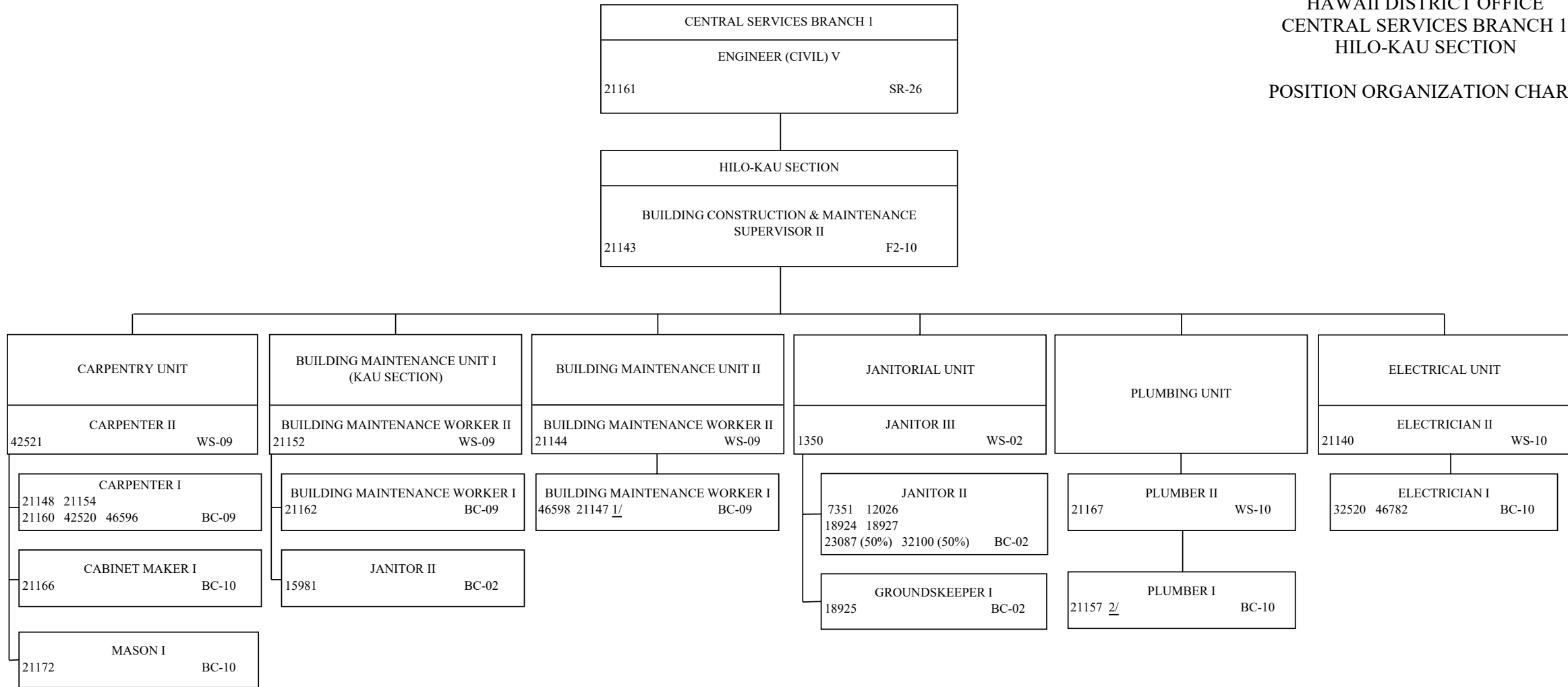

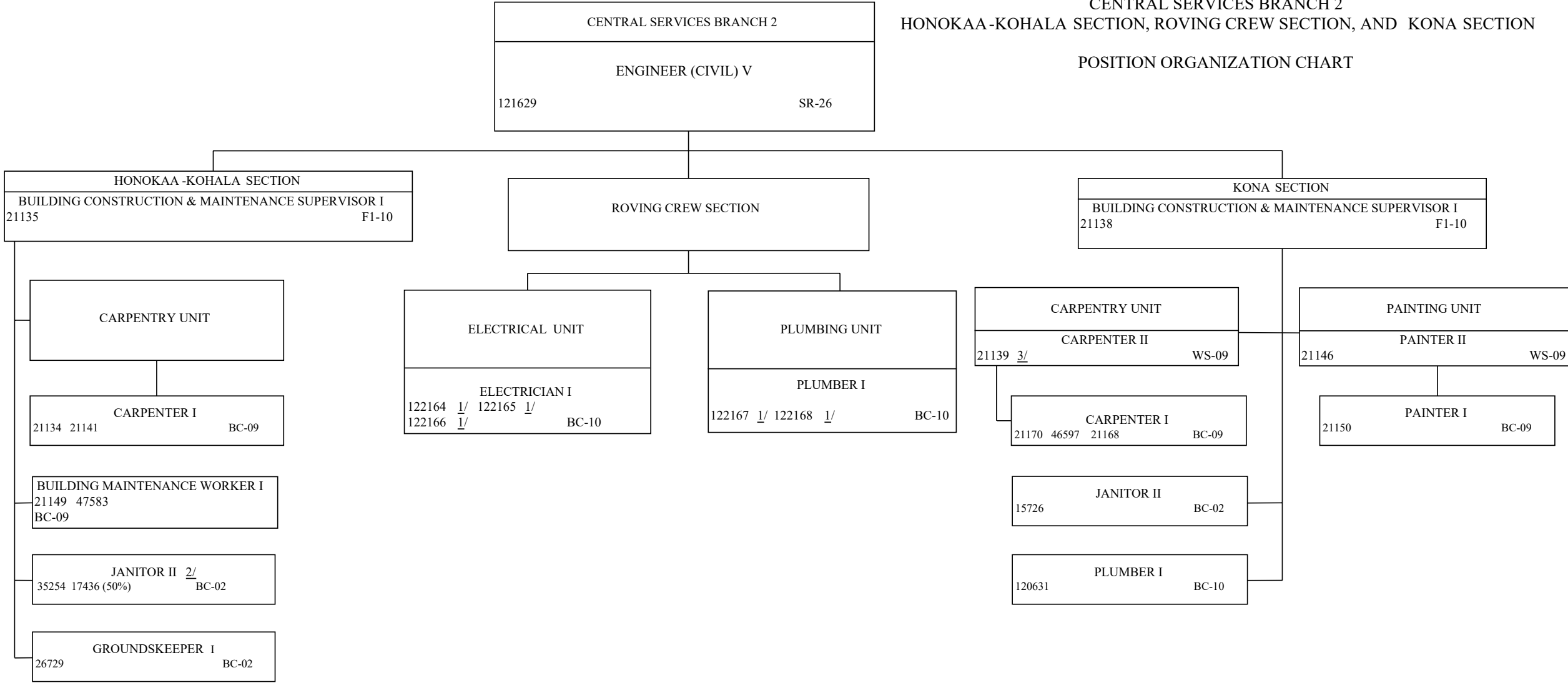

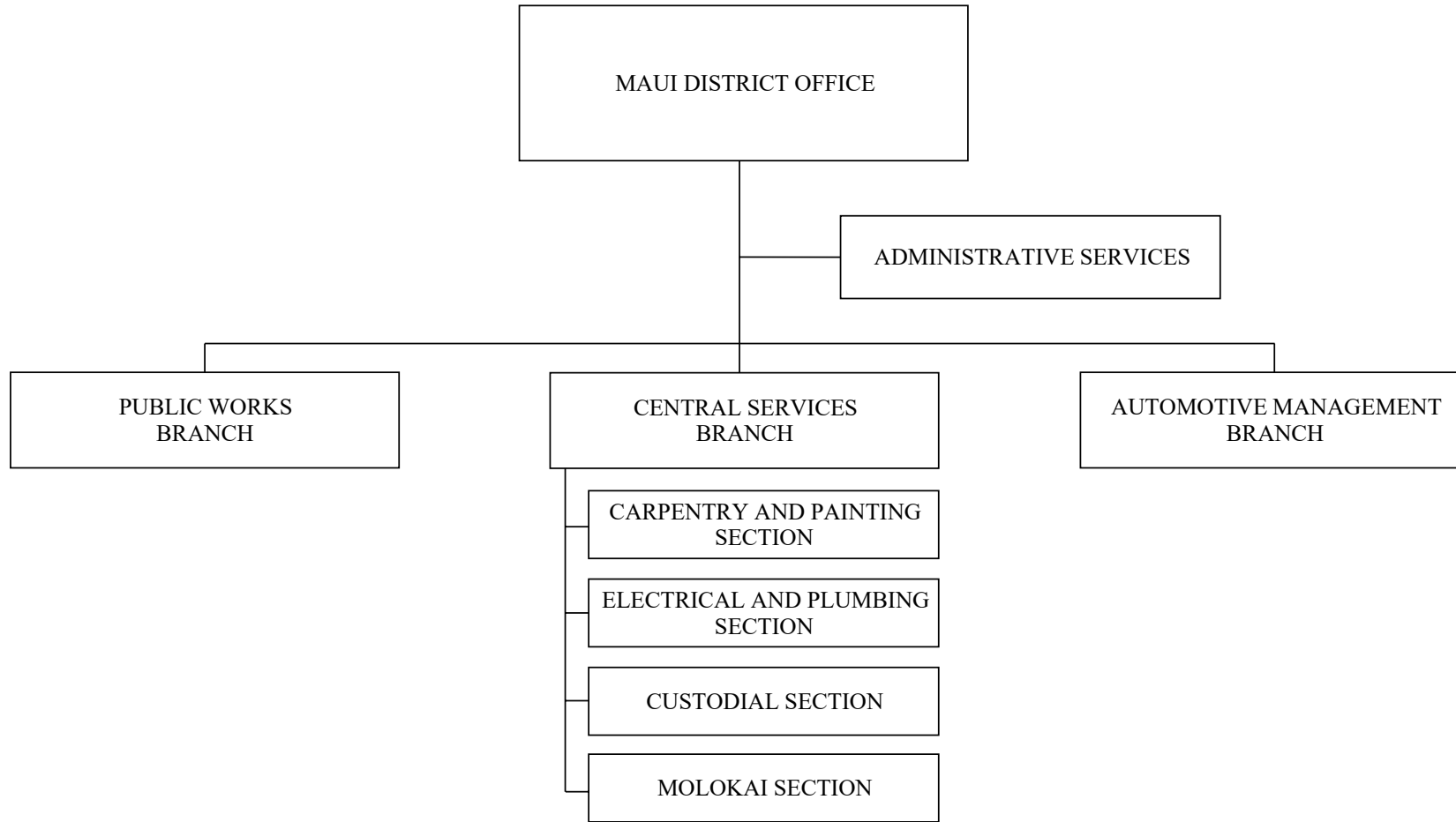

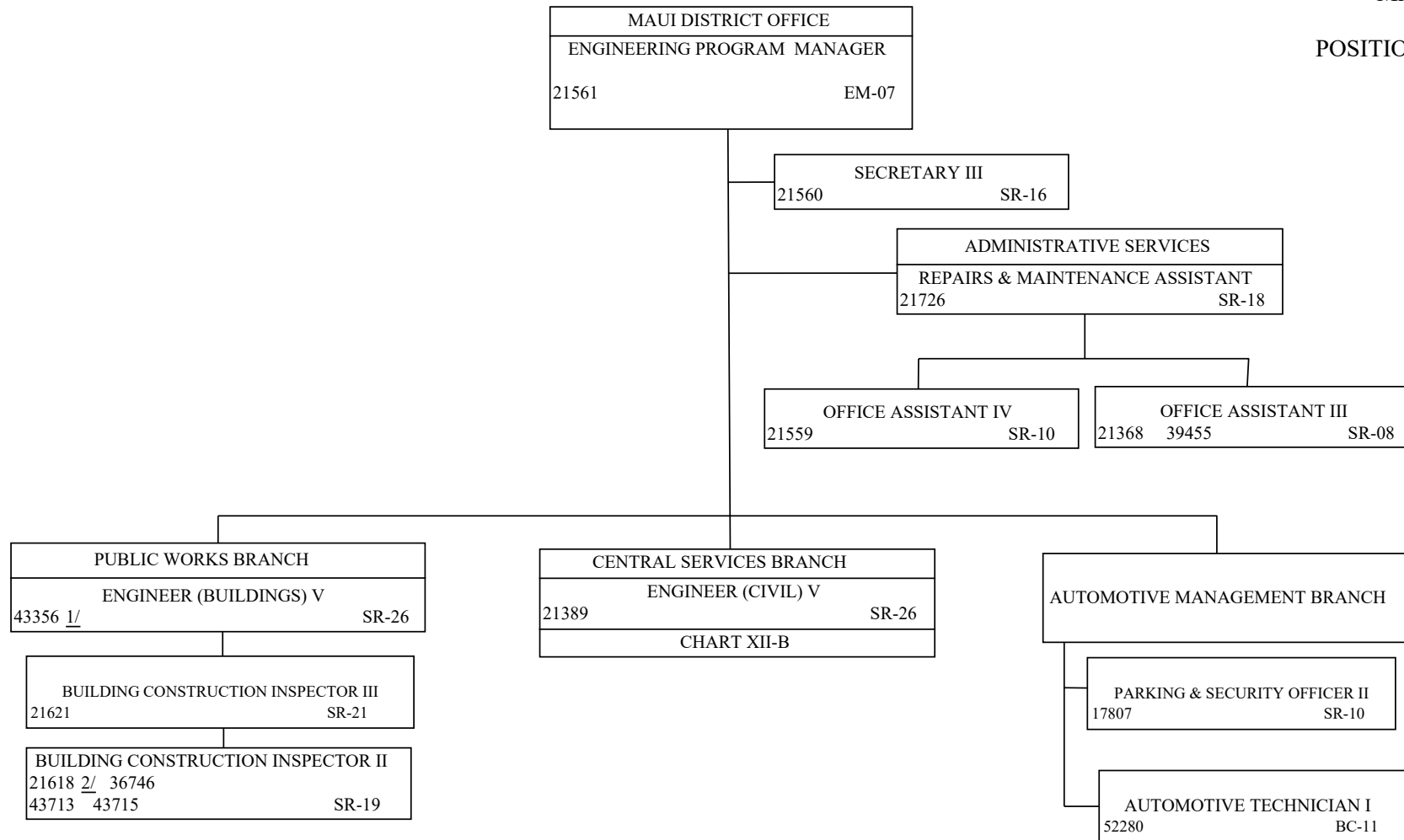

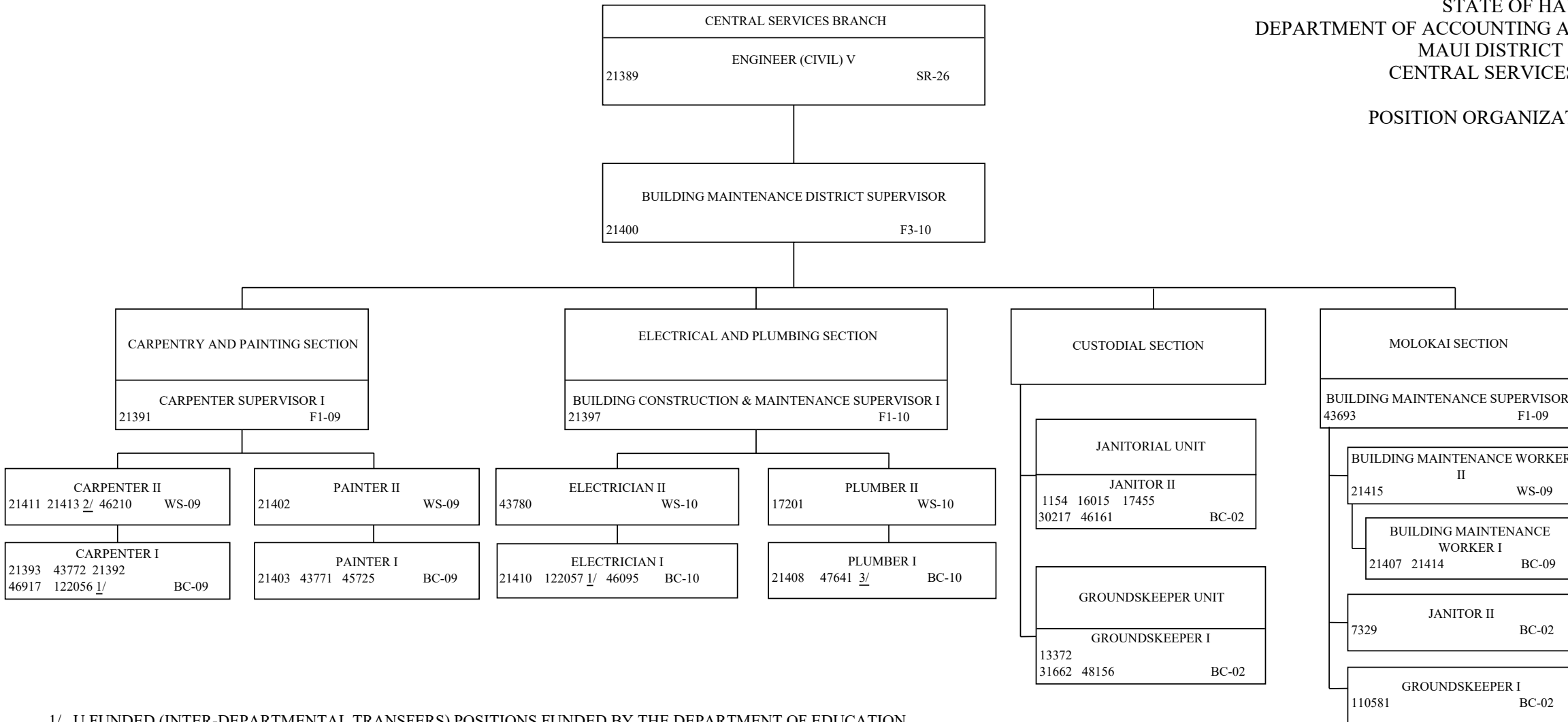

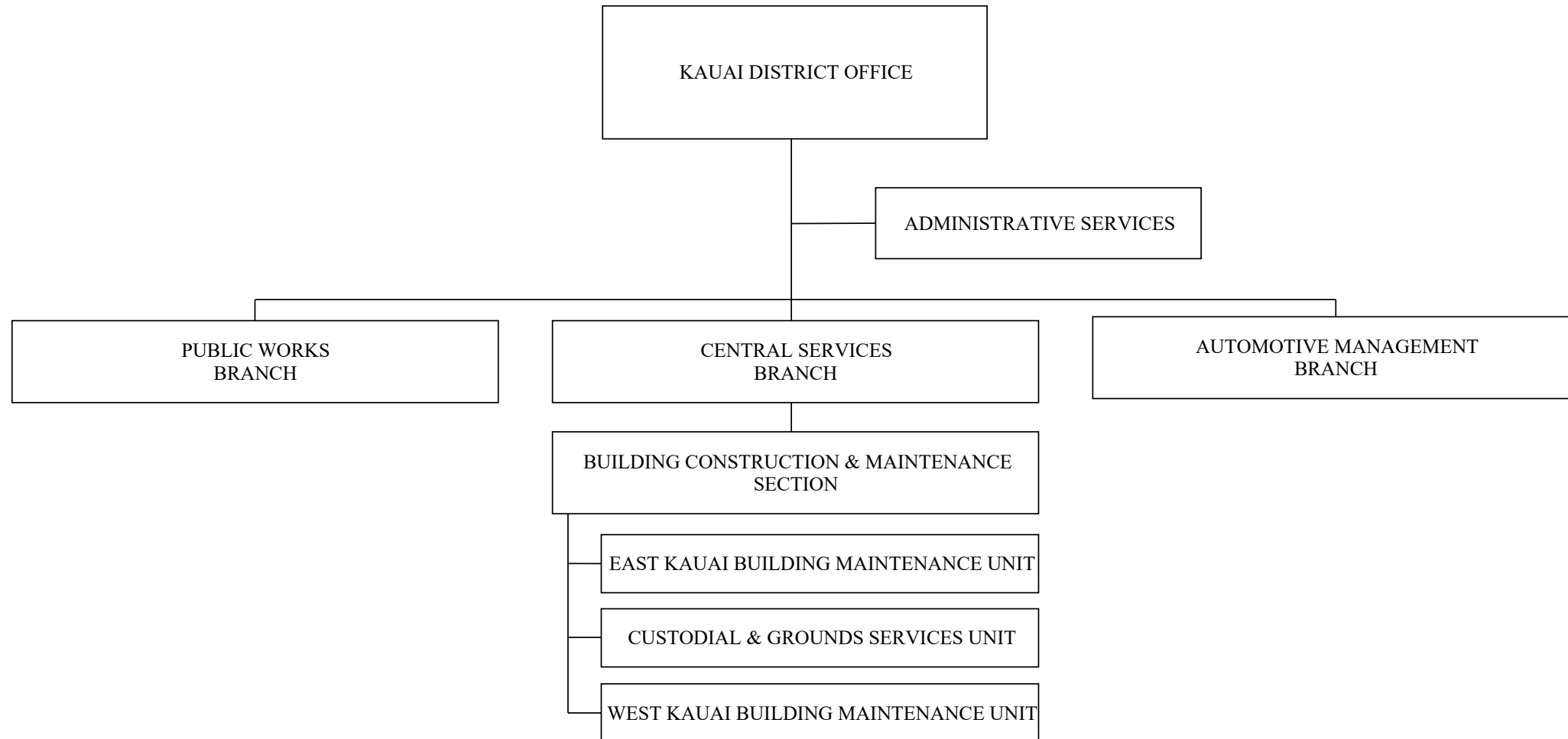

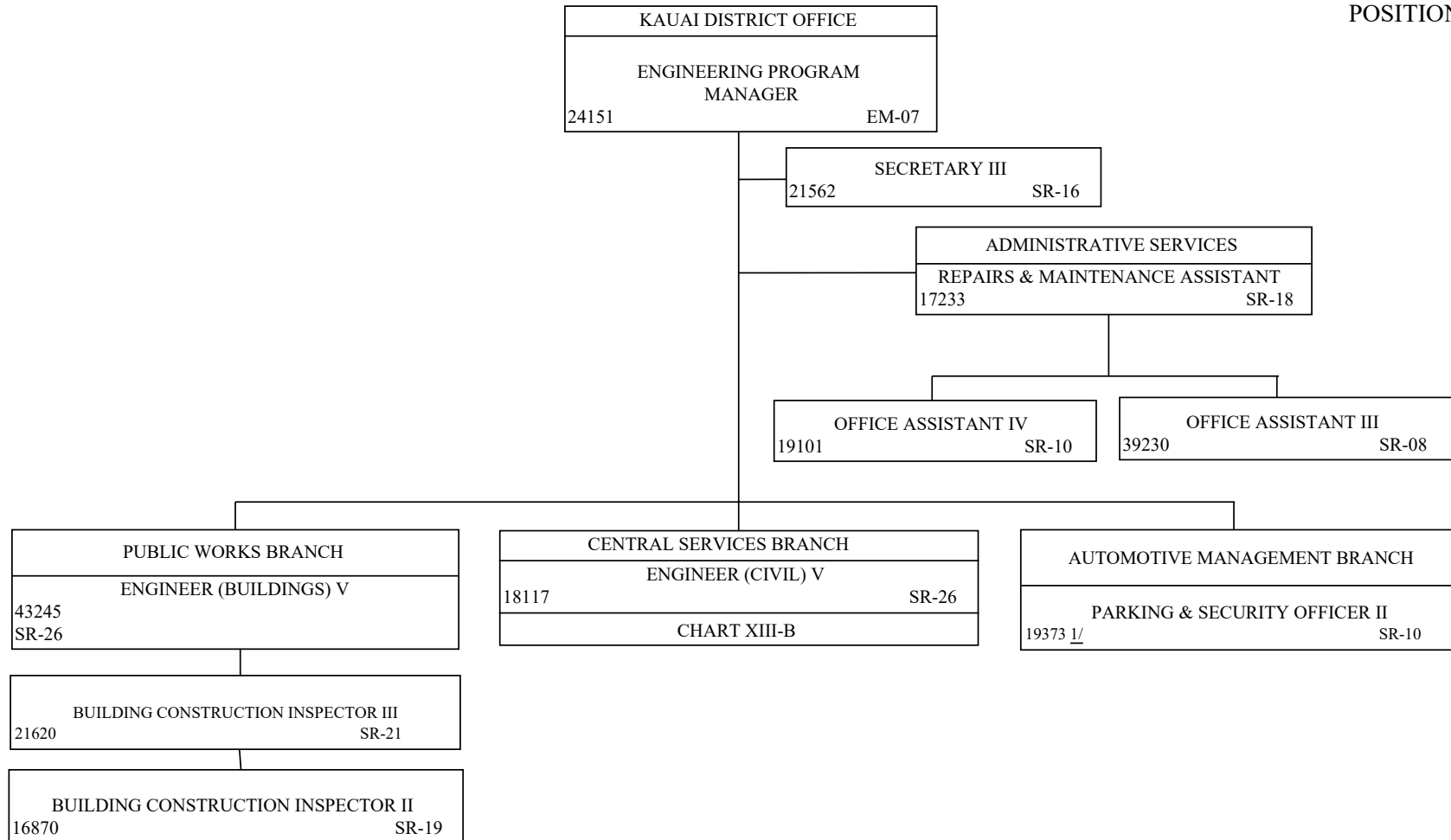

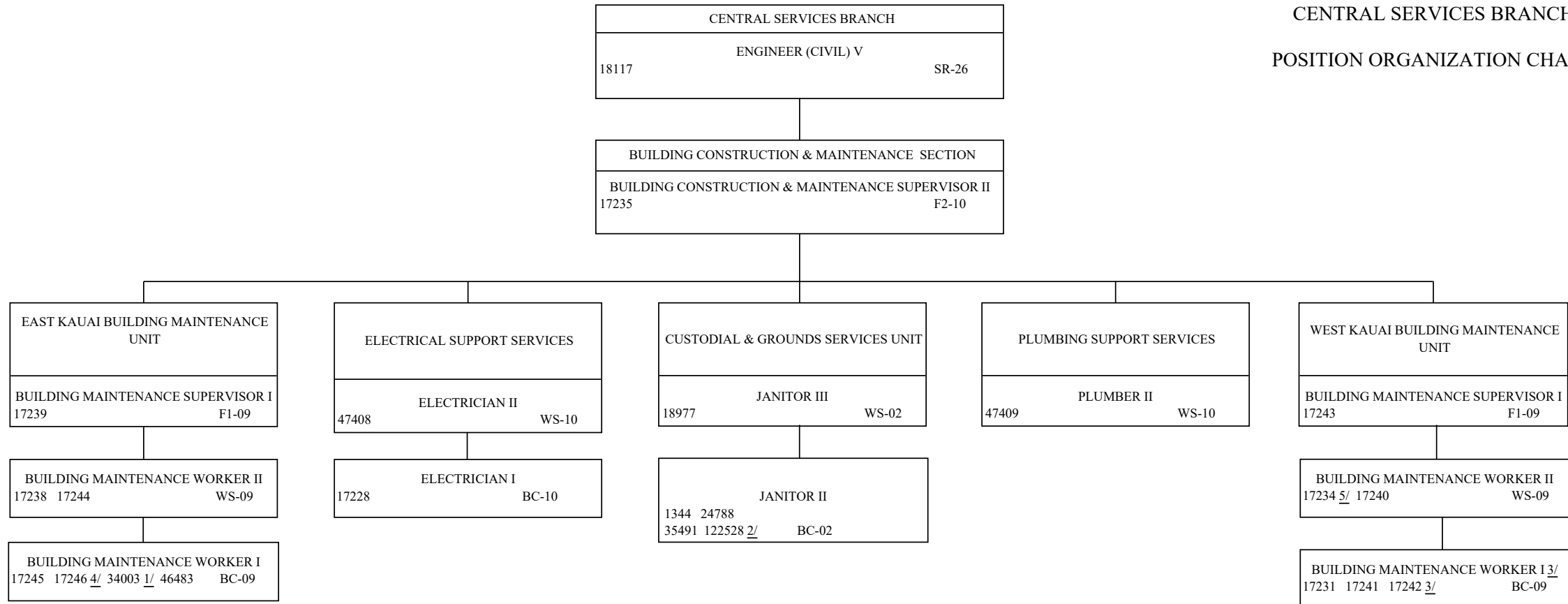

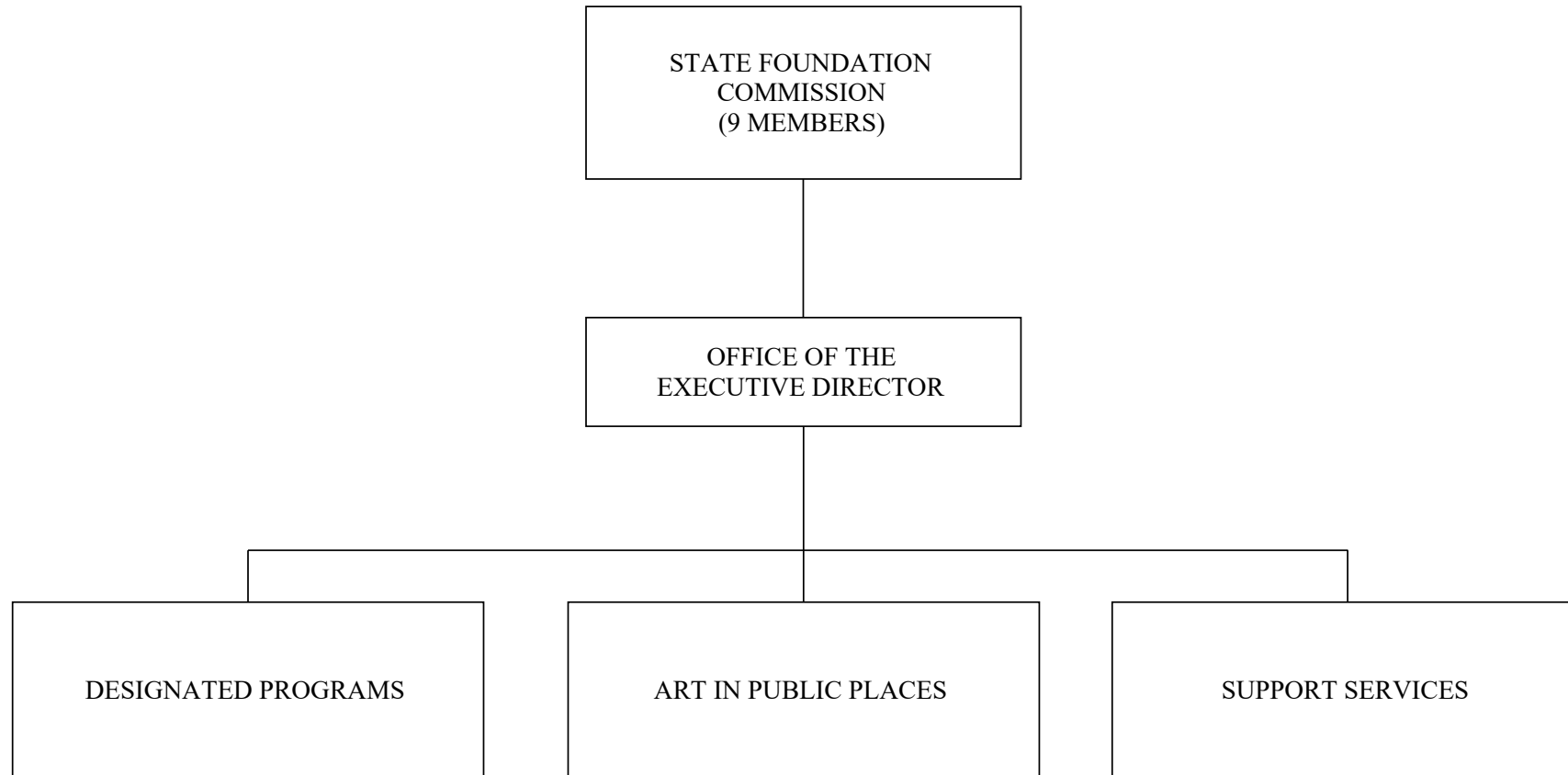

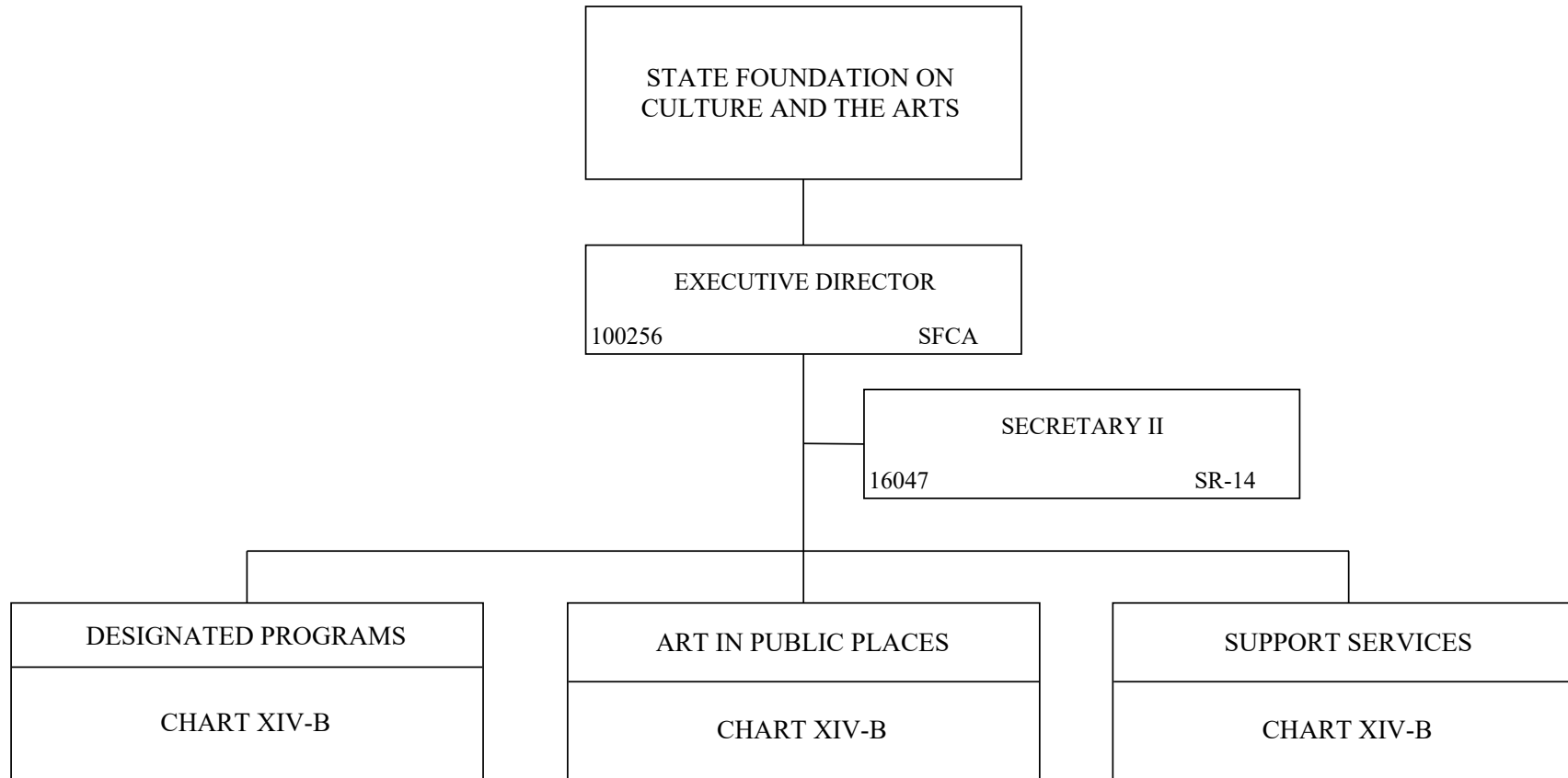

ORGANIZATION CHART



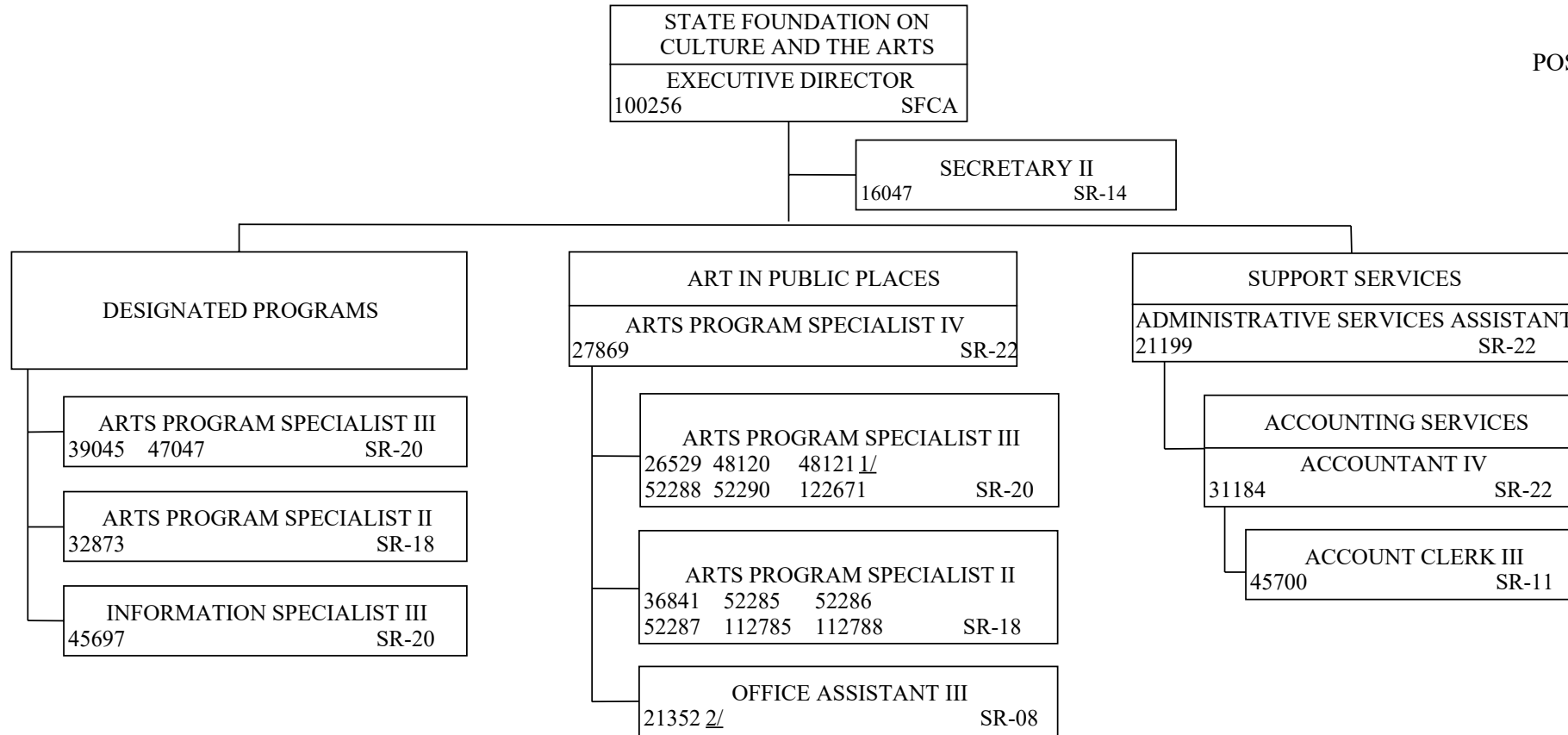

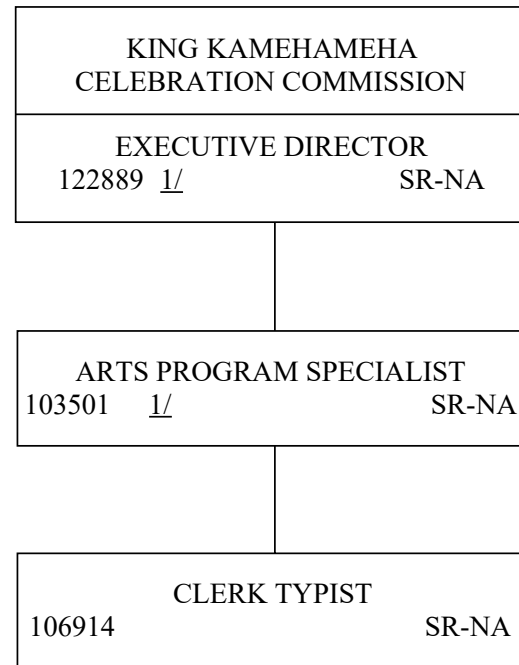

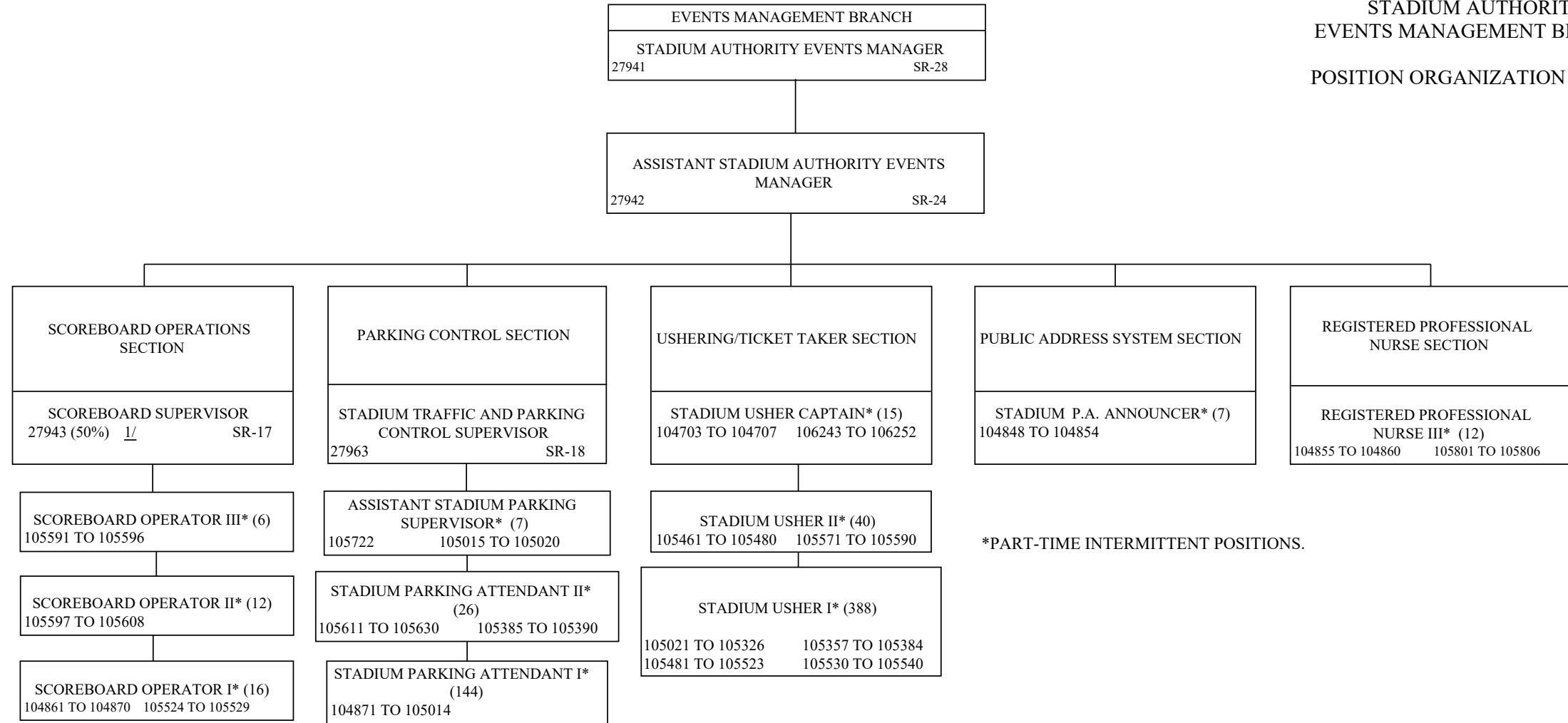

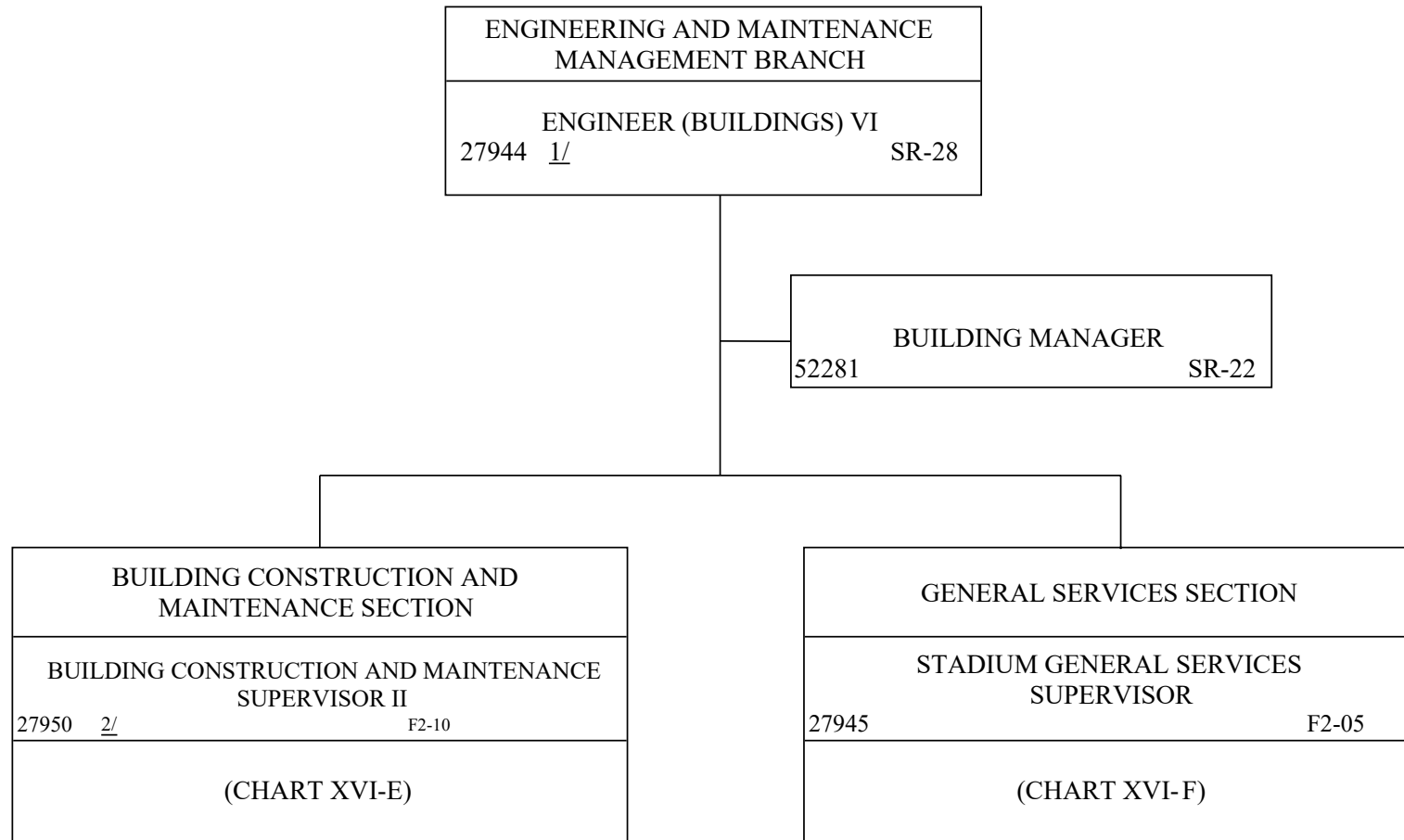

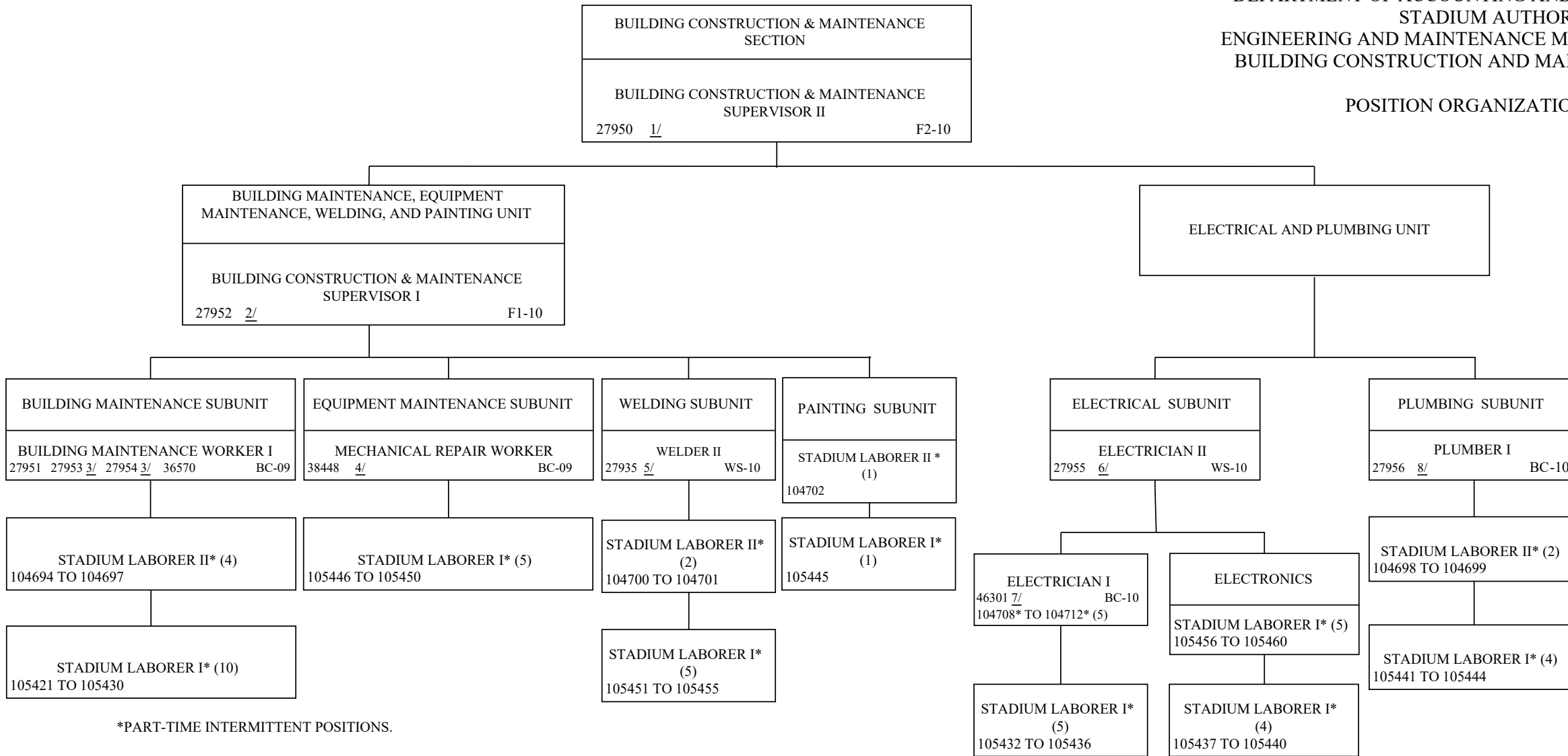

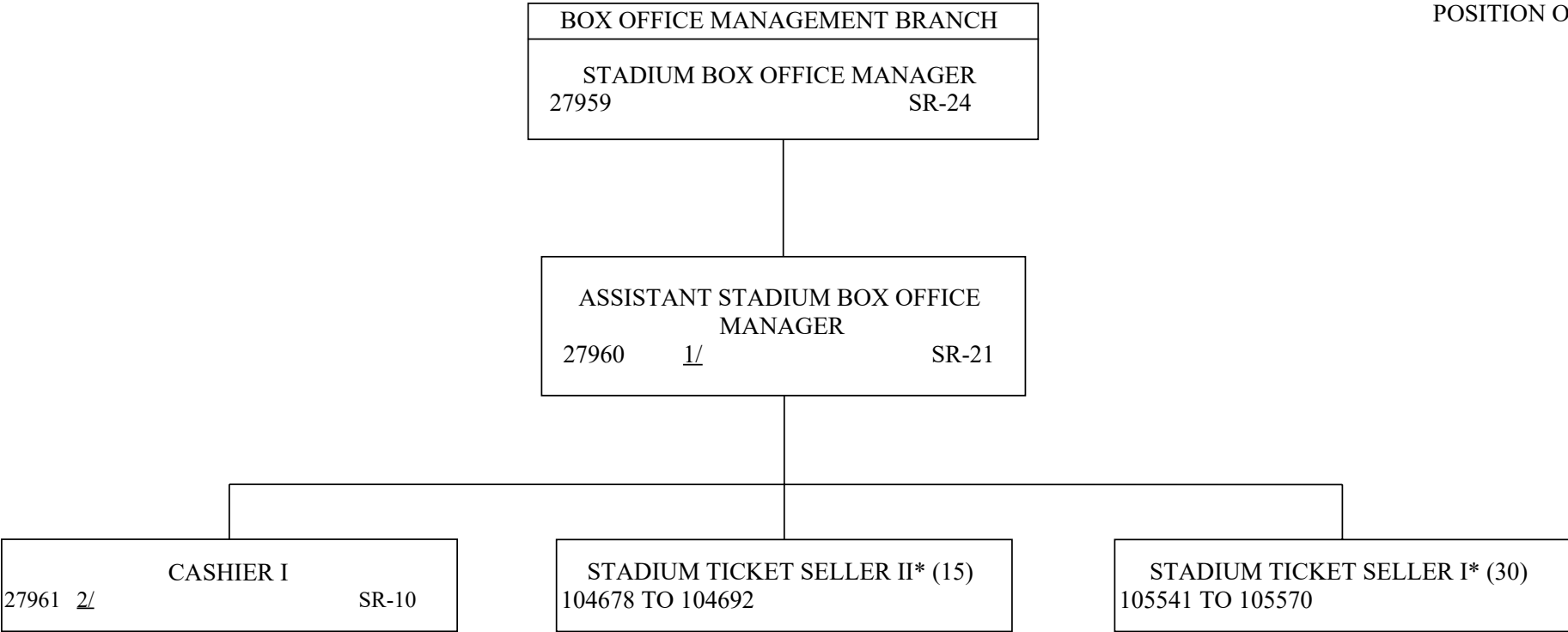

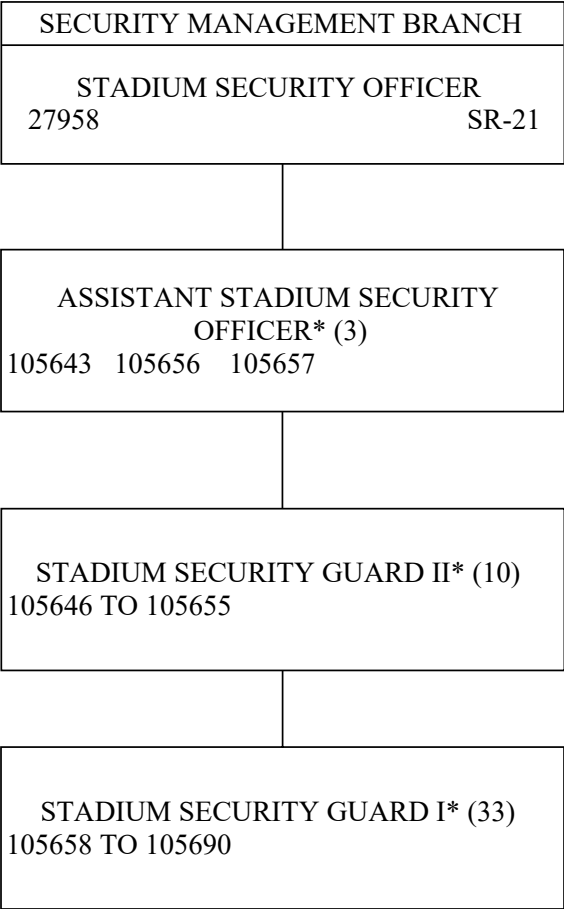

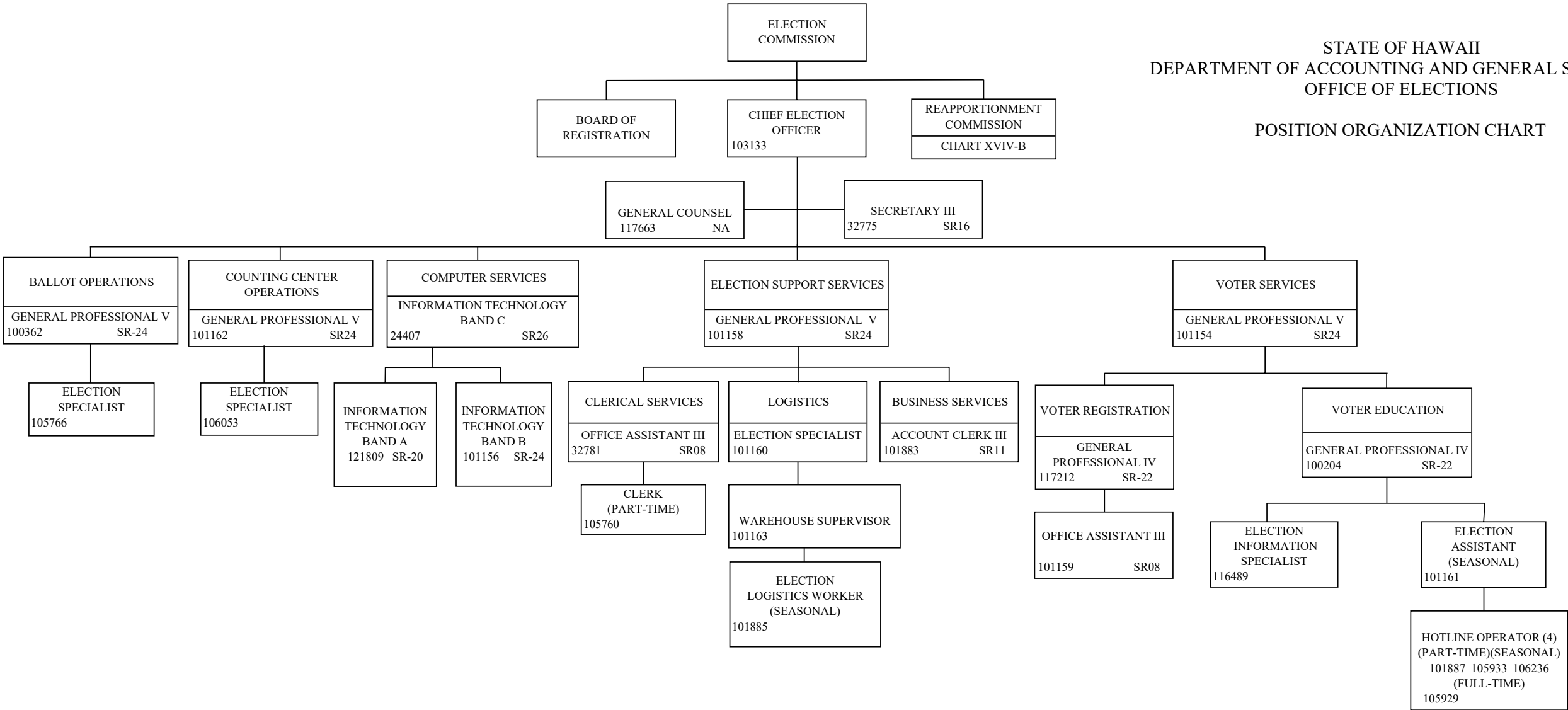

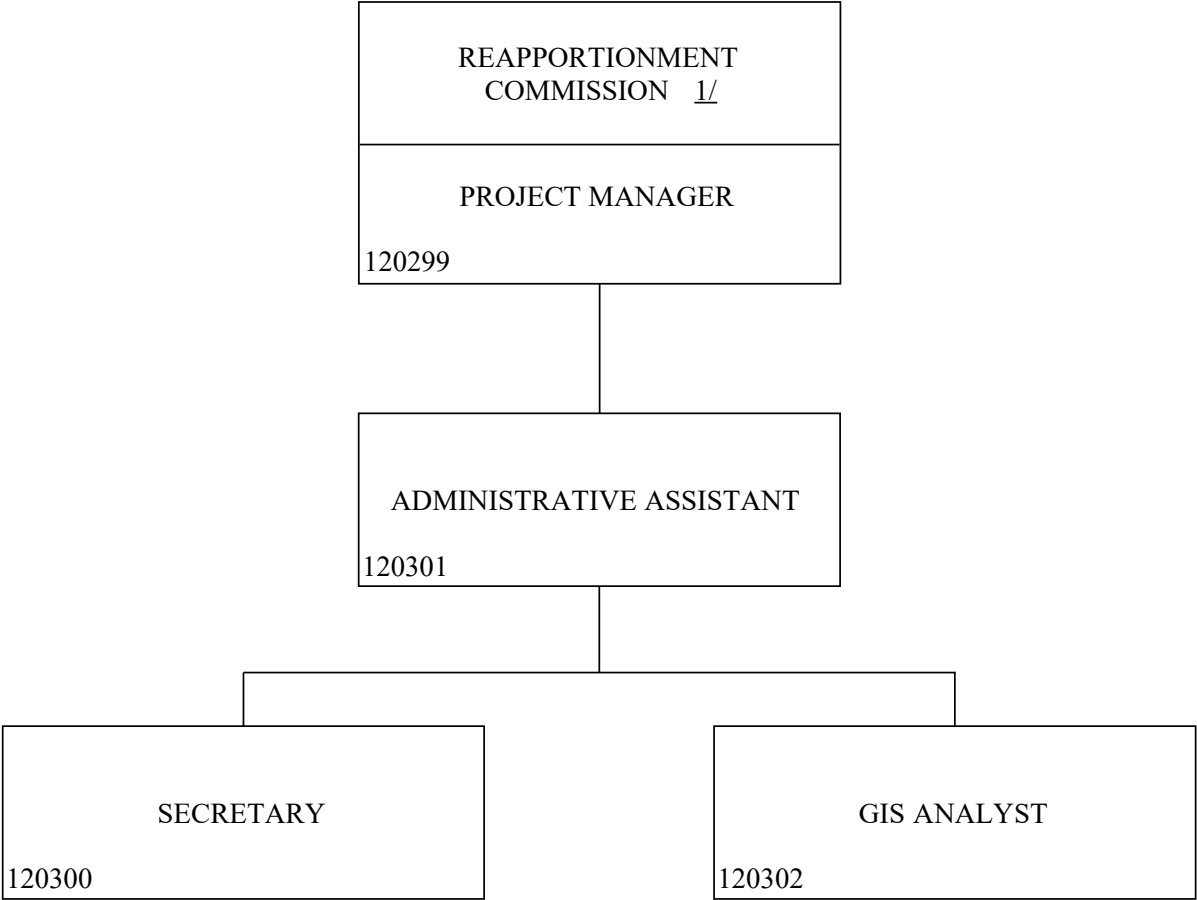

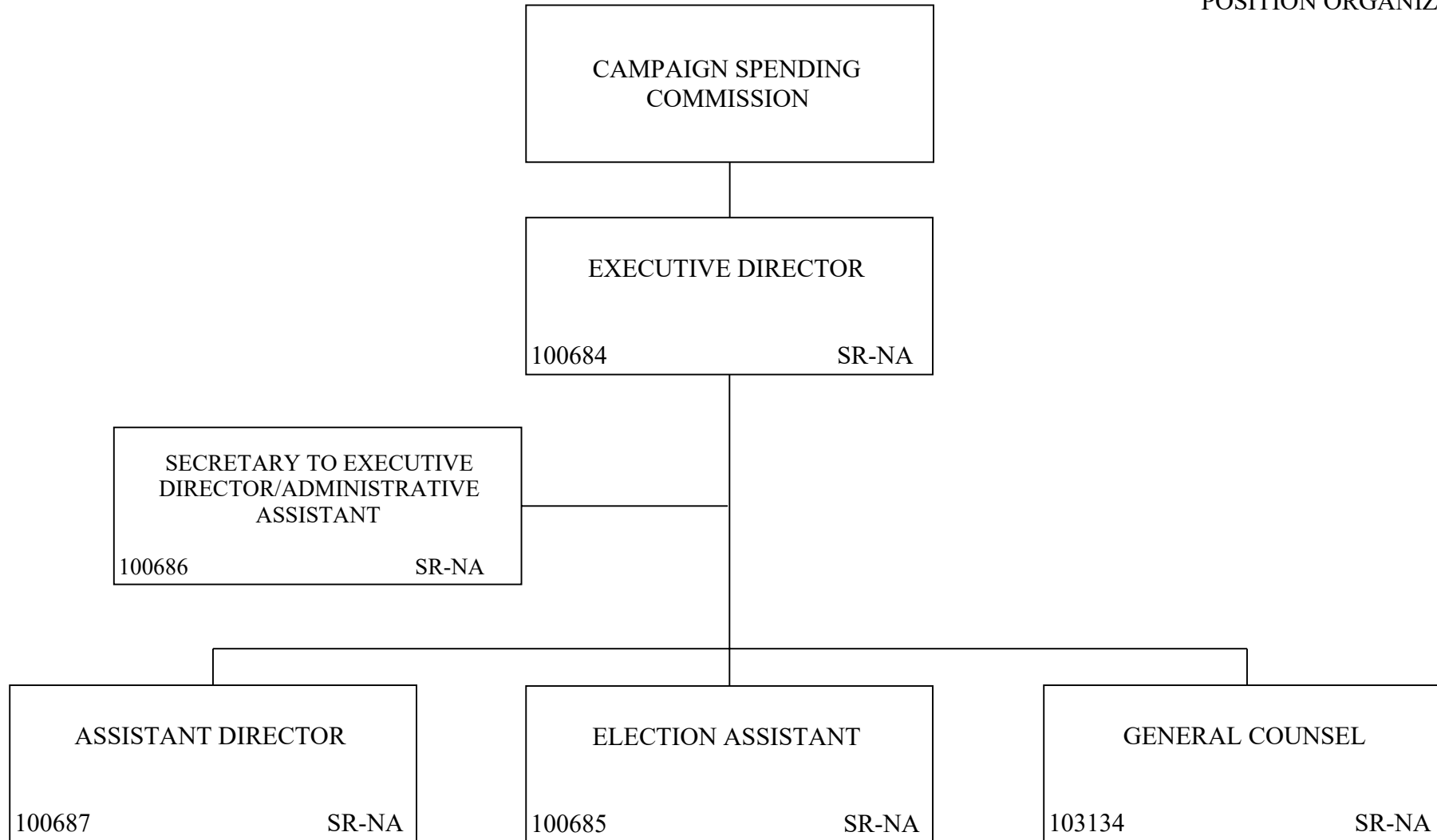

ORGANIZATION CHART



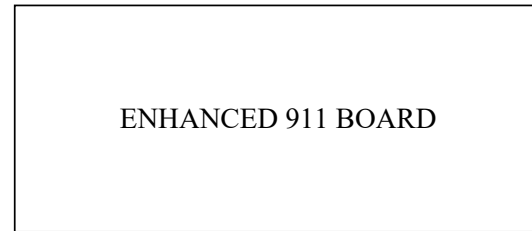

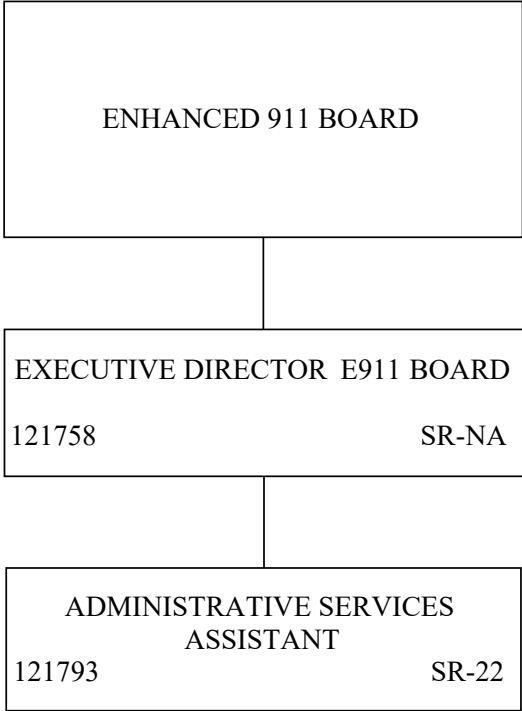

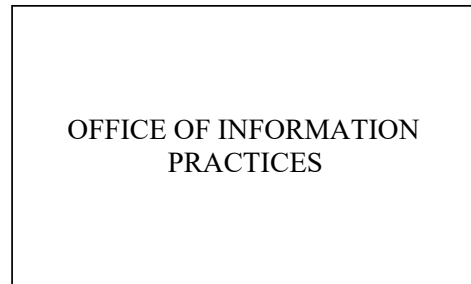

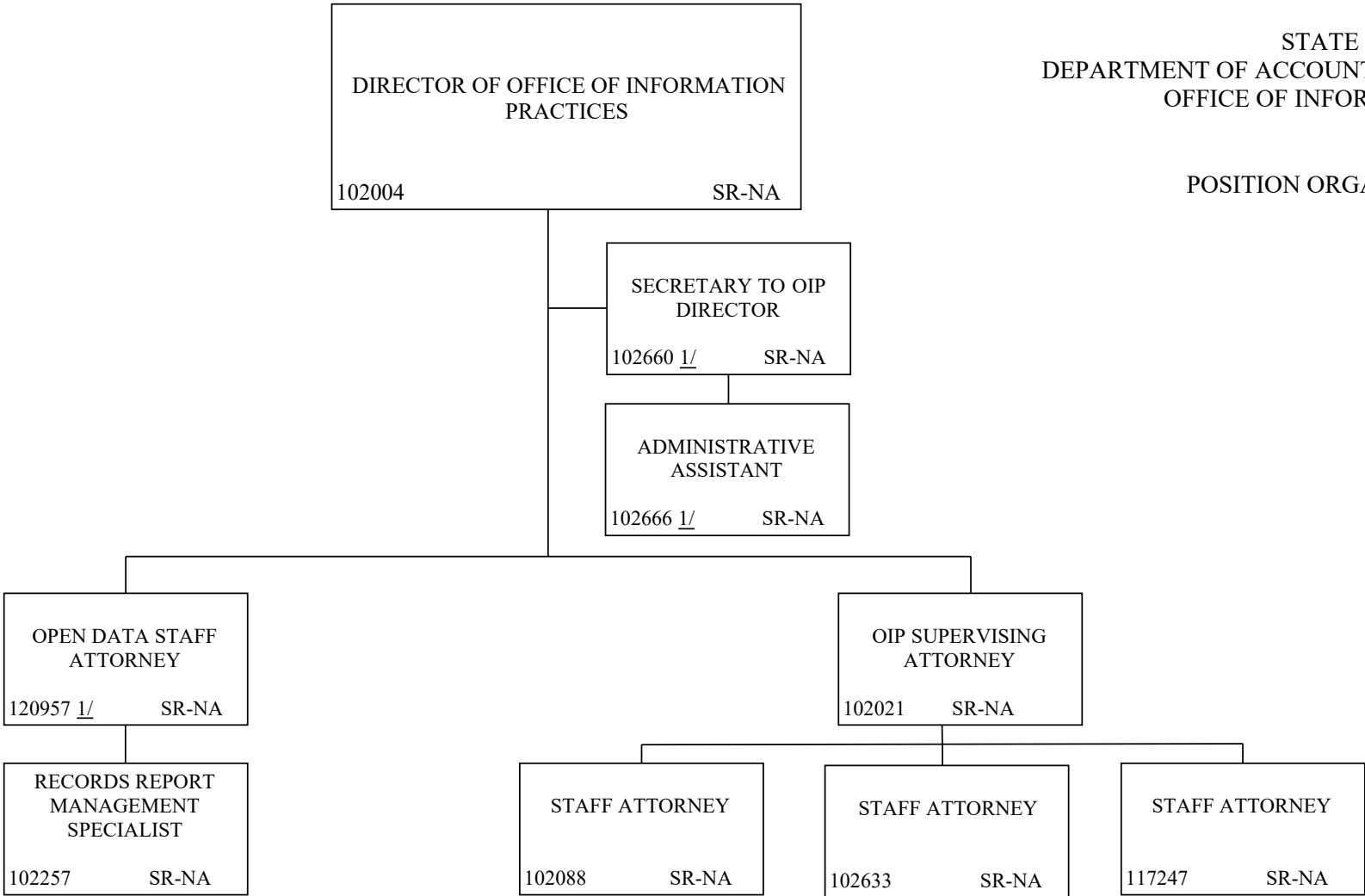
