9/1/2024 -9/30/2024	<p>The Honolulu C&C Primary and Secondary PSAPs 701/709 Report Status through 9/30/2024:</p> <p>Honolulu City & County: 0 - 701 Discrepancies and 0 - 709 Discrepancies</p> <p>The 701/709 Report is a "Location Address Report" received from the Telco indicating Wireline customers requesting telephone service which does not MSAG validate. A "701" discrepancy indicates a House Number that is "out of range", and a "709" discrepancy indicates a customer provided a "Street Name" or "MSAG Community" which did not MSAG validate.</p>
9/1/2024 -9/30/2024	The Honolulu C&C Primary and Secondary PSAPs processed 80,201 total 9-1-1 calls. There were 401 total calls with "No ALI" or location information delivered to the PSAPs. That is 99.50% of all 9-1-1 calls received at the PSAPs are delivered with location information.
9/1/2024 -9/30/2024	The Honolulu C&C Primary and Secondary PSAPs performed 31 total 9-1-1 Net Transactions, 2 MSAG, 29 ALI transactions, 0 Ali Dr, and 0 VoIP.
9/1/2024 -9/30/2024	<p>The Honolulu C&C Primary and Secondary PSAPs submits daily to West (Intrado), Telephone Number Change Request (TN CR). The current status of these TNCR requests is that there are 4,229 ALI records that are in an open status.</p> <p>Honolulu C&C breakdown: 4,229 Record Submitted, 20 Pending DBMSP, 3,508 Pending Telco, and 701 Telephone records remain Unopened;</p> <p>A TN CR is an indication that a ALI records requires some type of correction, edit, or modification by the Database Maintenance Service Provider (DBMSP), or the Telephone Company (Telco) .</p>
9/1/2024 -9/30/2024	The Oahu PSAPs performed 37 Sites and 104 Sectors updates to their Wireless 9-1-1 Databases (includes updates to both Wireless GIS layers).
9/1/2024 -9/30/2024	The Honolulu C&C Primary and Secondary PSAPs conducted Wireless 9-1-1 testing of 0 Wireless Cell Sites and 0 Sectors.
9/1/2024 -9/30/2024	The Honolulu C&C Primary and Secondary PSAPs initiated a soft launch of their Text to 9-1-1 system on December 21, 2015. During this soft launch period, PSAP personnel will utilize this period to sharpen their Texting skills and procedures. Although there is a "Text to 911" plot on the MapFlex, the location of the plot is not reliable. Text to 911 Dispatchers should use their skills to determine the exact location of the emergency response. There were a total of (316) 911 Text messages received at the Primary and Secondary PSAPs in September 2024.
