4/1/2025 - 4/30/2025	<p>The Kauai County Primary PSAP 701/709 Report Status through 4/30/2025:</p> <p>Kauai County: 0 - 701 Discrepancies and 0 - 709 Discrepancies</p> <p>The 701/709 Report is a "Location Address Report" received from the Telco indicating Wireline customers requesting telephone service which does not MSAG validate. A "701" discrepancy indicates a House Number that is "out of range", and a "709" discrepancy indicates a customer provided a "Street Name" or "MSAG Community" which did not MSAG validate.</p>
4/1/2025 - 4/30/2025	<p>The Kauai County Primary PSAP processed 1,832 total 9-1-1 calls.</p> <p>* There was 51 total 9-1-1 calls with "No Class of Service" delivered to the PSAPs. That means 97.22% of all 9-1-1 calls received at the PSAPs are delivered with location information.</p>
4/1/2025 - 4/30/2025	The Kauai County Primary PSAP submitted 502 total "Dispatchable Locations", 2 MSAG, 0 TNCRs, 0 ALI DR, and 0 VoIP transaction.
4/1/2025 - 4/30/2025	<p>The Kauai County Primary PSAP the below Telephone Number Change Request (TN CR). This identifies that 461 ALI records are in an open status.</p> <p>Kauai County breakdown: 461 Records Submitted, 0 Pending DBMSP, 301 Pending Telco, and 160 Telephone records remain unopened</p> <p>A TN CR is an indication that a ALI records requires some type of correction, edit, or modification by the Database Maintenance Service Provider (DBMSP), or the Telephone Company (Telco).</p>
4/1/2025 - 4/30/2025	The Kauai County Primary PSAP performed 3 Sites and 27 Sectors updates to its Wireless 9-1-1 Database.
4/1/2025 - 4/30/2025	The Kauai County Primary PSAP performed the following 9-1-1 wireless field testing: 0 - Sites and 0 - Sectors.
4/1/2025 - 4/30/2025	In a press conference on October 13, 2016, an official announcement was made by the Governor of the State of Hawaii introducing "TEXT TO 911" as an emergency public service now available in the State of Hawaii.
4/1/2025 - 4/30/2025	The Kauai County PSAPs initiated a soft launch of their Text to 9-1-1 system on December 21, 2015. During this soft launch period, internal testing and training should continue to be conducted. Although there is a "Text to 911" plot on the MapFlex, the location of the plot is not reliable. Text to 911 Dispatchers should use their skills to determine the exact location of the emergency response There were a total of (61) 911 Text message received at the PSAPs in April 2025.
